Meeting called to order.

Roll call. All five present.

Judy thanks the pancake breakfast volunteers. Says she thinks we should have a thank you party.

Paul thanks the community.

Allen discusses the mis-directed deposit and makes a motion to issue a \$2,000 check to Lake George Fire. Brief affirmative comments, motion made, seconded, motion passed.

6:10 PM

Discussion RE Quicks pay following June 22nd of his promotion by vote of the board to interim chief. Hourly wage set at \$27.50 and hour based on a 40 hour week. No overtime.

Motion made to make pay level as described, seconded, voted, motion carried.

Motion made to make pay retroactive to starting date, seconded, voted, motion carried.

Public discussion re fire code enforcement. Public asked board not to "punt it to the county."

Fire core discussion.

Allen states that he had very little participation in the pancake breakfast. He was not on any committees. He attended no meetings. As alleged by some, he did not promote anybody to any position. He has discussed many things with many people, ideas, structures, conflicts. For unknown reasons, some people accused him of doing this, and he became a lightning rod for anger and he felt vilified. In an effort to avoid future blame, he will recuse himself from any board vote assigning members into a position of authority on fire core.
