  - a. - b. Overview of process provided to public; financials in a good state as of year-end, no audit needed as the District is exempt this year, and no specific deadline to amend the 2022 budget
- Reminder that the budget hearing process and public input/objections is reserved for taxpayers/electors of the Florissant Fire Protection District
- d. Discussion regarding some confusion in line items that items that appear to be blank in budget and also have a subsequent debit/credit, by line do not show a percentage over/under budget. Clarified the summary total categories reflect percentage and totals accurately; Chief Holt explained some of the confusion may also be cleaning up and recategorizing categories and retiring/creation of line items and moving in/out of categories; District and Chief acknowledged this could be clearer in the future
- e. Discussion regarding some confusion between accrual based and cash-based budgets and budget comparisons.
- f. Suggestion and discussion to separate out capital outlay from operational; Chief, district admin and CPA are working together to define and create policies on this.
- g. Discussed strategies for budgeting next year that may put us in a better position to decrease likelihood of budget amendments in the future; although not uncommon to amend
- h. District prioritizing creating additional policies and procedures.
- Pending clarification on final budget amendment amount from Tori and sending to Legal for final review, board agreed to move forward with budget amendment; final paperwork will be submitted and approved by the State and District will then post final amended 2022 budget on District website.
