2 MR. PASHOVITZ: Good morning, Your Honour. 3 THE COURT: Good morning. 4 MR. PASHOVITZ: I think that leaves us with 5 the matters involving James and Jarvis Stewart. 6 THE COURT: All right. 7 MR. PASHOVITZ: I'm Bryce Pashovitz for the 8 Crown. And I have carriage of these matters. 9 THE COURT: All right. 10 MR. PASHOVITZ: They're --11 THE COURT: Just a --12 MR. PASHOVITZ: -- just coming forward. 13 THE COURT: -- just a moment, please. 14 Come forward, Mr. Stewart and Mr. Stewart. Have a seat there, please. I just have to make a couple of 15 16 notes, and then I'll make some comments, and then 17 we'll get going. 18 All right, Mr. Pashovitz, is 19 it your intention to have a trial set, both -- all 20 matters to proceed at the same time? 21 MR. PASHOVITZ: Yes, Your Honour. And just procedurally, there were a number of case 22 23 managements that were held, but I believe the 24 endorsements will show that even though the matter is set for trial today, I think formally there had 25 26 not been not guilty pleas entered on the two

Informations, so --THE COURT: Well, we're having a trial, so I'm going to enter not guilty pleas. MR. PASHOVITZ: Thank you, Your Honour. Crown is ready to proceed. I have five Saskatoon Police Service officers on my witness list, plus a special constable, Amy Radke from the Saskatoon Police Service is available as a witness, as well, too. And that came out as a request during one of the case managements by both Mr. Jarvis and Mr. James Stewart. THE COURT: All right. MR. PASHOVITZ: One thing I can advise, Your Honour -- and I apologize. I don't want to stray too far into other issues, but I am advised there is a civil action that has been commenced against Constable Keating, one of the Saskatoon Police Service members. And I did receive a call last week -- and I see she's here in the courtroom this morning -- from an Anna Singer, indicating that she's acting on behalf of Constable Keating. So when I heard that Judge Singer --THE COURT: That's the first --MR. PASHOVITZ: -- was walking in --

I just -- we all know 2 about the appearance, so I just wanted to raise that 3 with the Court, as well, too, Your Honour, so --4 THE COURT: Just -- just so you 5 understand what that's about, my daughter is a 6 lawyer, and she works for the firm of Scharfstein 7 -- whatever they're called. Warfin (ph), yeah --8 MR. JARVIS STEWART: 9 THE COURT: And --10 MR. JARVIS STEWART: -- I've been in contact with 11 them. 12 THE COURT: Pardon me? 13 MR. JARVIS STEWART: I've been in contact with 14 them, yeah. 15 THE COURT: Yes. 16 MR. JARVIS STEWART: I was not --17 THE COURT: They --18 MR. MR. JARVIS STEWART: 8 -- for bringing it to my 9 attention, but --10 THE COURT: Yes, okay. You are Jarvis? 11 MR. JARVIS STEWART: Jarvis, yes. THE COURT: 12 Yes, how --13 MR. JARVIS STEWART: I'm Jarvis. 14 THE COURT: -- do you do? MR. JARVIS STEWART: 15 And I'm --16 COURT CLERK: I'm just going --17 MR. JARVIS STEWART: -- representing --COURT CLERK: 18 -- to ask you to (inaudible). MR. JARVIS STEWART: 19 -- myself, yes. 20 THE COURT: How do --21 MR. JARVIS STEWART: I'm sorry. 22 THE COURT: -- you do? No, that's okay. 23 And you're James? 24 MR. JAMES STEWART: Yes, I'm James, Your Honour. THE COURT: 25 I received your notice. MR. JARVIS STEWART: 26 Okay.

1 THE COURT: And thank you very much for 2 that. 3 MR. JARVIS STEWART: Okay. 4 THE COURT: And I -- and on the notice 5 you say that you're -- you'll be representing 6 yourself along with your brother? 7 MR. JARVIS STEWART: Yeah. 8 THE COURT: Okay, so that -- that -- that 9 doesn't mean you won't get to ask questions if you 10 wish to --11 MR. JAMES STEWART: Oh, okay. 12 THE COURT: -- because you're -- you're 13 also charged. 14 MR. JAMES STEWART: Yes. 15 THE COURT: I'll just explain the usual 16 process in -- in the court. First of all, because I 17 received this -- this Charter notice, what we do is 18 have -- it's usually -- it's called a voir dire. But what it is -- is -- is the -- all of the 19 20 circumstances regarding the breach of the Charter 21 -- strictly speaking, you have to prove those, so 22 -- but you do it through the Crown's case. And so 23 what the -- what we traditionally do in this court 24 is we have the voir dire on that at the same time as we have the trial. So the two are, sort of, melded 25 26 together. And they -- what -- and it's for me to

1 sort it out at -- at the end, what evidence applies 2 to what, and what -- what doesn't. And so we just 3 run it like a regular trial. And -- and -- but it 4 -- but you're entitled to ask questions about the 5 Charter breach things when it's your turn to ask 6 questions. Okay? 7 Yeah. MR. JARVIS STEWART: 8 THE COURT: So that's -- that's the 9 process that we're going to follow with regard to 10 that Charter -- the Charter application. And that's 11 the usual one we always follow. And that -- and 12 that seems to work the best. 13 MR. JARVIS STEWART: Okay. Thank you. 14 THE COURT: Secondly, the -- I don't know 15 if you've had trials before or seen a trial, but I 16 -- when you're -- when you represent yourself, we 17 run the trial the same way as -- as when -- when 18 -- as if you had a lawyer --19 MR. JARVIS STEWART: Mmhmm. 20 THE COURT: -- except -- with a couple of 21 exceptions. First of all, the usual process 22 applies. The prosecutor's job is -- is to call his witnesses first. He'll call their first -- his 23 24 first witness. And I don't know who it is, but he's told me he has five police officers, so it's 25 26 probably going to be a police officer. So he'll

1 call that witness first. The witness will testify. 2 Well, he'll -- he'll lead the witness through their 3 -- their -- what we call a direct examination, his 4 evidence. 5 Then you each have the 6 opportunity to cross-examine the witness, if you 7 want, or just you, if you want. It's up to you. 8 But you have the -- you have the opportunity then to 9 ask that witness questions. And that's all. Okay? 10 MR. JARVIS STEWART: (No audible response.) 11 THE COURT: I don't want to hear any 12 statements about what you think happened and all of 13 this. You just get to ask questions. Then the 14 second -- then he calls his next witness. And when 15 -- he calls -- well, and you go through each one, 16 just like that. 17 And when he's done, then you 18 get an opportunity to call your own witnesses, whether it's yourself or someone else or some --19 20 something like that. 21 MR. JARVIS STEWART: Okay. 22 THE COURT: And that's when I hear your 23 side of it. So, first, we get the Crown's side in, 24 then we get your side in. And then we do it that 25 way. 26 MR. JARVIS STEWART: Okay.

1 THE COURT: Are there any questions? 2 MR. JARVIS STEWART: I do, actually. Just --3 THE COURT: Sure. 4 MR. JARVIS STEWART: -- with all -- with all due 5 respect, I don't mean to -- to --6 THE COURT: No, you just --7 MR. JARVIS STEWART: -- confront you --8 THE COURT: -- ask your question. 9 MR. JARVIS STEWART: -- on procedure, but --10 THE COURT: That's what I'm here for. 11 MR. JARVIS STEWART: -- I'm -- I'm pretty sure I 12 can prove prima facie -- at first glance that these 13 men, the witnesses have violated my rights. 14 THE COURT: Well, that's okay --15 MR. Thank you very much. 26 THE COURT: Well, that's okay. You --

- 8 A The New Glasgow Police Service, from May of 20099 until December.

THE COURT: 6 THE WITNESS: A white SGI continuous 7 sticker, or what was -- is a homemade sticker that 8 was meant to look like an SGI continuous sticker. 9 THE COURT: What did you notice? 10 THE WITNESS: (No audible response.) 11 THE COURT: Were you -- did you notice it 12 was homemade? 13 THE WITNESS: I noticed that there was 14 something odd about the sticker, Your Honour. It 15 wasn't a -- it didn't appear to be an SGI issued 16 continuous sticker. 17 I ran the -- the plate on 18 And it came back to a Honda Civic that was SGI. -- had expired registration in 2010. I confirmed 19 20 that the plate that was on the back of the Toyota 21 Celica was the plate that I had run, and it was. It 22 still came back to a Honda Civic. 23 So I pulled in-behind the 24 Toyota Celica in the left-hand turn lane on 8<sup>th</sup> and Grosvenor, and waited for the car to make a legal 25 26 left-hand turn on a green light, and activated my

emergency red and blue lights to initiate a traffic
 stop.

At this time, the car proceeded into the parking lot, making a right-hand turn, eastbound through the separation in the concrete median, and then made a left-hand turn, and then a left-hand turn into a parking lot (sic) -- a parking spot facing west-bound in front of the Shopper's Drug Mart.

10 At this time, I noted that 11 the driver's side door -- or sorry -- the passenger side door opened first. And a male exited the 12 13 vehicle. And then the driver's side door opened, 14 and the male driver exited the vehicle. At this 15 time, I used the loud haler in 477, otherwise known 16 as the loudspeaker, to instruct both occupants to 17 get back into the vehicle.

18 As it was August and I had my driver's side window down, I observed and heard as 19 20 the passenger, who is, now, known to me as James 21 Stewart, told me to "Fuck off", and kept walking. Ι 22 exited my patrol vehicle, and observed as the driver 23 walked towards me. I told him to get back in his 24 vehicle. He failed to do so, walked by me, brushing 25 his left shoulder into my left shoulder as he walked 26 I instructed the male, who is, now, known to me by.

as Jarvis Stewart, to stop, requested his driver's
 license. He refused and began yelling at me that I
 had no right to detain him.
 At this time, James Stewart,

5 who was approximately two car lengths away from my 6 location, began telling me to go fuck myself.

7 I again asked Jarvis Stewart for his driver's license, explained that he had been 8 9 stopped -- it was a traffic stop for the misuse of 10 plates. He continued to ask me if I was a peace 11 officer or a police officer and would not provide me with his name or any photo identification. I 12 explained to Mr. Stewart, if he didn't have his 13 14 driver's license on him, his name and date of birth would be sufficient, as I could run it on my inboard 15 16 -- onboard computer through the SGI system.

And Mr. Stewart failed to provide his name, date of birth, or any type of photo identification. He continued to ask me if I was a police officer or a peace officer. He continued to tell me that he didn't believe in our laws or that I had any right to detain him, and attempted to walk away.

I informed Jarvis Stewart that if he did not provide me with his identification or did not adhere to my commands with

1 regards to the traffic stop that he would be 2 arrested for obstruction. I gave Mr. Stewart ample 3 opportunities to provide his name, date of birth, or 4 photo ID. He continually stated -- asked me if I 5 was a peace officer or a police officer, and 6 continued to rant about how he didn't believe in our 7 laws. All the while his brother was continually telling me to fuck off. 8 9 Mr. Stewart made a 180 degree 10 turn, and began walking towards Shopper's Drug Mart. 11 I again --12 THE COURT: I'm sorry, which Mr. 13 Stewart? 14 THE WITNESS: -- informed him --THE COURT: 15 I apologize. 16 THE WITNESS: I'm sorry. Jarvis Stewart 17 made the 180 degree turn and started walking towards 18 Shopper's Drug Mart. I again asked him for his 19 identification, again explained to him the traffic 20 stop, and if he continued to walk away, that he 21 would be arrested for obstruction. 22 He again told me to fuck off 23 and that he had -- I had no right to detain him. 24 And at this time, I informed him that he was under 25 arrest for obstruction. I took Mr. Jarvis Stewart's 26 left wrist, placed him in a handcuff, and he

1 attempted -- attempted to pull away. I gained 2 control of his right wrist, placed it in a handcuff, 3 and at this time, he was arrested for obstruction. 4 While arresting Mr. Jarvis 5 Stewart, James Stewart began marching towards me in an aggressive manner. He had both fists clenched. 6 7 His teeth were clenched. He began swearing at me to let his brother go. 8 9 As I had one individual in 10 custody and Mr. James Stewart was clearly agitated, 11 I requested back-up to my location, through -- using my portable radio, I contacted our communication 12 13 centre. 14 It should be noted -- excuse 15 me -- traffic unit 477 that I was operating that 16 day, we don't have a secure area to place 17 individuals that are under arrest, so I could not 18 place Mr. Jarvis Stewart in the rear of the patrol 19 car. 20 I maintained my position on 21 the driver's side of 477 with Mr. Jarvis Stewart in 22 custody, and watched James Stewart as he continued 23 to yell and scream in my direction, telling me to 24 let his brother go. He continued -- continually 25 telling me to go fuck myself. 26 Mr. James Stewart walked

1 towards me, again with both fists clenched. At this 2 time, I was unsure if he was going to stop. Ι 3 raised my right foot in -- in anticipation that he 4 would be charging towards me, and I would be 5 prepared to kick him, to get him away from me. Ι 6 told him to stop. He did. He turned around, went 7 back towards the Shopper's Drug Mart, continually ranting and swearing, and then came back towards me 8 9 again. 10 Again I lifted -- lifted my 11 right leg and prepared to kick at him, if he did 12 come too close. 13 EXAMINATION-IN-CHIEF ON VOIR MR. PASHOVITZ: 14 DIRE CONTINUES: I apologize, Constable. I need to interrupt you 15 Ο 16 here before I forget. Can you at this time 17 demonstrate for the Court and all of us what you 18 were doing with the detained individual, and how 19 your right leg was positioned for us, please? 20 Yeah, sure. If 477 is here at an angle, I had Α 21 Mr. Jarvis Stewart in handcuffs right here. 22 Mr. James Stewart was walking towards me, clenched 23 -- clenched fists, clenched teeth. He's sweating 24 profusely. As he got to about where you are, I 25 raised my right leg, simply like this, prepared to kick at him, if he got too close. Like I said, I 26

1 told him to stop. He stopped, turned around, went 2 back. I -- he made it to the Shopper's Drug Mart 3 awning, where he made another 180 degree turn, 4 continually ranting and swearing, and came back 5 towards me again in the aggressive manner, both 6 fists clenched, teeth clenched, sweating profusely. 7 I then lifted my right leg. If he got too close, I was prepared to kick at him. 8 9 I'll just stop you there, Constable, because we're Q 10 leaving a record here. So you're indicating that 11 your police car number 477 was on your left-hand 12 side when you --13 That's correct. Α 14 -- motioned just now? 0 15 That's correct. It would be right here. Α 16 Okay. And when you said about from you to me, we're 0 17 talking about six to eight feet --18 Α Yes. 19 -- would you agree? Q 20 I would agree, it's approximately eight feet. Α 21 0 And how high off the ground did you lift your foot? 22 (No audible response.) Α 23 You can use centimetres or inches, whichever is Q 24 easiest for you. 25 Α Six to seven inches. 26 Okay. Please, proceed from then on? Q

1 Α Mr. James Stewart then began circling around in 2 front of me, approximately from where you are, eight 3 to ten feet, with his fists still clenched, still 4 yelling and screaming. And at this time, I heard 5 what I believed to be a police siren rapidly 6 approaching my -- my location. I noted traffic unit 7 474, which is an unmarked blue Crown Victoria, eastbound on 8<sup>th</sup> Street. It pulled into the parking 8 9 lot with its emergency lights and siren activated. 10 It stopped approximately three car lengths from my 11 location. I observed as Constable Schaefer exited the driver's side, and Constable McAvoy exited the 12 13 passenger side of 474. At this time, I told them 14 that Mr. James Stewart was arrestable for obstruction, and observed as Constable Schaefer told 15 Mr. James Stewart to stop. It should be noted that 16 17 when 474 entered the parking lot, James Stewart velled, "Here come the fucking heroes." Mr. Stewart 18 19 -- James Stewart began walking westbound through the 20 parking lot. Constable Schaefer again told him to 21 stop. He ignored that command. Constable McAvoy 22 and Constable Schaefer attempted to arrest him. I 23 observed as they struggled with him. Mr. Stewart 24 -- James Stewart began flailing around his arms and legs, and ended up on the -- the ground, where I 25 26 noticed that he immediately placed both his left and

1 right hands in the pockets of his hooded sweater, 2 and would not produce his hands for Constable 3 Schaefer and Constable McAvoy. I watched as he 4 continued to flail around, and they struggled to gain control of him. I noted a marked police car 5 6 enter the parking lot, and Constable Hounsell and 7 Constable Boyce exited that police car. They took custody of Jarvis Stewart for me, as they have a 8 9 secure area in the rear of their patrol vehicle to 10 house arrested persons. I then attended to 11 Constable Schaefer and Constable McAvoy, and assisted with gaining control of James Stewart and 12 13 placing him in handcuffs. Mr. James Stewart was 14 subsequently placed in the rear of Constable Smith's 15 police car, who arrived on scene shortly after. 16 Okay. I'll just take you back then. Which street 0 17 did you observe this vehicle on? The Toyota Celica I had observed in the left-hand 18 Α turn lane on 8<sup>th</sup> Street, headed eastbound. He was 19 20 indicating to make a northbound turn into the Shopper's Drug Mart parking lot located at 8<sup>th</sup> and 21 22 Grosvenor. We're talking about Saskatoon, Saskatchewan here? 23 Q 24 We are. Α Okay. 8<sup>th</sup> Street, a public highway as defined by the 25 0 26 Traffic Safety Act?

1 A It is.

2 It may be best for you just to carry on from what 0 3 happened after you just finished there. Did you 4 take any steps to look inside the vehicle that you 5 had stopped, and if so, tell us about that? 6 А I still had not identified either Mr. Jarvis Stewart 7 or James Stewart, as they had failed to provide 8 their date of birth, their names, or any type of 9 photo identification. Constable McAvoy had attended 10 to the Toyota Celica with the -- the improper plate 11 on it. He had located a piece of paper --12 And did he eventually show you this, as well, too --Q 13 He did. Α 14 -- or not? Okay, sorry. Carry on then. 0 15 It was an Affidavit signed by a James Stewart, and Α 16 there was one signed by a Jarvis Stewart. I used 17 SGI on my computer inside my car, and confirmed that 18 the photo ID -- or the photo on SGI of Jarvis 19 Stewart was the -- the male driver of the vehicle 20 that I arrested for obstruction. And James Stewart 21 also had a photo on SGI. And that the individual 22 that was in the passenger seat. 23 Are those same two individuals here in the courtroom Q 24 today? 25 Jarvis Stewart is wearing a yellow and red Α Yes. 26 rugby shirt. And James Stewart is wearing a grey

- 1 hooded sweater.
- 2 Q Thank you.
- 3 A (No audible response.)
- 4 MR. PASHOVITZ: Identifying the accused for
  5 the record, Your Honour.
- 6 Q If you could carry on from what you did after that7 then, Constable?
- 8 A I then attended to Jarvis Stewart, who was in the 9 back of Constable Hounsell and Constable Boyce's 10 police vehicle. I told him that he -- that he was 11 arrested for obstruction, I read him his *Charter* 12 rights and caution and police warning. For the 13 direct quote, I'd have to refer to my notes.
- 14 Q That's fine.
- 15 A I then attended to Constable Smith's patrol vehicle, 16 where James Stewart was being detained. I told him 17 that he was under arrest for obstruction and, as 18 well, resisting arrest. I read him his Charter
- 19 rights and caution and police warning.
- 20 Q Before I move on to the next area, did you at that 21 point in time tell them that you had found out what 22 their names were, or did they at that point in time 23 provide you with their names?
- 24 A They never --

25 Q Or can --

26 A -- provided me with their names. I told him that I

1 had gotten their names through the SGI system.

2 Q Okay. What happened after those --

3 A Excuse me.

4 Q -- pieces of information were provided to each of 5 them?

6 Α Again, for the exact quotes, I read them their 7 Charter rights and caution and police warning. For 8 the exact quotes, I'd have to refer to my notes. 9 Then I attended to the Toyota Celica, where I 10 obtained the VIN number off the front left-hand dash 11 area of the vehicle. I -- the CPIC query of that vehicle showed that it hadn't been registered since 12 13 2006. I then seized the plate off the back of the 14 Toyota Celica, which I've brought to court today, as it belonged to a Honda Civic that had not been 15 16 registered since 2010. Sergeant Spot of the traffic 17 section had arrived on scene, and he was going to 18 stay with the vehicle until it was towed. 19 What type of vehicle did he arrive in, do you 0 20 remember off the top of your head or not? 21 Α That was a -- that's a white unmarked Chevy 22 Silverado pick-up truck. 23 Okay. Please, proceed. Q 24 It is equipped with emergency red and blue lights, Α 25 as well.

26 Q Okay.

1 Q I don't need to -- to jog your memory about those.

2 I'll ask you about in a bit, so --

4 So when you were telling these individuals that they Q 5 were under arrest, were you reading that from a card 6 at all, or was this all just off the top of your 7 head, due to the nature of the situation?

8 That they were under arrest? А

9 Earlier on. I apologize. When you were telling 0 10 them to stop, when you were telling them that you 11 would arrest them for obstruction?

12 I didn't read from a card, no. Α

13 0 Okay.

14 I read their Charter rights and caution and the Α 15 police warning from the stamp that's inside my 16 police-issued notebook.

17 When you were being asked whether you were a 0 Okay. 18 peace officer or a police officer, did you give any 19 comments back at all?

20 I told them that I was a police officer. Α

- 21 Ο When you were being told to fuck off, did you give 22 any comments back to that?
- 23 Α No, I wasn't -- I had eyes on Mr. James Stewart, as 24 he was, as I had mentioned, a couple car lengths 25 away from my location. I was dealing with the driver, Jarvis Stewart, as I was attempting to 26

identify the driver, and my traffic investigation with regards to the misuse of the plates, and finding out if this vehicle was actually registered and if Mr. Jarvis Stewart had a driver's license. I maintained visual contact with Mr. Stewart. However, I didn't engage in any type of conversation at the time.

8 Q Okay. When exactly did you activate your emergency
9 lights, Constable?

10 I was approximately a quarter of the way through my Α 11 left-hand turn after I had observed Mr. Jarvis 12 Stewart make a safe and legal left-hand turn into 13 the parking lot. I made sure the intersection was 14 clear, made my left-hand turn, and as I made my 15 -- about a quarter of the way through, I activated 16 my -- my emergency lights. I also gave a quick 17 chirp of the siren, to get people's attention.

18 Q Do you --

19 A I did the --

20 -- remember when -- I'm sorry to interrupt. Do you Q 21 remember you did that, the chirp of the siren? 22 It would be at the same time I initially turned the Α 23 lights on. It's my practice, in order to get the 24 attention of drivers -- I do this at every single 25 traffic stop. I turn the lights on, which is two 26 clicks on the -- on the lights and siren activation

1 Two clicks turns on both the rear and the system. 2 front lights. The third click over provides a chirp 3 of the siren. And if you leave that on, then the 4 siren continually stays on. I turned it over all 5 the way to the third one, and let the siren chirp, 6 and then I put it back to the second position, which 7 keeps the front and rear lights going.

33

8 Q Okay. So --

9 A I did -- this is my practice. I've done this since
10 I became a police officer.

11 Q With respect to this particular stop, which -- which 12 emergency lights were flashing then, from the time 13 you started them going, until the time you stopped 14 in the parking lot?

15 The first click activates all of the rear lights, so Α 16 anything in the back windshield, the back brake 17 lights, the two strobes will start. Then the red 18 and blue flashing strobe lights that are in the 19 white reverse lights in the back. I turned it to the second position, which eliminates those, as well 20 21 as the front wigwags, which are in the headlights, 22 the front red and blue -- blue -- blue strobe 23 lights, which are on the corner markers, the front 24 red and blue strobe lights on the side mirrors, as 25 well as the bigger red and blue lights that are in 26 the front windshield.

1 Okay. And how long did you let the siren chirp for, Q 2 and how many times did you chirp the siren, to use 3 your phrase, if you can remember? 4 Α The siren chirped for two seconds, just one, two, 5 just to get the driver's attention. 6 0 And did you chirp the siren again during this call 7 or not? 8 Because Mr. Jarvis Stewart, who was operating А No. 9 the vehicle, made his left-hand turn and then made 10 the right-hand turn and pulled into the parking spot 11 facing westbound. 12 Where did you position your police car in light of Q 13 that? 14 Excuse me. It's -- the parking lot at Shopper's Α 15 Drug Mart where he pulled in could only afford me to 16 park my -- park my vehicle at a -- almost a 17 northwest angle, so the front of my Crown Vic would 18 have been -- the front left portion of the bumper 19 would have been approximately in the middle of 20 Mr. Stewart's Toyota Celica, at an angle. 21 0 And how far back was your police car from his 22 bumper, approximately? 23 Probably five to -- five, six feet. Α 24 Okay. How did you communicate to the driver of the 0 25 vehicle, were you using the voice you're using, now, 26 or were you using a megaphone or something like that

1 or --2 Initially when I conduct a traffic stop, it's my А 3 practice I use at every traffic stop --4 THE COURT: Well, just tell me what you 5 did then. 6 THE WITNESS: Okay. I attempted to make 7 the -- do a CPIC query of the plate, which is on a 8 different screen on my computer. At this time I 9 noted that the passenger and the driver were both 10 getting out of the vehicle. I used the megaphone or 11 loud haler in my police vehicle to tell them to both 12 get back into the vehicle. And then the sequence of 13 events that I explained earlier. 14 Okay. And tell us about the use of this megaphone Q 15 or loud haler, and tell us what you said and --16 Α Excuse me. It's a -- it's a speaker that's mounted 17 in the front -- front area of the patrol vehicle. I 18 used the -- the microphone inside and told 19 -- instructed the -- the driver and the passenger to get back in the vehicle, and I simple said, "Get 20 21 back in the vehicle." 22 That's the phrase that you used that day? Q 23 Α Yes. 24 How loud of a haler are we talking about here? 0 25 I'm not sure what the actual amplification is. Α It's 26 loud enough that people at traffic stops could

- 9 phrasing, but Mr. Stewart just stated -- excuse me 10 -- stated that I had no right to detain him, pushed 11 by me with his left shoulder, making contact with my 12 -- my left shoulder, and then the sequence of events 13 that I've explained earlier.
- 14 Q Okay. So where were you positioned when the 15 shoulder brush --
- 16 A Excuse me. I would have exited my patrol vehicle
  17 through the driver's side. I closed the driver
  18 door. I would have been towards the front fender of
  19 my police vehicle, on the driver's side.
- 20 Q Okay. And whose shoulder touched whose?
- 21 A Mr. Jarvis Stewart was attempting to walk by me.
- 22 His left shoulder made contact with my left
- 23 shoulder --
- 24 Q And what --
- 25 A -- or left arm.
- 26 Q Okay. What did you say as a result of that?

1 That's when I started to explain to Mr. Stewart Α 2 about the -- the traffic stop, asking him to stop 3 and provide identification, his name, date of 4 birth. 5 Okay. Did you tell him the reason for your traffic 0 6 stop? 7 Misuse of plates. Α Yes. 8 Q Okay. I'm sorry, what was that again? 9 А It's misuse of plates. 10 Did you --0 11 А I told him -- I told him that -- I explained that 12 the -- the vehicle description did not match the 13 registration to that plate. 14 Q Did you get a response back from him as a result of 15 providing that information? 16 Α No. There was no comment on -- on the actual 17 traffic stop itself. He began talking about how I had no right to detain him. And he immediately 18 19 started questioning whether or not I was a peace 20 officer or a police officer. 21 0 So what did you say in response to that? 22 I informed him --Α 23 I'm sorry. This may be painstaking, but I just need Q 24 to know --25 No, that's --Α 26 Q -- exactly --

1 A -- okay.

2 Q -- what you said, exactly what the responses were.
3 You did --

4 A I --

5 Q -- the narrative initially, but --

6 Α -- I informed him that I was a police officer, and I 7 again explained to him the reason for the traffic 8 stop and requested his driver's license or his name 9 and date of birth, so I could look it up on SGI. 10 Okay. And the response you received to that was? 0 11 Α No, he just -- he continually stated non-factual 12 laws, went on about I had no right to detain him, he 13 didn't need a driver's license because they were 14 travelling on the roads and not using them, 15 continued on in -- with that -- those phrases, and 16 then attempted to walk away.

Q Okay, so when you say, "Attempted to walk away,"

So Constable McAvoy and myself -- myself 11 gathered our equipment from the -- and were in the car, and we ended up heading eastbound on the  $8^{th}$ 12 Street and to his location with full lights and 13 14 When we got there -- it took about -- about siren. 15 a minute to -- to get there, a minute, a minute 16 and-a-half. We just had to go around a little bit 17 of traffic to get to where -- the location where he 18 requested assistance at.

19 Q Carry on.

20 We ended up getting into the parking lot of Α 21 Shopper's Drug Mart. And I had noticed that 22 Constable Keating, who was working alone at the 23 time, had one male in custody. And he requested 24 that we take another male into custody. He 25 indicated, "Arrest that man," and he indicated to me 26 to arrest who now I know as James Stewart, the

person in the white coat. I could have drawn a
photo or a picture, I guess, of the layout, if you
like?

4 Q Well --

5 A But I'll --

6 Q -- maybe I'll just --

7 A -- I'll see if I can describe it.

8 Q Sure.

9 А The -- it was just west of the Shopper's Drug Mart, in the parking lot at 8<sup>th</sup> and Grosvenor. 10 I had 11 pointed my car directly at the scene. There were some curbs in the way. It was a nice evening. 12 Ιt 13 wasn't raining. It was just a regular summer 14 evening. Constable Keating had ordered me to -- or 15 wanted me to arrest James Stewart, but there was no 16 time for us to discuss the matters of why he wanted 17 him arrested. He just wanted him taken into 18 custody. He already had his hands full with 19 Mr. Jarvis Stewart, as well. Jarvis was already 20 handcuffed by Constable Keating. And he -- there 21 wasn't a lot of conversation, other than, "Have him 22 placed under arrest."

23 Q Mmhmm.

A I heard James say, "Here come the heroes," while he
was looking at us. I -- at this time, I was already
out of the car, walking towards him. I had -- had

1 indicated that it was a summer day, the pavement was 2 dry. And because of the reasons of him being a 3 taller male than myself, he was already in a 4 situation with Constable Keating, and the fact that 5 I wanted control of the situation a little better, I 6 had had asked him to lay on the ground. It's a 7 normal police technique to have a person on the ground for better control, for handling. 8 It was 9 under -- so I had made the -- the demand for him to 10 go to the ground. He stated, "No, I'm not doing 11 that," and began walking towards his Celica. Just 12 maybe to paint the picture a little bit better, 13 Constable Keating had his emergency vehicle with the 14 lights on. There was no siren, but it was parked 15 directly behind a white Toyota Celica in the parking lot. He already made a traffic stop on this -- no 16 17 this vehicle. Beside the white Celica was another 18 I don't know the make and model, but there vehicle. was two occupants of the vehicle. They were, kind 19 20 of, watching what was going on, the events that were 21 unfolding.

22 Q You're welcome.

23 A So -- so James was walking towards the vehicle. It 24 made a -- it looked in my mind that he was trying to 25 evade police. He already heard Constable Keating 26 say, "Arrest that person." And this is because I

1 heard Constable Keating without any issues, and 2 James was closer to -- to Constable Keating than 3 myself. So I had asked him to go to the ground. He 4 said, "No, I'm not doing that." I repeated the 5 command to go to the ground. He said, "No." So 6 then I approached him. I -- in order to make the 7 -- effect the arrest, I grabbed him to his arm. I'm not sure which arm. However, I made contact with 8 9 him. I also noted that he had had his hands stuffed 10 in the pockets of his bunny hug that he was wearing 11 that day. And he had lowered his body weight, 12 almost like a stance a person would take, as if they 13 were ready to start a fight. At this point, I had 14 grabbed his arm, trying to effect the arrest. And 15 Constable McAvoy, who was the passenger in my car, 16 came around and went behind him and -- and did a 17 -- like, wrapped his arms around the back of -- of 18 James. He didn't go to the ground immediately. He was requested to, "Go to the ground, go to the 19 20 ground." And then he had been taken to the ground 21 by myself and Constable McAvoy. At this point, he 22 had fallen to the ground. I did direct his head to 23 the ground, as well. And he had landed in such a 24 way that his right arm was under his body. Constable McAvoy had requested, "Get your arm out in 25 26 front." Again, I did not see his hands at the time.

1 It was unknown if there was a weapon in his pouch or 2 in his -- his pockets because he didn't take his 3 arms out at any time. So for officer -- officer 4 safety reasons, as well as to handcuff him, we 5 requested that his arm come out behind his back. Ι 6 had tried to pull out his arm, his right arm from 7 his body, as he was laying on his face and the front body -- like, his stomach. And as I was pulling his 8 9 arm out, I felt him tugging the arm back in. He was 10 hollering and yelling, trying to get some sort of 11 support from the crowd around him that was, now, forming. At the same time, I noticed that his 12 13 -- his head was flipping back and forth, trying to 14 It looked as if he was rubbing his face see us. 15 into the ground at some point, too. 16 What type of ground are we talking about here? 0 17 It was pavement, asphalt. There would have been a Α 18 little bit of dust or gravel from the road, from 19 vehicles. However, it was not wet at all. 20 Constable McAvoy had applied some pressure on his 21 arm. I heard James say, "You're going to break my 22 arm." We said, "Well, then pull your arm out from 23 beneath you." Eventually the arm was -- the right 24 arm was brought out and put behind his back, and I 25 had placed a handcuff on his right arm. And I had 26 given his right arm to Constable McAvoy to handcuff

1 his left to his right through -- over his back. He 2 was then searched. Constable Boyce and Constable 3 Hounsell came in during the handcuffing and assisted 4 us in ensuring that he was handcuffed and secured. 5 He was searched, and he was eventually stood up and 6 put into the back of a marked patrol car with a 7 silent patrolman. There is no silent patrolman in 8 the traffic cars, so we had patrol transport him 9 down to detention.

10 Q Do you know which patrol officers did that or not?11 A Constable Smith had transported him to detention.

12 Q Okay. And we're talking about --

- 13 A James.
- 14 Q -- James --
- 15 A Yeah.
- 16 Q -- Stewart? Okay.

17 A I don't recall who transported Jarvis.

18 Q Okay.

19 Α There was profanity and obscenities shouted at us by 20 James. I don't recall what Jarvis had said to me. 21 I didn't have much dealing with Jarvis at all at 22 that point. So he was transported to detention, and 23 then our focus was, now, on the -- the vehicle 24 stopped, looking at the vehicle that they were 25 driving. It was not roadworthy at all. There was a lot of defects with the vehicle. I had noted right 26

1 away that there was a huge indent into the driver's 2 door. It looked like -- as if it -- you know, it 3 wouldn't have opened easily. Like, it was just 4 -- it looked like it was in a collision with another 5 vehicle. So there was concern for structural 6 integrity, why this vehicle should not be on the 7 road. Also, walking around the vehicle, we noted that there were some issues with the taillights 8 9 being painted over, problems with the side marker 10 lights being painted over, so we had spoken to 11 Constable Keating about what -- what the issue was 12 with this vehicle, and why it should not go back on 13 the road. Constable Keating also mentioned to us 14 that he had a plate with a sticker on it that said, 15 "Continuous"; however it looked like a photocopy on 16 it. I had looked at the plate myself, and saw the 17 photocopy that said, "Continuous" on it. The plate did not match the vehicle. And when we looked at 18 the -- the VIN number on the dash, it almost looked 19 20 like it was not able to be read very easily. Ιt 21 -- it looked like -- almost it would have been 22 tampered with at one point. However, after looking 23 at it closely, it was just hard to read. There was 24 one part in our minds that we thought that this vehicle may have been stolen. We had done a search 25 26 on the plate, the history of it, the -- the vehicle

1 identification number, and the last known registered 2 person was out of B.C. Searching it a little bit 3 more, we had found that that person had been 4 deceased for some time. We were wondering, well, 5 how does that connect to these -- these men, and how 6 the vehicle came from B.C.? 7 Sorry to interrupt, but --0 8 For --А 9 -- were all of these checks being done while the 0 10 vehicle was still at the scene --11 Α Yes --12 -- or --Q 13 -- it was. Α 14 0 Okay. Sorry, carry on then. So there would have been a little bit of time from 15 Α 16 when they had been transported from patrol until the 17 time that myself and Constable McAvoy and Constable 18 Keating had attended to detention. We also waited 19 for a tow truck to arrive to take it to our compound. It turned out that it wasn't stolen. 20 21 However, the investigation went that way for a 22 certain point. And then we just determined that it 23 was just not registered. We did locate later on that there was a bill of sale in the vehicle. 24 That 25 vehicle appeared to have been bought legitimately. 26 However, it took a little bit of time to find that.

1 Q About how much time, Constable?

2 A (No audible response.)

3 Q I'm maybe putting you on the spot here, but --

4 A Probably about an hour, an hour and-a-half.

- 5 Q Okay.
- 6 A Okay.

7 That may be about all I need to ask you, as far as 0 8 the narrative then, Constable. Or is there anything 9 else that you had on the tip of your mind or --10 I had -- still didn't know who these -- these Α Yeah. 11 men were at the time. I had arrived in detention, 12 and normally we -- we come up from the basement, 13 through an elevator shaft, and into the second floor 14 where we go to the booking room. As I -- the 15 elevator's doors opened, I heard this yelling and 16 screaming from a prisoner. It turned out to be Mr. 17 James Stewart, who was yelling from the back of our 18 detention. I did approach him because I wanted to know who he was. And he remembered me from the 19 20 incident. However, I asked him for his name and 21 date of birth, just so we can determine his 22 identity. He didn't give it to me. He wanted to 23 know my name and my identity. And he read my badge 24 number, so he knew who I was. I wasn't -- I wasn't 25 sure if he was under the influence of a drug. I am 26 also -- part of my training is in the drug

By Mr. Pashovitz 1 recognition expert program. And just because he was 2 so irate, I didn't want to open the door to the cell 3 to talk to him, to see if there was anything that he 4 may have been under the influence of. So I never 5 did determine --MR. JARVIS STEWART: 6 Well, objection --7 -- if he was --THE WITNESS: -- for a second. You had 8 MR. JARVIS STEWART: 9 already searched this man and found no drugs, no 10 alcohol, no --11 THE COURT: Just -- just --12 MR. JARVIS STEWART: -- anything? 13 THE COURT: -- just -- just a moment. 14 That's not relevant information anyways. Let's go 15 ahead. 16 MR. PASHOVITZ: Yes. Thank you, Your 17 Honour. 18 MR. PASHOVITZ: EXAMINATION-IN-CHIEF ON VOIR 19 DIRE CONTINUES: 20 Did --Q 21 T --А 22 -- did he identify himself to you in cells? 0 23 Α No, he didn't. 24 No? 0 25 Α (No audible response.) 26 Ο Okay.

1 I did talk to Jarvis, who did say that he -- his Α 2 name was Jarvis, and his brother's name was James. 3 Was that in cells, as well? Q 4 Yeah, it was. Α 5 0 You spoke to Jarvis after you -- you spoke to 6 James? 7 Α I went around the -- because they were Yeah. 8 -- sort of, the cells were back-to-back. And Jarvis 9 at the time was cooperative, and he was -- seemed 10 -- you know, I guess, in a normal mental state, 11 considering what just happened. But it seemed like James was out of control. 12 13 And I think that's sufficient then, Constable. 0 I'll 14 take you back to the scene. 15 Α Okay. 16 I'm just curious about the -- the timing of 0 17 everything that you've discussed for us. 18 Mmhmm. Α 19 And approximately what time was it that you got this Q 20 call for assistance or --21 Α About seven o'clock in the evening. 22 Q Okay. 23 Α Sorry, 1700. That would be about five o'clock. My 24 apologies. About five o'clock. 25 Q All right. And then what time did you get to the 26 scene itself?

Your Honour, may I --Α 5 THE COURT: Yes. 6 THE WITNESS: -- refer to my notes --7 THE COURT: Go ahead. 8 -- for this? THE WITNESS: 9 THE COURT: Sure. 10 THE WITNESS: I had arrived at the scene at 11 about 1905, according to my notebook. And I had 12 arrived at detention at about 1957. And that's when 13 I spoke with James. 14 EXAMINATION-IN-CHIEF ON VOIR MR. PASHOVITZ: 15 DIRE CONTINUES: Okay. So from time at the scene until time at 16 0 17 detention, less than 60 minutes? 18 Α Just --19 Do I have the math right there? 0 20 -- just under 60 minutes, yeah. Α 21 Okay. And how quickly did things happen at the 0 22 scene? 23 Α (No audible response.) 24 Can you tell the Court as far as you arrive at the 0 25 scene, from that time until the time of James's 26 arrest?

- 1 A (No audible response.)
- 2 Q Or can you walk me through that, please, as far as 3 how quickly things happened?
- 4 A Within a minute. It took us approximately a minute
  5 to get from where we were set up for doing radar to
  6 8<sup>th</sup> and Grosvenor to assist Constable Keating. From
  7 the time that I had arrived, to the time that James
  8 was taken into custody and arrested, approximately a
  9 minute -- less than a minute.
- 10 Q Do you have a notation of that time in your notebook11 at all or not, Constable?
- 12 A (No audible response.)
- 13 Q Feel free to review it again, as well.
- 14 A No, I don't, but it -- I had watched Constable Smith
  15 record a time in his notebook where he read James
  16 for -- for obstruction for his rights to counsel.
- 17 O Okay. Do you recall that time or not?
- 18 A No, I don't.
- 19 Q Okay. No, and that's fine. So back to the scene 20 then. Tell me about what you saw when you got 21 there, tell me how much information was passed to 22 you by Constable Keating, and tell us what you did 23 as a result of that?

24 A Okay.

25 Q Walk me through that, more slowly, please. I'm26 interested.

1 Okay. When we arrived, Constable McAvoy and myself, Α 2 we had positioned our car, sort of, in a field of 3 view where we can see the Shopper's Drug Mart. And 4 there's a -- the extension where Grosvenor would go 5 to take you to the mall. So we're, kind of, at a 45 6 degree angle, so our vision was Shopper's Drug Mart, 7 the persons being under arrest, the -- the police vehicle, and the vehicle that was stopped, as well 8 9 as a person who just -- or a vehicle who happened to 10 be on the lot. There was also a few people milling 11 about, you know, doing their business at Shopper's 12 Drug Mart, in that area. Upon my arrival, there was 13 Constable Keating's vehicle with its emergency 14 lights flashing still. He had been --15 How -- can you tell the Court, how visible were Q 16 those to you with your eyes? 17 Very visible. You can see them from the street, Α from 8<sup>th</sup> Street. 18 19 Tell us about the lights that you saw on that 0 20 vehicle with your own eyes? 21 Α Okay. 22 Colours --Q 23 Α There was --24 -- how many, et cetera? 0 25 From the side of that vehicle, you can see the blue Α 26 light that would have been in the signal light -- or

1 sorry the rear view mirror. There's a -- there's 2 lights, sort of, integrated into the rear view 3 mirrors of the patrol car. And that would have been 4 the one that would have been most prominent, as well 5 as a visor light. There's a light that's mounted 6 just above the rear view mirror. I would have saw 7 those two, as well as the front headlight would have been flashing, as well, because there's two lights 8 9 on either side that would be flashing. I wasn't 10 able to see the back of it, but I -- I've driven 11 that car myself, and I've done a check on it. And 12 there's also a red and blue light in the back 13 In addition, the taillights would also window. 14 flash.

15 Q Okay. Thank you for that. Please, proceed as far16 as what the scene looked like to you.

17 Constable Keating was standing by the -- his Α Okay. 18 -- his patrol vehicle 477. And he already had 19 Jarvis in handcuffs. But he -- it appeared to me 20 that he was, kind of, backing away from James, with 21 still maintaining control with one hand on Jarvis's 22 handcuffs. Jarvis was standing near the wall, on 23 the west side of the Shopper's Drug Mart.

24 Q I'm sorry, would that be Jarvis --

25 A I'm sorry.

26 Q -- or James?

1 Α James, James. Thank you. James would have been 2 standing. He wasn't in custody. He had his hands in 3 his front pockets of his bunny hug. I stand up out 4 of my patrol car, and he states -- James says to me 5 -- or to our direction, "Here come the heroes." 6 Constable Keating say -- says to me, "Arrest that 7 man," or, "Arrest that person," or, "Arrest him." 8 It was clear to me that that person needed to be 9 placed under arrest. James walks away from the 10 Shopper's Drug Mart, walks across the parking lot, 11 away from Constable Keating, and towards where his Celica was parked. I -- and, again, based on the 12 13 fact that Constable Keating's a very large man, he's 14 already asked for assistance, I've noticed the size 15 of James. He's a bigger person than myself. And I 16 wanted to have control over him. Using the minimum 17 amount of force I could to effect that arrest, I 18 wanted to have control of -- of him, by having him 19 lay on the -- on the pavement. We call it a prone 20 position. And we've been trained this from police 21 college to have him proned-out. If he's laying 22 (sic) on the ground, there's no way of (sic) him to 23 run away from us, to flee, I guess. He says, "No, 24 I'm not doing that."

Q I'm sorry. So what's the first thing that you,
yourself, say to James?

- 1 A "Get on the ground."
- 2 Where was James positioned when Constable Keating 0 3 told you the phrase, "Arrest him," "Arrest that 4 man, " "Arrest that person"? 5 Α He was still close to the Shopper's Drug Mart, by 6 the west wall. Just -- it seemed -- and I picture 7 in my mind, it was just off the sidewalk. There's a -- kind of, a deep sidewalk, walkway, that, kind of, 8 9 has an overhang from the building that people can 10 shelter themselves from the rain or whatnot. 11 Did you believe that James Stewart had heard Q 12 Constable Keating say, "Arrest him," or, "Arrest 13 that man, " "Arrest that person"? 14 I do. Α 15 Tell -- tell the Court about why you believe that? Q 16 Just from the fact that Constable Keating directed Α 17 it loud enough so I can hear it, and James was close 18 to -- or closer to Constable Keating than myself. 19 Are you able to say how close James was to Constable Q 20 Keating? 21 Α (No audible response.) 22 Or by pointing to something here in the room or Q 23 whatever is easiest for you? 24 I was at the -- the curb that you would turn into Α 25 the -- the parking lot by Grosvenor. It's 26 -- there's enough room for a vehicle to park facing

1 westbound. There's enough room for another vehicle 2 to park towards the building. And there's enough 3 room for traffic to -- to go in-between the 4 vehicles. The parking lot -- I would estimate it 5 -- oh, probably 150 feet. That was my distance to 6 where Constable Keating was. And James would have 7 been about 30 feet from Constable Keating when he said, "Arrest that person." I heard him at about 8 9 150 feet.

10 Okay. I appreciate that. Carry on then, as far as 0 11 what you said to James and what his responses were? Okay. I had ordered him to get on the ground once. 12 Α 13 He says, "No, I'm not going to do that." I ordered 14 him twice to go on the ground. "No, I -- no," was 15 the statement. He still was in motion, walking towards his Toyota. And we approached him. And we 16 17 had -- again, I had tried to affect the arrest by 18 making contact with him by grabbing one of his arms. Again, I don't recall which arm it was, but I made 19 20 contact with him. He had taken a stance where he 21 would have his hands still in the pockets of his 22 bunny hug. And he dropped his body weight. 23 Constable McAvoy then went around him and held on to 24 his body. It was apparent that -- we have a use of 25 force continuum. And it appeared that he was 26 actively resisting, using that phrase, basically

1 saying he did not want to be arrested. He wasn't 2 making a -- not a runaway to flee, but he was not 3 complying with the police. For that use of force, 4 we could use different levels of force at our 5 disposal. This would have been something where we 6 could use anywhere from a soft body contact, whereas 7 we're holding him using a twist-lock, using pressure points, to an actual hard control tactic, where we 8 9 would physically take control of him and put him to 10 the ground. I already started with the soft control 11 technique of holding onto his arm, but he pulled away from me on that point. And this is where 12 13 Constable McAvoy went around him, grabbed him, and I 14 directed him to the ground using his head, and Constable McAvoy also followed through with his body 15 16 weight on him. The way he landed was on his front. 17 And he had his right arm under his body. Constable 18 McAvoy already had his left hand. Your Honour, I can demonstrate, kind of, the best I can by 19 standing. Left hand behind his back. Constable 20 21 McAvoy was on his back, applying pressure upwards to 22 get -- essentially a pain compliance for him to 23 remove his right hand out from under his body, to 24 put back to effect the cuffing. James did say, 25 "You're going to break my arm." Constable McAvoy 26 said, "Put your right arm behind your back." I was

1 -- the crook of the elbow would be sticking out of 2 the body a little bit, and I would have been pulling 3 on the -- the right arm. But I also felt him 4 pulling back into his body. Eventually, after 5 -- you know, this is all going on about ten, 15 6 seconds. It happened very quickly. The -- the 7 right arm was pulled out behind his body because his left hand was already behind him. A handcuff was 8 9 -- was put on his right wrist, and then it was 10 connected to his back with his left hand. He would 11 have been rolled to his side, and he would have been searched. And just to -- you know, looking for 12 13 anything for weapons of escape, anything for officer 14 safety, he was searched for. He was stood up, and 15 then he was taken by other officers. It was -- I 16 believe it was Constable Hounsell who had directed 17 him, and Constable Smith, I believe, directed him, 18 and put him in the back of that patrol car. I don't recall the number of that car. But he was placed in 19 20 there. I did notice that there was some scrapings 21 on -- on his face, on James's face from the -- the 22 contact he had with the arrest. 23 Are you able to -- when you say "the contact with Q

24 the arrest", can you elaborate on that for me, 25 please, as far as --

26 A There was some scratches, some little scratches

across his nose, across his cheeks. There was also
 an abrasion on his forehead.

3 Q Did you see what had come into contact with his face 4 to lead to those?

5 A It would have been on the pavement of the ground.

6 Q Did you have any role in doing that or not, can you7 tell me about that?

8 Yeah, I would have because I would have held onto А 9 his head to take him down to the ground. But I also 10 noted him -- like, there could have been some 11 -- well, there would have been contact with the ground at that point. But I also noticed that he 12 13 was pushing his face back and forth against the 14 pavement, looking to see where we were in relation 15 to -- you know, where -- because I had to -- I had my arm on -- on -- or his hands on his right arm, 16 17 trying to pull him out. And I'd seen his head going 18 back and forth. At one point, I approached the 19 patrol car. I had not opened the door, but I had 20 opened the front driver's door, rolled down the back 21 window, and advised him that he was under arrest for 22 obstruction. And then this is when Constable Smith 23 was behind me. And I asked Constable Smith to read 24 him for rights to counsel for the obstruction. And 25 he had his notebook out. He recorded that. I heard 26 Constable Smith read to James for his arrest, that

1 he -- the reasons for his arrest for that. 2 Okay. Up until that point in time, I take it then, 0 3 you weren't reading from a card, certainly? 4 No. Α 5 Anything you said was just off the tip of your 0 6 memory --7 That's right. Α 8 -- as opposed to from a card? You've been talking Q 9 about James Smith (sic) and Jarvis -- I'm sorry -- James Stewart and Jarvis Stewart. Are they in 10 11 the courtroom here today? 12 (No audible response.) Α 13 Can you point to them, please? 0 14 This was Jarvis and that's James. Jarvis is Α Yes. 15 in the striped shirt. 16 0 Thank you. 17 (No audible response.) Α 18 MR. PASHOVITZ: Identifying the same two 19 individuals as the other witness, Your Honour. 20 All of these events occurred in Saskatoon, Q 21 Saskatchewan; is that correct? Yes, it happened at 8<sup>th</sup> and Grosvenor, which are 22 Α 23 public streets in Saskatoon, in the Province of 24 Saskatchewan. 25 Thank you, Constable. Q 26 Α (No audible response.)

1 MR. PASHOVITZ: If I may just have a moment, 2 Your Honour? I believe those are all of my 3 questions. 4 You were in the traffic section back on the date of Q 5 this incident; is that correct? 6 Α That's right. 7 You still are? 0 8 I still am. А 9 And how long have you been with the traffic section, 0 10 approximately? 11 А I was two years in hit-and-run. It's an 12 investigative role. It's still uniformed. And then 13 I went to three years into enforcement. 14 How many traffic stops have you conducted, Q 15 approximately? Thousands. 16 А 17 0 Okay. 18 This is -- for somebody to act this way, it's not a Α 19 normal occurrence during a traffic stop. However, 20 for the traffic violations that I had noted on -- on 21 their traffic stop, it's very typical of other 22 vehicles that we'd see in Saskatoon: This being 23 painted or tinted taillights; vehicles driving with 24 body damage on it; vehicles that were unregistered; 25 and persons driving without a driver's license. 26 Q Okay. We had received a 5 -- pardon me -- we had received a call for 6 assistance from another officer on the -- that came 7 in as being the Shopper's Drug Mart on 8<sup>th</sup> Street. We assumed it was the Shopper's Drug Mart at the 8 9 2100 block in Grosvenor -- Grosvenor Avenue and  $8^{th}$ 10 Street. We'd arrived. I'd observed that there were 11 two other patrol cars at this time. A male that I 12 recognized as Constable Keating had one individual, 13 walking him towards our patrol car as we showed up. 14 Another individual was on the ground, face-down, had 15 two officers trying to control him at that time. Ι exited my patrol car. Constable Keating approached 16 17 with one male whom I later came to know as Jarvis 18 Stewart. At this point, he asked if we could place Mr. Stewart in the back of our patrol car. 19 I took 20 hold of his right arm, and we walked him to my 21 patrol car, and placed him the back seat of the 22 patrol car as quickly as possible because I could 23 see -- still see that there was another 24 confrontation going on between the other officers and the remaining male, James Stewart. So as soon 25 26 as I placed James (sic) -- or sorry -- Jarvis

1 Stewart in the back of my patrol car, I'd rushed 2 back to assist the other officers, at which point I 3 took control of Mr. James Stewart's upper body, his 4 head specifically. I could see that there was blood 5 around his face and on his mouth and he seemed to 6 be, kind of, spitting. And I wanted to make sure 7 that he was unable to spit on any officers, spit any blood on anyone. So I controlled his head, at which 8 9 point we -- at which point we were able to -- I 10 believe James was already in handcuffs at this time. 11 I -- I couldn't say or not. I was controlling his 12 head. But once we were able to search him for 13 -- give him a quick search -- search for weapons, 14 that type of thing, we were waiting for another 15 marked patrol car, one that would have a silent 16 patrolman that James Stewart could be placed into. 17 So we waited. I believe it was Constable Smith that 18 showed up. I don't recall his patrol car number, 19 but we placed James into the back of that car. And 20 at which point, I was -- returned to my patrol car. 21 I observed Constable Keating to be reading Jarvis 22 Stewart his rights and warnings, at which point, we 23 had transported Jarvis into detention cells. At 24 that point, I placed Jarvis into the north phone room, at his request, he wished to have a -- I -- I 25 26 gave him a phone book, so he could locate his

1 lawyer. At which point, I heard Constable Smith 2 calling in, stating that James Stewart was agitated 3 in the back of his patrol car and was spitting blood 4 and so on in the back of the patrol car. I noted I 5 -- I noted that I had a spit sock -- what's referred 6 to as a spit sock. It's, kind of, a mesh hood that 7 goes around a person to prevent them from spitting bodily -- bodily fluids on you. So I went down into 8 9 the basement, at which point I spoke with James and 10 explained to him that I needed to place this spit 11 sock on his head. And basically that -- that went 12 fairly smooth. We placed the sock on his head. And 13 that was end of my involvement. And I went back up, 14 at which point Jarvis stated that he didn't want to 15 speak to his lawyer anymore. His lawyer lived in 16 B.C., so I took him to the washroom, I guess, and 17 that was about it for my involvement.

18 Okay. I'll -- I'll take you back to the call. Ο How 19 many calls did you hear from Constable Keating? 20 I believe it was maybe broken into two parts. First Α 21 of all, you could hear a struggle, and that he 22 required another unit. And it was later on that it 23 came in that he -- he actually got his location out. 24 I think maybe other officers were on, wondering which location he was exactly at. There's more than 25 one Shopper's on 8<sup>th</sup> Street, but I -- I -- there was 26

1 -- there was the initial call that came in, and then 2 there was at least one update. I don't recall 3 whether it was from Constable Keating or -- or 4 dispatch or another officers that had seen his 5 location or what, so --6 0 Okay. From the time that basically the other officers -- as soon as myself and Constable Boyce 16 17 got hands on James, the other officers would have 18 released. At which point, we're, kind of, fresh to 19 the situation, and we would attempt to, kind of, 20 de-escalate the situation from where it was before. 21 So I felt at that time that James wasn't physically 22 resisting a whole lot at that point, when -- when I -- when I first got hands onto him. I just 23 24 basically controlled his head, so that he wouldn't 25 be able to -- like I said, turn his head towards 26 officers.

8 all.

9 But you had no idea why? Q

10 No, that's correct. Α

11 Q Okay. And then so when you did show up, you took 12 custody of me, essentially, you took control of me, 13 that was one of the first things you did, you took 14 me from Jay Keating?

15 Α That's correct.

16 Okay. And so at that point, were you aware that I 0 17 hadn't been read any rights or warnings or -- or 18 even been told the reason for my arrest?

19 No. I --Α

20 You weren't --Q

21 Α -- wasn't.

22 -- aware of that? Okay, so then -- but then you Q 23 took control of me, and then put me in the back of 24 your car?

25 Α That's correct.

26 So you're aware -- you weren't aware at that point Q

1 then that I wasn't aware of why I'd even been

2 arrested?

3 A (No audible response.)

4 Q I -- I really had no idea, and neither --

5 A I --

6 Q -- did you? Jay Keating made no attempt to tell
7 anybody what was going on; right?

8 A I -- that -- my main concern would have been officer

9 safety, so I wasn't concerned with that at that --

10 Q Officer --

11 A -- time.

12 Q -- safety?

13 A Correct.

14 Q Okay. Okay, so your main concern was officer 15 safety, but then you did get control of me, and you 16 put me in the back of your car, and then you raced 17 back to the scene. And at this point, you saw my 18 brother proned out on the pavement with handcuffs on

19 behind his back; is that right?

20 A I believe he had handcuffs on.

21 Q You --

22 A Yes.

23 Q -- believe he did? Okay. And so there was how many

24 officers standing over him at that point?

25 A (No audible response.)

26 Q There was Constable Keating --

- 1 A I --
- 2 Q -- Constable McAvoy, Constable --
- 3 A -- I --
- 4 Q -- Schaefer, and, now, -- and, now, Constable Boyce; 5 right?
- 6 A I thought that there was two officers, and I thought
  7 that myself and Constable Boyce relieved those two
- 8 officers, but I --
- 9 Q You --
- 10 A -- I don't --
- 11 Q -- thought --
- 12 A -- know where --
- 13 Q -- there was two, but --
- 14 A -- the other officers --
- 15 Q -- because --
- 16 A -- were then.
- 17 Q -- as it turns out, there was -- Keating was there;
- 18 Schaefer was there; McAvoy was there; and, now, your
- 19 -- your partner, Boyce --
- 20 A It could be.
- 21 Q -- was on the --
- 22 A I couldn't --
- 23 Q -- back of him --
- 24 A -- speculate that.
- 25 Q -- so, now, there's four officers on top of this
- 26 man, who is face-down on the pavement with handcuffs

	on behind his back, and you considered this a fight?
A	(No audible response.)
Q	You said there's still there was still at least
	one fight happening, so I had to race back to the
	scene; is that right?
A	That's correct.
Q	So you thought
A	In my

A	When someone is fighting with the police, I consider

Q	On on face-down on the pavement?
A	That would be my description, yes.
Q	Really?
A	(No audible response.)
Q	Okay, and so were the other were the other police
	officers really striking this man, were they kicking
	him, telling
	Q A Q A Q A Q A Q A Q A Q A Q A

- 1 A Not --
- 2 Q -- him to stop resisting?
- 3 A -- not that I observed.
- 4 Q So --
- 5 A I definitely did hear other officers when I first
- 6 arrived at the scene --
- 7 Q Okay.
- 8 A -- stating something to the effect of, "Stop
- 9 resisting," or, "Stop fighting."
- 10 Q So then -- then you took control of this man's head;
- 11 is that what you meant by kneeling on his head and

- 17 Q So you -- you -- you already saw that he was
- 18 face-down on the ground with handcuffs on behind his

- 22 A -- but using my knees.
- 23 Q -- his head --
- 24 A That's correct.
- 25 Q -- so you --
- 26 A Yes.

- 1 Q -- kneeled on his head, and you were aware that this
- 2 man hadn't really done anything?
- 3 A I wasn't aware of the --
- 4 Q Nobody --
- 5 A -- circumstances --
- 6 Q -- nobody --
- 7 A -- besides --
- 8 Q -- told you the circumstances, you just decided to 9 take it on -- upon yourself to go and control his 10 head by kneeling on it; is that right?
- 11 A He was fighting with the police, and I controlled12 his head, that's correct.
- 13 Q He was fighting with the police?
- 14 A (No audible response.)
- Q Okay, okay. So you controlled his head. And so then he said, "Jesus Christ, what are you doing? I didn't do anything." So you stopped, you let him go, you got up. And at that point -- some point, you went back to your car, and then you transported
- 20 me back to detention; is that right?
- 21 A That sounds correct.
- 22 Q That sounds about correct?
- 23 A (No audible response.)
- Q Okay. And so I was handcuffed in the back of the car?
- 26 A I would believe --

- 1 Q With handcuffs?
- 2 A -- that you would be.

- 5 Q And then you guys left that scene in your car with
- 6 the lights and sirens going; is that right?
- 7 A I -- it would be --

- 12 A -- say if the lights were on at that time, but --13 Q So you're sure you didn't leave the lights and 14 sirens going the whole time, and then drive
- 15 aggressively back to the detention, bouncing me in 16 the back of the car?
- 17 A Oh, I'm a hundred percent certain that we wouldn't
  18 have had the lights and sirens --
- 19 Q Oh, really?
- 20 A -- on.

21 Q Are you a hundred percent certain that your partner 22 didn't turn the volume up all the way in the car, so 23 that he didn't have to answer my questions about why 24 I had been arrested?

25 A I'm a hundred percent certain my partner has never
 26 turned the volume up --

1 Q Oh, really?

2 A -- a hundred percent --

- 3 Q A hundred --
- 4 A -- of the way, yes.
- 5 Q -- percent certain?
- 6 A That's correct.

7 Q All right. All right, so then at that point, you 8 got me back to the -- to the Saskatoon detention 9 cells, and at that point, you could hear me because 10 the car wasn't running anymore, and I was asking you 11 questions; right?

12 A (No audible response.)

13 Q And I was asking you the whole time about why I'd 14 been detained and arrested, and why you guys had me 15 in custody, and you weren't really able to tell me 16 anything concrete as to what was going on; right?

17 A That could be. At that point, you had --

- 18 Q You really --
- 19 A -- already been explained --
- 20 Q -- you really --
- 21 A -- that by Constable Keating --
- 22 Q -- had no idea --

23 A -- so --

Q -- that it was an obstruction charge at that point,
did you?

26 A I -- I wasn't -- I wasn't the arresting officer,

- 1 so --
- 2 Q You weren't aware?
- 3 A -- I didn't know --
- 4 Q You didn't know?
- 5 A -- what you were charged with.
- 6 Q No?
- 7 A (No audible response.)

8 Q Okay, so even when I asked you about, you know,
9 about what the circumstances were, you didn't really

10 make any attempt to try to, you know, contact Jay

11 Keating and -- and get him to tell me what -- what,

- 12 sort of, legal circumstances I was in, you made no
- 13 effort to do that?

14 A Is that the officer that had already explained that15 to you, is that what you're asking?

16 Q No. I'm asking if you made any attempt to contact

- 17 Mr. Keating?
- 18 A Well, I never made any attempt to contact --
- 19 Q Okay.
- 20 A -- Constable --
- 21 Q So --
- 22 A -- Keating --
- 23 Q -- but then --
- 24 A -- at all, no.

Q -- but then at that point, you took me back and you
booked me into the Saskatoon detention cells; that's

- 1 right?
- 2 A (No audible response.)
- 3 Q Right?
- 4 A That's correct, yes.
- 5 Q And you completely searched me, turned my pockets
  6 inside-out, took my belt out, took my cell phone,
  7 took everything?
- 8 A No.
- 9 Q Took all of my personal possessions?
- 10 A That wouldn't have been me, but that would have been
- 11 a detention special in --
- 12 Q It wouldn't --
- 13 A -- or constable.
- 14 Q -- have been you, but you -- you were standing right
- 15 there, watching; right?

- 5 Q Is that what you thought I indicated to you, that I 6 wanted to search for a lawyer's number, or that I 7 actually wanted to talk to a lawyer?
- 8 A I don't really understand the difference --
- 9 Q Well, you see --
- 10 A -- off the top --
- 11 Q -- I wanted to --
- 12 A -- of my head.
- 13 Q -- talk to a lawyer. I didn't want to look up his 14 name in a phone book. I wanted to talk -- to talk 15 to him?

  24 you put me in the north phone room, and you shut the

- 1 Q Or was that Constable Mitzul (ph)?
- 2 A No, that would have been me.
- 3 Q That would have been you?
- 4 A (No audible response.)
- 5 Q Are you sure because I have it on video, hey?
- 6 A Yeah.
- 7 Q I have the whole thing on video --
- 8 A Okay, well --
- 9 Q -- and I -- I can -- I'm pretty sure it wasn't you,

- 23 Q And so then you left me in there with a phone that 24 doesn't work?

  26 is they have to be dialed --

- 1 Q I'm aware --
- 2 A -- from the outside.

3 Q -- I'm aware of that, yeah. But you didn't think I 4 needed my cell phone, my cell phone -- that was off 5 limits, I couldn't have my cell phone to talk to a 6 lawyer?

- 7 A Had you have asked for your cell phone for a
  8 specific lawyer's number, I definitely would have
  9 gotten it for you.
- 10 Q Oh, well, you just said that I -- I said my lawyer 11 lives in B.C., so you didn't think I wanted to talk 12 to him?
- 13 A I asked you, and you stated that your lawyer lived 14 in B.C., and you no longer wished to speak to him. 15 Q No. And then you actually told me that I couldn't 16 make a toll free call, that I had to phone within 17 business hours, that I didn't have access to my cell 18 phone; is that correct?
- 19 A (No audible response.)
- 20 Q You completely --
- 21 A That's --
- 22 Q -- frustrated my rights to counsel?
- 23 A -- that is absolutely incorrect --
- 24 Q Really?
- 25 A -- because I wouldn't even say --
- 26 Q Okay.

- 1 A -- that to anyone.
- 2 Q We -- we can watch the video. I will remind you --
- 3 A Absolutely, sir.
- 4 Q -- you're under oath here, man.
- 5 A Absolutely.
- 6 Q We can watch -- we can watch the video when this is
  7 all said and done.
- 8 A Absolutely.
- 9 Q So at that point, I -- you say that I -- I indicated 10 to you that I no longer wanted to speak to a lawyer; 11 is that right?
- 12 A That's correct.
- 13 Q That's correct, but you never gave me a Prosper 14 warning?
- 15 A (No audible response.)
- 16 Q Is that correct?
- 17 A I wasn't the one that arrested you, so, no, I18 didn't.
- 19 Oh, okay, so you just -- you just decided that I'd Q 20 waive my right to counsel, now, after sitting in the 21 north phone room for 20 minutes, trying to use the 22 phone that didn't work, now, you advised me that I 23 had waived my right to counsel, you weren't really 24 that interested in giving me a Prosper warning, and 25 then -- and then so what did you do with me? 26 Α After you declined a lawyer, I took you to the

- 1 washroom, as per your request.
- 2 Q I declined a lawyer, did I?
- 3 A (No audible response.)
- 4 Q I declined a lawyer?
- 5 A That's correct.
- 6 Q It says right in your own words here, in your own
  7 notes, that I asked to speak to a lawyer.
- 8 A That's right. And then you changed your mind after
  9 I --
- 10 Q I changed --
- 11 A -- let you look --
- 12 Q -- my mind --
- 13 A -- in a phone book.

14 Q -- after you put me in a room with a phone that

- 15 doesn't work?
- 16 A The phone --
- 17 Q Did you think I was, maybe, frustrated out of my18 right to counsel?
- 19 A Well, the phone does work, sir. It just has to be20 dialed by a police officer.
- 21 Q But you didn't dial. You went down to the basement?
- 22 A Had you asked me to dial a certain number, I
- 23 certainly --
- 24 Q I -- was I --
- 25 A -- would have.
- 26 Q -- was I supposed to have known that the phone

- 1 didn't work, that I would be required to ask you to
- 2 dial it on my behalf?
- 3 A Okay. No. I'm not going to --

Now, did Constable Keating, did Constable 5 McAvoy, or did Constable Vince Schaefer, did they 6 make any comments to you about a combat or a 7 fighting or a striking or aggression by me? 8 I didn't have time to question them on that. Α 9 Q There was --10 I just --Α 11 Q -- not a lot of time? 12 Α No. 13 You -- you would agree with me that there was not a 0 14 lot of time? 15 Α Not a lot of time to -- to hear that, no. 16 Things happened --Ο 17 Α That's correct. 18 -- very quickly? 0 19 Α Absolutely. 20 According to the video, about seven minutes? 1 hear about you, before you actually make any actions? 2 3 I'm not familiar with that term, sir, no. Α 4 Not threshold, not, like, waiting or -- you know, if Q 5 someone asks you a question, would you feel that, 6 you know, a 30 second window of time to talk about 7 that would be a fine threshold, or would that be too 8 soon? 9 Α I -- I'm having trouble understanding your question. 10 Okay. If I'm going to ask you a question, and 0 11 you're going to respond, but it takes you a few moments to respond, I would consider that as a 12 13 threshold. And what's going on?" 22 And this man got out of his 23 car and aggressively approached me and assaulted me, 24 ran at me, attempted to tackle me, grabbed me into an arm bar, and just started screaming at me. 25 He 26 completely lost it. I had no idea what it was

about, what was going on. This man refused to
 identify himself to me, and just informed me that I
 was under arrest, and I needed to comply, I was
 under arrest.

5 I objected to this. I -- I 6 told him to just get his hands off me. I didn't 7 know what it was about. I wanted him to identify 8 himself to me, and explain what the situation was, 9 why he was, you know, assaulting me at this point. 10 And he knocked my hat of my head, and grabbed my 11 sunglasses and threw them off to the ground and 12 threatened to pepper spray me, unless I was 13 -- unless I complied to have my handcuffs on behind 14 my back.

15 Now, I certainly didn't want 16 to be pepper sprayed, so I complied. I -- I put my 17 hands behind my back, and allowed this man to arrest 18 me, but he still was very aggressive with me, and would not answer any of my questions regarding 19 20 whatever seemed to be the problem at this point. Ι 21 had no idea. But he did really seem to want to 22 arrest me. That was first and foremost in his mind. 23 So I complied with his 24 demands under -- against getting pepper sprayed, to be handcuffed on behind my back. And at this point, 25

the man was still freaking out, would not answer any

of my questions. And for some reason, he phoned
 backup, he just decided to call backup. He was
 freaking out.

4 Now, at no time did I refuse 5 to identify myself. At no time did I refuse 6 anything. I had my driver's license in my pocket. 7 I believed that because I was in a private parking lot, that he didn't really have much authority over 8 9 me to affect a traffic stop, and I can back that up 10 with case law. But at the same time, I never 11 refused to identify myself. I know Section 209.1 of 12 The Traffic Safety Act and what it entails, and I 13 knew what my rights were in that parking lot. And I 14 simply wanted to know who this man was and what was 15 going on.

16 And at this point, he started 17 to tell me, "Just shut the fuck up, douchebag." I 18 didn't -- he didn't want to answer any of my questions. So I asked this man if he was a police 19 20 officer or a peace officer. And he told me that he 21 was a peace officer. He said, "I'm a peace 22 officer." And I said, "How have you observed me 23 breach the peace?" And he said nothing. And I 24 asked him again, "How have you observed me breach 25 the peace?"

26

And by this time, cop cars

1 were coming from all directions because he'd phoned 2 backup. And at this point when I asked him again 3 how he'd observed me breach the peace, he told me 4 again, "Just shut the fuck up, douchebag." And I 5 began to really worry about my safety because there 6 seemed to be nothing I could say to this man that 7 would get him to de-escalate the situation and just relax and take his hands off me. 8 9 At that point, I just 10 remember cars coming from all directions. Ten 11 police vehicles ended up responding to the scene, with -- cars came from all directions in the parking 12 13 lot. 14 And another -- the first car 15 that arrived into the parking lot was an unmarked 16 black car. And my brother was with me at this 17 traffic stop. And he was protesting what this 18 -- this police officer was doing to me. He was 19 protesting the actions of this man and was making 20 him aware that he was assaulting me and he needed to 21 let me go. 22 We didn't really -- really 23 take kindly to this -- to this treatment and the 24 fact that he wasn't answering our questions. And 25 upon the vehicles responding to the parking lot, 26 like we said, the first vehicle that responded was

1an unmarked car operated by Constable McAvoy and2Constable Schaefer.

3 And they immediately got out 4 of the car, ran towards my brother. And Jay Keating 5 just pointed at my brother and said, "Take him down, 6 take him down." That was it. That was the only 7 instruction that was given. That was the only thing that I heard. And I had to stand there and watch 8 9 it, while Jay Keating just was violently swinging me 10 around using the handcuffs behind my back as a pain 11 compliance device.

And subsequently it led to about -- well, I mean, ten police vehicles responded to that scene, so I'm going to say there's probably seven or eight people piling on top of my brother, pinning him to the ground, violently striking him, punching him, telling him to stop resisting.

18 And at this point I was, kind 19 of, freaking out. I didn't really know what to do. 20 I had no recourse as to make these men stop. I did 21 not understand what had happened at all. No one had 22 given me any explanation as to what was going on, 23 what the reasons were for this. And, now, they were 24 violently attacking my brother, savaging my 25 brother.

26

So subsequently some of the

1 officers that responded to the scene -- one of them 2 grabbed me and took me back to his squad car. This 3 man never identified himself to me. He took me from 4 Jay Keating. At this point, no one had read me my 5 rights. No one had informed me of the reason for my 6 detention. He took me back to their squad car, 7 threw me in the back of it. 8 My brother, at this point, 9 was still being pummeled on the ground. He was 10 still being pinned to the ground. They pinned him 11 to the ground for several minutes. And then I had 12 to watch as they dragged him up off to the other car

and put him in the back of that car. And we both

minutes, while the police just searched my vehicle,

sat in the parking lot for probably about ten

searched everything, searched right through the

17 car. 18 At this point, there was, 19 like I said, ten -- ten police vehicles and about 18 20 or 19 officers at the scene. And they had the 21 whole, entire parking lot shut off. There were cop 22 cars everywhere with lights and sirens. And they 23 proceeded to just go through my vehicle. 24 And still no one would really

answer my questions. People kept demanding to know
what my name was, and I told them, "My name is

1 Jarvis." I told them it was my car. And then it 2 seemed to steer towards some sort of drug 3 They started asking me where the investigation. 4 drugs were, how much coke I'd done or -- you know, 5 or did I throw the drugs out the window of the car 6 when I moved into the parking lot, where were the 7 drugs? 8 And they were savagely going 9 through the back of my car, violently going through 10 everything, the backseat, the trunk, which is all 11 -- you can see it all on the video, corroborated. Within four and-a-half 12 13 minutes of us being pulled over by Jay Keating, we 14 were both in handcuffs in the back of separate squad 15 cars, and ten police vehicles and 18 officers had 16 responded. And Jay Keating was going through my 17 vehicle, without either of us having known what 18 -- the reasons for being stopped. 19 And then we were taken back to detention cells. I was booked into Saskatoon 20 21 detention by two different officers. Those were the 22 two that testified yesterday, officers Boyce and officer Hounsell -- or constables or whatever you 23 24 want to call them. And they took me back to detention and completely searched me, took all of my 25 26 personal possession away from me, took my belt, took

1 my wallet, took my cell phone, emptied my pockets, 2 took -- you can see it all on the video, searching 3 through even the -- the pockets in my wallet, and 4 then put me into detention cells. 5 And the whole time, I -- I 6 didn't consent to these searches. I told these men 7 that I thought they were all acting unlawfully. I 8 didn't really appreciate them searching me without 9 any reasonable cause. But they still were pretty 10 insistent, or I think thought they were going to 11 find drugs or something on my person that would constitute a criminal offence because I was 12 13 threatened the whole time that if they found drugs, 14 I would be charged. And as soon as they searched, me, you know, I'm going to be charged. 15 16 So they searched me through, 17 and the whole time I requested to talk to a lawyer 18 before any of this happened. And they seemed to be 19 more intent on booking me and searching me and 20 getting me into detention before they were going to 21 let me talk to a lawyer. So they did that and got

22 me in. And finally I requested to talk to a lawyer 23 and two of the constables put me into the phone room 24 in the Saskatoon Police detention cells and then 25 left -- and then left. And I can corroborate that 26 with video of me in the north corner.

1 And the phone that I've cited 2 multiple case law for that in my Charter application 3 there about the phone room in the Saskatoon Police 4 detention cells because it doesn't actually work. A 5 person that goes into the phone room can't actually 6 operate the phone. The phone is operated from 7 outside of the room. Now, I did not know this. 8 I 9 had no idea about this going into it. I thought I 10 was just going to go in that room and be able to talk to a lawyer -- or my lawyer, I should say, 11 12 because I have a lawyer. My uncle is a lawyer. Ι 13 actually know several, and there was multiple people 14 I could have phoned at that point, multiple people I 15 could have phoned just to make arrangements in my 16 life because I can't just -- you know, I had no 17 intention of going to jail. You know, I had things 18 to do at home. 19 I had arrangements to take 20 care of. It was actually -- the day it happened was 21 my birthday, so I was going to have a party at home 22 the next day. So I had some things to take care 23 of. 24 So they stuck me in this 25 north phone room, and then they left. These 26 officers decided there was something else more

1 important to do and left to go to the basement or 2 -- or do something else. And they left me in the 3 And it's corroborated on the video of me in room. 4 the room, basically losing my cool, getting 5 completely frustrated because I'm stuck in a room 6 with a phone that doesn't work. 7 And these men that put me in 8 this room seemed to think it was funny. They seemed 9 to think this was a cute little -- you know, a game 10 they were playing, to just deny me my right. 11 And so I got really scared. 12 I stayed in the phone room for about five minutes. 13 I think we'll -- I'll enter the video here, so we 14 can watch that. But I stayed in the phone room for about five or ten minutes before I was actually so 15 16 scared that I needed to use the washroom. 17 So at this point they had put 18 me in there and forgotten about me, so I started 19 yelling and banging on the door, so someone would 20 -- so -- to come and just -- you know. And so I 21 -- I -- I called someone to the door finally, and 22 they allowed me to use the washroom. 23 And at this point, I was 24 pretty upset, and I told them as such. I told them, "I don't know what you think you're doing, but I 25 26 have the right to talk to a lawyer." Your phone

1 doesn't work. And they informed me, "Yes, we know 2 that. You know, we know our phone doesn't work. We 3 need to dial out for you." I said, "Okay, well I 4 want to talk to my lawyer. He lives in B.C." 5 Now, at this point one of the 6 constables did a really great job of frustrating my 7 right to counsel because he began to tell me that I could not make a toll free call. He told me that I 8 9 could only make a call between normal business 10 hours, to -- to a lawyer, to someone that we knew 11 -- that they knew had to be a lawyer. I couldn't 12 just phone anybody, and that I didn't have the right 13 to use my cell phone. The conditions of me being in 14 jail were that I had no right to use my cell phone 15 and make the call to anybody. 16 And so I was pretty worried 17 at this point, but I thought, still, well, okay, I'll -- I'll phone somebody. You know, that's fine. 18 19 So they put me back in the phone room, and I 20 instructed them that I did want to talk to my uncle, 21 who is a lawyer in B.C. I did want to talk to him. 22 I wasn't really that concerned about his toll free 23 call system, whether or not I was going to make the 24 call on his phone or my cell phone. My cell phone was able to operate out, no problem, and I had his 25 26 number right in there.

1 So he -- he informed me that, 2 "Okay, just sit tight in the phone room," and he'd 3 take care of it, he'd go and get me my cell phone. 4 Anyways, I waited in the 5 phone room for another -- probably ten or 15 minutes 6 before detention staff came back to the phone room 7 and just grabbed me, told me, "Let's go, it's time 8 to go," pulled me out of the phone room, and took me 9 out and took me back to cells, despite my protests. 10 Now, and the whole time, I -- I informed them, "I 11 have not made a call. I'm not satisfied with my 12 right to counsel. I am not satisfied with any of 13 this." And they said, just basically, "Shut up, 14 buddy. Right here," pulled me away, and threw me 15 into detention cells.

And one of the officers at 16 17 that point, who I had never met -- it was different 18 guys, it was a different chain of command the whole 19 way through. I dealt with at least a dozen officers 20 that night. One of the officers informed me, 21 basically, "Don't worry, it will all be over soon." 22 He just appeased me, "Don't worry, it will all be over soon." So I did start to relax a little bit. 23 24 I mean, I was in jail and I hadn't phoned a lawyer, 25 but I thought maybe at this point, they were really 26 close to releasing me. I thought, okay, I'll be

able to get out of jail here. You know, at least I
 can phone a lawyer on my own time.

3 Well, at that point,

4 Constable Schaefer came back to my cell. Now, me 5 and my brother were attempting to communicate within 6 the bottoms of the prison cells, so I could see how 7 he was doing because at this point, my brother had been badly beaten up, and I didn't know how he was. 8 9 Nobody seemed to want to inform me as to how he was 10 doing because he just had his head smashed off the 11 pavement in the parking lot. And the last I saw 12 him, you know, he was bloodied and bleeding, all 13 messed up.

14 So anyways, Constable 15 Schaefer came back to my cell to start asking me 16 some questions. And I informed Constable Schaefer 17 that I had not talked to a lawyer, I was not 18 satisfied with my right to counsel. And I had no 19 real right to answer any of his questions until I 20 talked to a lawyer, until I had -- and he didn't 21 really seem to care. He didn't really seem to think 22 that my legal rights mattered. He just performed 23 his little investigative detention there, while I 24 was in jail, and asked me a bunch of questions, and I insisted that I inform them or -- or tell him who 25 26 my brother was because he didn't seem to think -- he

1 didn't seem to know who my brother was. He couldn't 2 identify him, even though the -- he was in 3 detention, and he'd just been booked in and given 4 the front desk all of his information. Neither of 5 us ever refused to identify ourselves at any time. 6 We'd just been booked in.

7 You can watch all of the 8 video. We were quite compliant in going through 9 jail, despite having just been beaten up and 10 arbitrarily detained. But there was no problem 11 anyone identifying themselves or saying who we were. 12 We both were -- had nothing to hide. We both have 13 clean criminal records and a clean driving abstract. 14 There was nothing to hide. There was never any 15 reason for us not to identify ourselves, but 16 Constable Schaefer really wanted to know everything 17 about me and this stop. And, again, the subject 18 matter turned quickly to drugs, where the drugs 19 were, you know, where were they going to find the 20 drugs in the car? You know, what's going on with 21 the drugs?

22 And I told him at that point, 23 I just -- "I don't want to answer any more of your 24 questions. I want to speak to a lawyer." And he 25 said, "Fine," he'd take care of it. And so he left 26 and left me in cells. And it wasn't until probably

1 an hour and 20 minutes after the initial check-stop 2 that I was in detention cells that Jay Keating came 3 back and visited me in detention. And he informed 4 me that, yeah, he was going to give me a bunch of 5 tickets -- traffic tickets, and that was it. And I 6 asked him if he thought this was -- if he thought 7 that he had the right because he was going to give me some traffic tickets, to arbitrarily detain me 8 9 and throw me in jail. And he thought that was no 10 problem at all, and I was going to spend the night 11 in jail, and, you know how dare I, basically. And 12 that was that. That was pretty much as close. 13 And then still -- I still 14 informed him that I hadn't talked to a lawyer. I wasn't satisfied with my right to legal counsel. 15 16 And he basically did -- just informed me that he 17 didn't care, he wasn't really concerned about that. 18 And then he sarcastically made a comment that he thinks from -- the detention staff had said I waived 19 20 my right to counsel somehow. 21 And he -- he even put that in 22 his notes, which I thought was pretty shocking that 23 all the way through that he would just say that I 24 waived my right to legal counsel. And I can -- I can show the video. And we'll all see what happened 25

to me in the phone room. And I was never given an

26

1 adequate chance to phone legal counsel. 2 But, anyways, Jay Keating 3 gave me a bunch of tickets for this offence, which 4 were subsequently withdrawn from the Saskatoon 5 Police Service. And I have a letter here that I can 6 enter into evidence, if you'd like, from the 7 Saskatoon Police, saying all of the tickets that I 8 received at that stop are withdrawn. 9 THE COURT: Just a moment because I have 10 a number of tickets here. Yeah. And I also have my 11 THE WITNESS: 12 -- my invoice from SGI, where I bought my car. 13 They're alleging that my car wasn't registered. And 14 my car was, in fact, registered in my name. 20	asking me these questions?"
21	And they were pretty
22	insistent that something was really wrong. They
23	were calling me all kinds of names and just freaking
24	out at me and how dare I, you know, do this? "And
25	why were all of these cops here?" "And what the
26	hell was going on?"

1 And nobody really seemed to 2 know what was going on. So they're still just 3 grilling me in the back of the car here, and I'm 4 asking them who they are. No one at this point has 5 identified themselves to me. I'm asking them who 6 they are and what the problem seems to be, "What's 7 -- what's going on? What is it that I've done that 8 you're detaining me, now, and you've beaten the crap 9 out of my brother and have us back -- in the back of 10 separate squad cars?" 11 So, of course, this is the 12 commanding officer, now, I believe. This is -- Jay 13 Keating didn't seem to know who this guy was, but 14 this is Jeffrey Nashgal (ph) and his partner, D.J. 15 Swanstrom (ph). And that's Brad McAvoy. Now, on 16 -- on the screen, Mr. McAvoy is searching under my 17 vehicle. They went right through my car, 18 absolutely, all through the wheel wells, underneath 19 my car with a flashlight, through every part of my 20 car just in an attempt to find something criminal, I 21 guess. I don't really know why they went through my 22 car, but at this point, as you can see, there's four 23 officers on the screen. At some point, there was at 24 least -- probably six or seven guys going through my 25 There's still probably two guys going through car. 26 the front door of my car.

1 And, now, here's Constable 2 McAvoy attempting to explain what happened and why 3 they'd used force and why the whole parking lot is 4 filled up with police cars. 5 And they don't really know at 6 this point. No one has asked me any questions as to 7 why -- they don't -- it has nothing to do with a 8 traffic stop because nobody ever asked me for 9 license or registration or -- or anything to do with 10 It was all about drugs. It was all any of that. 11 -- you know. And -- and when I started asking 12 questions, they just told me to shut up. So then I'll -- I'll 13 14 fast-forward the tape. I mean, all you really see 15 here, now, is just cops searching through my car. 16 It's not really -- I mean, there's not really much 17 to see. 18 But I still haven't been read 19 my rights. I'm still in the back of the car. My 20 brother hasn't been read his rights yet. My brother 21 hasn't been read his rights, and we still haven't 22 been given a reason for our detention, but the cops 23 are still searching through our car. And they're 24 still -- some of them are still asking us 25 questions. So it's not until about 26

1 -- and there's still -- there's still probably about 2 50 to 100 people watching. It's classic cruise weekend, and 8<sup>th</sup> Street was just lined up with 3 4 people, so there's people everywhere. 5 So at some point the cops 6 become frustrated with us, and decide to just get us 7 out of there. Jay comes up and just decides that he needs these guys out of here right now. 8 9 I'm backing the video up here 10 because it's not until this point -- 19:14:30 11 -- until we leave. He gets us, he puts us in the back of a squad car, and we leave the -- leave the 12 13 parking lot, on to SPS detention cells. 14 Now, I guess that's not really that important, so I'll fast-forward it here. 15 16 You can see Jay Keating. This is at 19 -- this is 17 20 minutes after. They're still going through my 18 car. At this point, I've been -- me and my brother are both at SPS detention cells, and they're still 19 20 searching throughout my vehicle. And it remains 21 this way for -- I mean, Jay Keating didn't come back 22 to SPS detention cells for probably an hour 23 and-a-half after this traffic stop. So he stayed at 24 the side of the road, going through my car, going 25 through my car. 26 Now, this is 1923. They're

still going through my vehicle. Oh, sorry, I went too far ahead. But anyways, so that's Sergeant Spot (ph) arriving. That's 25 minutes after seven, and then they're still going through my car and searching it.

And this is where the video just ends. The -- the police's dash-cam video just ends there at 25 minutes after. But I didn't see the cop there for an additional -- probably hour before I got back to prison.

11 But, anyways, this is me 12 arriving in Saskatoon Police detention cells, in the 13 car 231. Now, this is Constable Boyce getting out 14 of the front driver's side, and Constable Hounsell 15 getting out of the passenger side. Now, they're putting their gloves on. And they've been 16 17 threatening and intimidating me. They've refused to 18 answer any of my questions. And they've been 19 threatening and intimidating me the entire way back 20 to detention.

They kept the radio in the car volume all the way to the top, so they couldn't hear me in the back. And they had me handcuffed in the back of the car, behind my back. And they drove really aggressively around -- around corners on the way to the police station in an attempt to bounce me

1 around in the back of the car. 2 And despite me yelling at him to slow down, there was nothing I could do. 3 They 4 seemed to think this was really quite funny. 5 As you can see, I'm quite 6 compliant. I don't really put up much resistance. 7 But this entire time, I'm 8 questioning these two officers as to why they -- why 9 they have me detained, why they're arresting me, why 10 they're booking me in the jail. And they don't 11 really seem to have any answers for me. All they 12 can really do is insult me and call me a douchebag. 13 And so I do start to inform 14 them that if they don't really -- if they don't really know what's going on, they should ask a 15 superior officer, otherwise they're going to be 16 17 -- I'm going to -- you know, file some civil action against them because I don't really appreciate being 18 19 arbitrarily detained here and being booked into 20 jail. 21 But they don't really seem to 22 care about that. They're still convinced at this 23 point that I have something in my pockets, or 24 they're going to search me because they're telling me the whole time, "When we find drugs, we're going 25 26 to charge you." "If we find anything on you, you're

1 going to be charged." "And once -- and once we find 2 the drugs, you're going to get charged. Don't 3 worry."

4 You know, so this is me at 5 the front desk in Saskatoon Police detention cells. 6 Now, you'll notice the whole time, Constable 7 Hounsell -- Hounsell -- he's in the top right of the screen. He's constantly on his radio because he's 8 9 in contact with the people that are still at the 10 traffic stop. And he's still talking with Keating 11 and asking because they're still trying to find 12 something criminal against me. They're still trying 13 to come up with a criminal charge to try to justify 14 the fact that they just kicked the shit out of two 15 guys and thrown them in jail.

16 So he's still asking me 17 questions. You can see Constable Hounsell and 18 Constable Boyce are asking me questions about drugs, how much coke had I done? "We're going to find the 19 20 drugs, when we go through you here. We're going to 21 search you right through."

22 And I'm telling them that I 23 don't consent to any searches. "You have no 24 reasonable cause to -- to detain me or to search me. And this is all against my -- " you know, I -- I 25 26 knew the *Charter* at this point. I mean, I knew my

1 rights at this point, and I knew this was a 2 violation of my Charter rights to just search me 3 like this. They've already patted me down at the 4 scene twice. They've already basically searched me 5 at the scene, patted me down, grilled me about 6 everything that I could have possibly had. 7 But they're determined, now, 8 to search me again. So -- and at this point, again, 9 he's -- he's come over again and they're grilling 10 me. I'm at the front desk. Like, "What are we 11 going to find?" You know, "What's -- what's -- as 12 soon as we find what's in your pockets, you're going 13 to be charged." You know, that's it, that's that. 14 "We're going through you. There's nothing you can 15 do. You're going to be searched." 16 So here they are booking me 17 in, now. As far as Jay saying I refused to identify 18 myself. I don't know. This is about 15 minutes 19 after the initial stop. And I'm -- I'm telling them 20 all of my information. They've got my -- my 21 driver's license at this point and they've got my 22 name. They know -- I -- I -- there's no way I would 23 ever refuse to identify myself. The fact that he's 24 arrested me for obstruction for disobeying his 25 lawful commands and not mention anything about 26 refusal to identify or anything like that is absurd.

1 I think it's absolutely absurd. 2 So I'm telling this man I 3 don't consent to his searches. And he's going right 4 through everything. He ends up turning my pockets 5 inside-out. He ends up taking my belt. They take 6 all of my possessions. They take my shoes. They've 7 already got my hat, my sunglasses, my necklace. I had some mail -- or I had, like, a little thing that 8 9 I needed to pick up some mail from Shopper's Drug 10 Mart, and they took that. They took everything away 11 from me. 12 Are -- is this -- do you want 13 to watch this or? 14 THE COURT: Sure, go ahead. 15 THE WITNESS: It doesn't take very Yeah? long. It should be over pretty shortly here. So 16 17 that's the ticket for my mail, as well as my cell 18 phone. And you can see the cops have no problem just going through. He -- he looks at my mail, he 19 20 reads it right through. He goes through my cell 21 phone, checks my numbers, checks to see who I've 22 been calling. 23 He started smelling my cell 24 phone. This is why I'm -- you know, they were so 25 convinced I had drugs, he starts smelling my phone 26 right here. I don't know why he's smelling my

phone. And he does it several times. Look at that. Ew, it smells. I -- I don't know what that's about.

4 Maybe I should have asked him 5 something about it yesterday, if there's something 6 he was smelling for, but, anyways, so, now, my 7 pockets are turned inside-out. They've taken my They've taken my belt. They've taken 8 shoes. 9 everything. They've refused to answer any of my 10 questions about why I'm in there and why I've been 11 detained. And it didn't -- and you can see 12 Constable Hounsell radioing in, now, back, that they 13 haven't found anything. "There's no drugs, we 14 haven't found anything on this guy." 15 Okay, and I'm insisting that I want to talk to a lawyer. I want to talk to a 16 17 lawyer now. I don't need to answer any more of your 18 questions or do any -- any more for you guys. I

19 want to talk to my lawyer because you've just jacked 20 me up.

And so I'll fast-forward it

1 they're looking for, I guess. I don't know. 2 Okay, so at this point, I've 3 indicated, I want to talk to a lawyer. And so this 4 is -- I'm going to pause it right here because 5 Constable Hounsell said on the stand yesterday that 6 he gave me a phone book and put me in the north room 7 -- phone room. Now, Constable Hounsell is the 8 furtherest (sic) person from me. And you can see 9 Constable Boyce pointing towards the phone room. 10 But that's literally what he did. He pointed 11 towards the room. "The phone room's over there." 12 "Yes, it's just over there." So as you can see 13 -- and in his testimony yesterday, he said that he 14 got me a phone -- a phone book and -- and -- to look 15 up my lawyer's number with, and put me in the north 16 phone room, to use the phone. He pointed to a room 17 with a phone in it, with a phone that doesn't work, 18 and then decided he needed to leave. The three of them decided, that's -- that's good enough, that's 19 20 their implementational duty fulfilled for my right 21 to counsel. Now, I'm in jail and I'm in the phone 22 room. 23 And I had no idea this phone

24 would not work. I mean, I didn't think there would 25 have been a problem giving me my cell phone, so I 26 could make a call. Here it is again. This is just

1 from another angle. But you can actually see a 2 little better from this angle, when they put me in 3 there. So they're just pointing at the room. 4 And this is Constable Mitzul. 5 I never heard his -- got a report from him or 6 anything, but you can see, he puts me in the phone 7 room, and he literally skips away. Like, a little 8 girl. He's all too happy to go, now, talk on the 9 elevator with his buddies and laugh it up about the 10 guy they just stuck in the phone room. 11 So here I am. This is the 12 north phone room. And they put me in the room. And 13 you can see the first thing I do is reach for the 14 I'm not -- Constable Hounsell there says he phone. 15 -- he put me in there, so I could look up my lawyer's number with. Well, I knew my lawyer's 16 17 number, and I was going to phone him. So the first thing I did was went into that room and I picked up 18 the phone and tried to dial. But wait a minute, 19 20 it's not a proper phone. It doesn't even have 21 numbers on it. There's no dial tone. You know, it 22 might as well say "Fisher Price" on the side of it. 23 So I'm pretty nervous at this 24 point because my brother's been beaten up, and I 25 don't really know how he is, and they have 26 completely searched me, taken all of my possessions,

1 and I really have no idea why I'm in jail. It's my 2 birthday. I've just -- I was just over at my 3 friend's house. They're probably getting worried 4 about me. I'm going to have a party at my house the 5 night after, so at this point, I need to make some 6 arrangements because I'm in jail and I really don't 7 -- I really don't know what for, and I really don't know, you know, what legal jeopardy I'm in. 8 9 So here I am. And this is 10 really painful to watch because I'm trying to use a 11 phone that doesn't work, and I don't realize that it 12 doesn't work. I'm thinking at any time a dial tone 13 is going to click in, it's going to get an operator 14 or something. There's no numbers you can dial. And 15 when you lift the receiver, there's no dial tone 16 -- no -- no dial tone. 17 So here I -- here I sit. And 18 the officers thought there was something more 19 -- more important to do. And that'll be my right to 20 counsel. 21 So this is them after putting 22 me in the phone room and leaving. That's Constable Hounsell, the first one on the elevator. This is 23 24 Constable Boyce, and this is Constable Mitzul. 25 Now, you can see them start to laugh here and joke it up because they think it's 26

1 pretty funny to stick somebody in the phone room and 2 not give them a call. This is quite humorous for 3 them.

And they're -- yeah, they're going down to the Sally port, I believe, to help with my brother because my brother is coming into detention next. But we'll get to that in a second here. I can probably fast-forward it because this isn't really that interesting.

10 So here I am, still in the 11 phone room. And, now, I've given up on the phone. 12 And I'm trying to yell or get the attention of 13 people because there's a bunch of people at the 14 front desk. I'm trying to get the attention of 15 someone to let them know that their phone's not 16 So I'm still, you know, trying the phone working. 17 to figure out what's going on. I figure, maybe it's 18 going to ring at some point or something's going to 19 I'm not really sure what I'm expecting. happen.

20 But at this point, I am 21 trying to attract the attention of the detention 22 staff because, yeah, I have a phone that doesn't 23 work, and they're not really interested.

24 So this is why our Constables 25 Hounsell, Boyce, and Mitzul there needed to -- to 26 leave, is they needed to be in the basement. This

1 is my brother right now. You can see Constable 2 Boyce there waving at my brother the whole time, 3 attempting to threaten and intimidate him. 4 Now, there's seven officers 5 in here to pull my brother out of the back of this 6 vehicle. Now, my brother is already in handcuffs 7 and already been beaten. 8 MR. PASHOVITZ: I just -- I apologize. I 9 wonder if that could be paused for a moment, Your 10 Honour? (VIDEO PAUSED) 11 MR. PASHOVITZ: I indicated I would consent 12 13 to this being played to see whether it's appropriate 14 or not, but there's a whole lot of editorialism 15 going on here. 16 THE COURT: Well, that's -- he's --17 MR. You can see me, now, really frustrated. I'm yelling gout to try to get the attention of whoever is in detention there, that I need to use the phone.

So the -- finally somebody 16 17 notices me. Now, at this point, I -- I tell them that their phone doesn't work. I don't know what 18 19 they're trying to pull here, but I have rights, I 20 need to talk to a lawyer. And I also informed them 21 that I really need to use the bathroom. Now, I'm 22 pretty scared at this point, and I need to use the 23 facilities. Since this whole thing has happened, I 24 haven't been able to use the washroom. So I need to 25 use the bathroom.

26

So at this point, he takes me

1 to the bathroom. I can probably fast-forward that 2 because I'm sure that's not of interest. But at no 3 time did I ever waive my right to counsel. At no 4 time did I ever say I was satisfied with my call 5 -- call to counsel. I was completely frustrated out 6 of my right to counsel. 7 But at this point, I informed 8 him that I want my cell phone, as well. "I would 9 like to make a call to my lawyer, and if you guys 10 are going to try to frustrate me and tell me that I 11 can't make toll free calls, that I have to phone a lawyer, that I'd like my cell phone to make a call 12 13 then, I don't need to use your phone." 14 So at this point he takes me 15 to go and use the washroom. This is -- I'll 16 fast-forward this because this is pretty uneventful. 17 So I go and use the washroom, and he brings me back 18 into the north phone room, so that I can make the 19 call. 20 So, now, I've instructed him 21 that I do want to talk to my lawyer. He never -- I 22 mean, it's up to him to -- to make the call. He never asked me for the number. He never asked me 23 24 for anything. I asked him for my cell phone. I asked him -- or told him that I wanted to talk to my 25 26 lawyer. And I explained it to him in great detail.

1 I seemed to know what my rights were a lot more 2 clearly than this constable did.

3 And I'm explaining as such, 4 right now, that I -- I don't know what you're trying 5 to pull here, but I need to make some calls. You 6 guys have arrested me and I'm in jail. I need to 7 know that -- what I'm been -- what I'm actually being charged with because it's not even that much 8 9 good for me to talk to a lawyer if I don't even know 10 what I'm being charged with or what my legal 11 jeopardy is.

12 So I'm explaining this to 13 him, that, "I want my cell phone, and if you don't 14 have a good enough reason and you're not even going 15 to let me talk to a lawyer, like, I want to leave. 16 I want to go home at this point. I'm not happy 17 being here. This is an arbitrary detention the 18 whole way. And if I -- if you're not going to tell 19 me what I'm being charged with and you're not going 20 to have any regard for my rights, I'd like to go 21 home."

22 And so I explained that to 23 And he said, "Great, no problem." And he goes him. 24 back, as far as I'm concerned, to go maybe make the call for me or get my cell phone. I'm still waiting 25 26 to make a call and get my cell phone. So I tell him

1 to get on it, "Go get my cell phone," you know, "Go 2 phone my lawyer. His name is Gordon MacDonald. He 3 lives in B.C."

4 And so at this point, I'm still not sure what I'm waiting for. Is the phone 5 6 going to ring? I don't -- I don't really know 7 what's -- what's going on. Or is he going to come back with my cell phone and let me make a call on 8 9 that? You know, I really don't know what, but no 10 one really seems to have any regard for me or my 11 rights at this point. I'm pretty concerned for my 12 personal safety because, now, it's been -- oh, it's 13 probably been at least 45 minutes to an hour since 14 the initial stop. And nobody seems to have any 15 regard for my rights. No one even seems to be 16 willing to answer any of my questions. 17 The -- the initial -- the 18 arresting officer isn't back at detention. He's

19 still back at the scene with my car.

20 And so I can fast-forward 21 this a bit, because this is literally just footage 22 of me waiting in the phone room for the phone to 23 ring or waiting for something to happen in the phone 24 room. I'm just waiting, waiting, waiting for 20 25 minutes. I'm still waiting to make a call.

No one's come back to see me

1 now. I haven't gotten my cell phone. The phone 2 hasn't rang. No one's offered to really dial it for 3 me or -- or inquired about that. I'm still -- so 4 I'm still just waiting for my cell phone, waiting to make the call, not really sure what's going on 5 6 because I'm -- I'm pretty sure they're still trying 7 to find something in my car. They're still -- so I 8 -- I really don't know what I'm being charged with 9 at this point or what their -- monkey business these 10 people are playing. 11 Oh, I must missed it. So 12 finally at this point -- I'll fast -- I'll back it 13 up a bit here. Finally at this point -- I'm going 14 to call this guy Rambo. I don't know who this 15 -- this constable is that comes to the -- the room 16 here, but I've never seen this man before that's 17 about to show up to the room. He's a huge guy, 18 probably the biggest cop. And he simply says, "Let's go, let's go." And I say, "Hey, I haven't 19 20 made a call yet, what's going on?" "Let's go." And 21 he simply points to the -- to cells. "You're going 22 to cells." And his partner there says, "Like, let's 23 go, right now." 24 And you can see me

25 protesting, putting my hands up, saying, "I haven't 26 even made a call yet. What's going on?" "Let's go,

1 let's go." And they usher me into a cell. That's 2 it. I don't have the right. Two guys. I've never 3 really -- I've never even said -- I've never seen 4 the -- the two guys before, now, at this point, but 5 they stick me in the cell. 6 And so there he is. And I'll 7 call him Rambo because he's huge. And at this point, I start to explain myself. At this point, he puts 8 9 me in the cell, and I say to this man, "So that's it 10 then? You just throw me in jail, and you don't even 11 let me make a phone call? You beat the crap out of 12 my brother. I have no idea what's going on, and, 13 now, I don't even have the right to counsel? Like, 14 I don't know what you're trying to pull here, but, 15 you know, please, if you can figure it out, like, 16 I'd like to talk to a lawyer, I'd like to know 17 what's going on, and I'd like to go home because you 18 don't really seem to have a good reason to keep me in here." 19 20 So I explain it to this man, 21 and this man placates me. This man says to me,

22 "Don't -- don't worry, buddy. It will all be over 23 soon. Don't -- you know, just don't -- don't sweat 24 it, no problem." And I say, "Okay, but I'd really 25 like -- you know, like to know what's going on at 26 this point because you've just -- as far as I'm

1 concerned, I have no rights from -- from you people. 2 And you -- you don't seem to be the least bit 3 concerned about my wellbeing or safety. Like, 4 you've just throw me in here." 5 And he leaves. I never saw 6 that man again either. So, now, basically, I'm in 7 jail for the night, that's it. He didn't see any 13 -- fit to answer any of my questions when I asked 14 him who he was and what -- what the problem seemed 15 He didn't even identify himself. He didn't to be. 16 say what the problem was. He didn't say anything. 17 Tell me how you exited your vehicle? 0 Okay. 18 I opened the door and got out, man. Α Okay. And then what did you do after that? 19 Q 20 I just basically stood by the side of my car. I Α 21 realized at that point that this man wanted me to do 22 something. I mean, he pulled his vehicle in so 23 close to mine, and was, now, yelling at me over a 24 loudspeaker. I figured something was up, so I just 25 got out of my car and stood there.

26 Q Okay. Do you remember seeing what James Stewart

  him my name, address, and date of birth. And I had

1 no problem doing that. I had nothing to hide.

2 Q When did you do that?

3 A The whole time.

4 Q The whole time?

5 A I told him my name's Jarvis Stewart. I never hid 6 behind that at all. There was never a refusal to 7 identify myself. And there's absolutely nothing in 8 Jay Keating's notes to corroborate any sort of 9 refusal to identify myself or refusal to produce any 10 documents.

11 Q I suggest to you that he was asking you for your

12 driver's license, your identification, and --

13 A Where are --

14 Q -- you were walking --

A -- Jay Keating is lying. I -- I mean, I -- there's
absolutely nothing in his notes to say that he asked
me for any information. The only thing in his notes

1 is that he told me to get back in my car, get back 2 in my car right now. And then he just says, "He 3 failed to comply with my commands." That's what I 4 got arrested for, was obstruction of a peace 5 officer, for failing -- for disobeying lawful 6 commands. So it was never failure to identify 7 myself. It was never refusal to identify myself. Just because I disobeyed lawful commands, I didn't 8 9 do what he said. And he -- he thought that was a 10 challenge to his authority for some reason. And so 11 he attacked me. 12 I suggest to you that you were walking away, and Q 13 then he said to you, "If you continue to walk away, 14 I'm going to arrest --" 15 Α No. 16 "-- you for obstruction"? 0 17 No, that never happened. Α 18 And then you did a 180 and --0 19 Α No. He --20 -- came back and confronted him? Q 21 Α No. He came right at me and attacked me. It's very 22 similar to the case of R. v. Pasqual Martins, where 23 Jay Keating was found to have grossly violated 24 someone's Charter rights under very -- the same 25 circumstances, just attacking someone at a traffic 26 stop.

1 Q And I would suggest to you that it was only when you 2 came back and confronted him and said, "I don't 3 believe in your laws, fuck you," and then did 4 another 180 --5 No. None --Α 6 0 -- away --7 -- of that --Α -- that then he --8 Q 9 А -- none of --10 -- told you, you're --0 11 Α -- that happened. 12 -- under arrest --Q 13 No, none of that --Α 14 -- for obstruction? 0 15 -- happened, no. Brown, which elucidates on 19 the Section 209.1 ruling of The Traffic Safety Act. 20 I was well informed. I knew what I was doing. 21 0 But you didn't put that in that September statement, 22 as far as --23 Α Well, I didn't think it was necessary. 24 There's a few things in that statement that you've 0 25 said different here in court, wouldn't you agree? 26 Α I guess, yeah. I mean, some inconsistencies maybe,

No reasonable person would do that. 6 0 Well, it just seems strange to me that an individual 7 with this document in his glove box, saying that I 8 don't need a driver's license, and I don't need to 9 register my car, would be so unfortunate to have 10 such a bad occurrence with a Saskatoon Police 11 Service officer, as far as him tackling you? 12 Α (No audible response.)

13 Q I'm suggesting to you that you were never going to 14 comply with any lawful demands of this police 15 officer because it's in your nature?

16 A I complied with his -- with his requests to be
17 handcuffed at the threat of being pepper sprayed.

18 Q He says you didn't. He says --

5 As we heard yesterday, Jarvis 6 Stewart did testify. He testified and played the 7 video from the phone room. He was cross-examined, however, about his earlier statement where he stated 8 in that statement, "I was then denied a phone call 9 10 for a period of almost an hour before I gave up. I 11 was stripped of my shoes and my personal belongings. 12 Another unidentified man then sexually assaulted me, 13 grabbing my testicles violently."

Your Honour, if the Court does find that the Section 10(b) right with respect to Jarvis Stewart was breached with respect to his submissions about the call to a lawyer, as you pointed out yesterday, the issue then would be, what is the -- the remedy?

20 Unlike the classic case -- or 21 I shouldn't say "classic", but unlike the common 22 case where there is an application to exclude breath 23 sample results after a call to a lawyer issue or an 24 application to exclude an admission or a confession 25 after a call to a lawyer issue, in this case, the 26 offence -- the offence of obstruction had already

1 occurred prior to the call to a lawyer. So I found 2 the case of The Crown and Galickus (ph) from the 3 Ontario Court of Appeal. And it's a similar situation, as far as the Court was left with the 4 5 issue of what the remedy was. The court did find 6 -- the trial judge did find that the accused, who 7 had flown in from Jamaica to Toronto, had been 8 -- had his Section 10(b) right breached, but the 9 evidence was subsequently not excluded under Section 10 24(2). 11 And the Court of Appeal read 12 as follows: 13 14 "Breach of a *Charter* guarantee 15 should not be considered in 16 imposing sentence, unless it 17 mitigated the seriousness of the 18 offence, or constituted a form of 19 punishment or undue hardship. Ιt 20 was an error to conclude that 21 compensation for improper police 22 action should be a factor in 23 determining an appropriate 24 sentence." 25 The court goes on to say, 26 Your Honour: 27 28 "The only appropriate remedy for 29 denial of the right to retain and 30 instruct counsel was to consider 31 the exclusion of evidence. The 32 breach of Section 10(b) did not in 33 any way mitigate the seriousness 34 of the offence." 35 THE COURT: Have -- have you -- have you

1 read the Supreme Court -- I think-- I can never 2 pronounce it -- Asagarelic (ph). 3 MR. JAMES STEWART: Asagarelic. MR. JARVIS STEWART: 4 Asagarelic. 5 THE COURT: Asagarelic. I have, Your Honour. 6 MR. PASHOVITZ: Yes. Doesn't that -- doesn't 7 THE COURT: 8 it make specific mention of this, and talks about 9 the remedies under 24 - possible remedies under 10 24(1), and comes to a similar conclusion, that the only -- that the -- the traditional way of dealing 11 12 with it is mitigation of sentence, but the 13 traditional rules of sentencing would allow for 14 mitigation of sentence where the police do something 15 they're not supposed to anyway. PASHOVITZ: Well, I think the 24(1) 8 remedy would be -- my read of that Asagarelic case 9 is that there can be reduction in sentence, if there is found to be that breach. 10 11 THE COURT: Well, there can be, but it 12 follows the rules of sentencing. 13 MR. PASHOVITZ: Correct. 14 THE COURT: Not because of 24(1). Now 15 -- and they raise that because Ontario took this 16 position. MR. I appreciate you --11 THE COURT: Yes. 12 MR. PASHOVITZ: -- raising that --13 THE COURT: Yes. 14 MR. PASHOVITZ: -- for the record then, Your 15 Honour. 16 Turning to the next issue 17 that was raised by the Court, and this was put in 18 the Notice filed by defence, the issue of arbitrary 19 detention at the scene. Yesterday, I filed the four 20 cases that I filed: Mann; Lundquist; and Papilion; 21 and then the Tisdale case that you're well familiar 22 with. 23 In my Brief, I did summarize 24 what the Crown in the Mann case stated from the 25 Supreme Court of Canada, where they recognized the 26 limited power of officers to detain for

1 investigative purposes and stress that police powers 2 and duties are not necessarily correlative. To be a lawful detention for investigative purposes, the 3 detention must be for a recent or ongoing offence. 4 5 The court summarized investigative detention as 6 follows: 7 8 "To summarize as discussed above, 9 police officers may detain an 10 individual for investigative 11 purposes if there are reasonable grounds to suspect in all of the 12 13 circumstances that the individual 14 is connected to a particular crime 15 and that such a detention is 16 necessary." 17 That's the Supreme Court of 18 Canada. Now, our Saskatchewan Court of Appeal made 19 a ruling in the Quist (ph) case, which is similar to 20 the facts here. With respect to the review of the 21 Quist case, the court there was reviewing an 22 obstruction count. There was an investigation 23 pursuant to an impaired driving investigation. And 24 there were some italicized portions added in by the 25 Court. And those are the only portions that I'll 26 Section 235 as it was at that time: read. 27 28 "The officer may by demand made to 29 that person forthwith or as soon 30 as practicable, require him to 31 provide and to accompany the peace 32 officer for the purpose of 33 enabling such samples to be

taken."

34

1 The Court of Appeal then, in 2 the next paragraph, indicated: 3 4 Here, the Appellant cannot refuse 5 without reasonable excuse to 6 accompany the constable for the 7 purpose of enabling samples to be 8 taken because the statute 9 specifically requires him to do 10 so. Counsel for the appellant 11 argued there was no duty on the 12 part of the Appellant to remain in 13 the police van until Constable 14 Noel had made his --" 15 THE COURT: Is that --16 MR. PASHOVITZ: "-- demand." 17 THE COURT: -- is that the -- the case 18 where they had him in the van, and he just took off 19 before the policeman had a chance to -- to give him 20 the actual demand? 21 MR. PASHOVITZ: I believe so --22 THE COURT: It's --23 MR. PASHOVITZ: -- Your Honour. 24 THE COURT: Yes, yes. Okay. I remember 25 now. 26 MR. PASHOVITZ: There's -- and there had to 27 be a differentiation, if it's actually refuse the 28 demand, then you should and ought to be charged with 29 refusing to provide a breath sample. But when you 30 bolt away before that's even allowed to happen, then 31 this led to an obstruction count and a conviction

1 that was upheld --2 THE COURT: Yes --3 MR. PASHOVITZ: -- by the --THE COURT: 4 -- it was. 5 MR. PASHOVITZ: -- Court of Appeal. 6 THE COURT: Yes. 7 MR. PASHOVITZ: The statute -- and -- and 8 this is what I found of interest with respect to 9 what the Saskatchewan Court of Appeal had to say: 10 11 "The statue imposes a duty on the 12 driver to remain in the presence 13 of the constable until the 14 constable has completed the duties imposed upon him by the section." 15 16 So then in my Brief, I've copied Section 209.1 of The Traffic Safety Act. 17 The 18 Crown respectfully submits that the precedent of 19 Quist is applicable to the case before this Court. 20 I won't read Section 209.1 in its entirety, but with 21 respect to (3) and (4): 22 23 "No person in charge of operating 24 a motor vehicle shall, when seeing 25 a request to stop by a peace 26 officer, fail to immediately bring 27 the vehicle to a safe stop." 28 And then (4): 29 30 "No person in charge of or 31 operating a motor vehicle shall 32 fail when requested by a peace officer to comply with the request 33 34 of a peace officer pursuant to

512 Submissions by Mr. Pashovitz 1 subsection (2)." 2 THE COURT: What section is that? Section 209.1 of The Traffic 3 MR. PASHOVITZ: 4 Safety Act, Your Honour. 5 My reading of that section puts it on all fours with the ratio from the Quist 6 7 case, Your Honour, when there's --8 THE COURT: Statutory --9 MR. PASHOVITZ: -- that --10 THE COURT: -- compulsion. 11 MR. PASHOVITZ: Exactly. Turning to the next 12 case that I've filed, the Papilion case. This is 13 from the Saskatchewan Court of Queen's Bench. This was a traffic case. And the Court reviewed 14 15 -- reviewed the cases there. And, again, I -- just going 16 17 back to that *Quist* case, there's some lines there 18 that just stand out, as far as the comparison to 19 this case. And, again, the Saskatchewan Court of 20 Appeal put it much better than I ever could: 21 22 "If that were so, then any person 23 stopped by a police officer 24 attempting to enforce Section 235 25 could completely frustrate 26 enforcement of the section by 27 simply driving off and running 28 away." 29 And, again, that's squarely 30 what we have before the Court today.

1 The Papilion case from the 2 Saskatchewan Court of Oueen's Bench reviewed the 3 cases of Houbin, Schaefer, as well as Section 209.1 of The Traffic Safety Act. And the review of those 4 5 cases led to the Saskatchewan Court of Appeal, stating that when they reviewed Schaefer and Houbin, 6 7 the Court of Appeal said neither of those cases 8 applied to the present facts of the case of 9 Papilion. In the present case, Constable Nordick 10 had a clear right to ask the respondent to produce 11 his driver's license. By the time the accused 12 produced his driver's license, Constable Nordick had 13 a clear right to impose investigative detention to 14 follow-up on the smell of alcohol he noted to be 15 coming from inside the vehicle. So that's just an 16 application of the Mann case and earlier cases. That's the recent pronouncement from our 17 18 Saskatchewan Court of Queen's Bench. 19 Turning, now, to my 20 submissions with respect to the merits of the actual 21 obstruction charges, Your Honour. I've included the 22 -- I think some people call it the bicycle case, the 23 case from the Supreme Court of Canada, back to 1977, 24 as far as a conviction there for obstruction, as far 25 as not providing a name. Hudson was another case 26 which I thought might assist the Court. It's a

1 Saskatchewan case. The review of the case there 2 indicated that the accused refused several times to 3 give his name and address to the constable, who observed him to be violating a city bylaw. 4 The 5 accused's appeal from conviction was dismissed. The offence was committed when the accused refused at 6 7 the request of the constable to give his name and 8 Since no arrest was made, his Charter address. 9 rights were not infringed.

10 The Lightmark (ph) case from 11 Alberta, the circumstances were as follows: A 12 confrontation between police and persons at a noisy 13 party resulted in beer bottles being thrown and 14 damage to a police car. The accused were told to leave two or three times and did not. The accused 15 16 were convicted, since the decision to remain in the 17 face of obvious police power and authority to act 18 constituted obstruction.

19MR. JAMES STEWART:Slow it down, big guy.20MR. PASHOVITZ:There's the Jarvi (ph) case,21leaning against a police car and refusing to leave22the area when demanded to do so by a police officer23constituted acts of obstruction.

In Saunders, the accused, was
 charged with obstruction when he got into a fight
 with a police officer who was in the process of

1arresting a driver. The officer had not informed2the driver of the reason for his arrest. Dismissal3of the charge against the driver was not a defence4to the charge of obstruction. Any right of5resistance to the driver had belonged to him alone,6and did not extend to the accused. And as a result,7the accused was convicted.

8 Watkins from Ontario,

9 affirmed by their Court of Appeal, indicated that 10 obstruction is not limited to physical contact of a 11 police officer by the accused, which, again, is 12 similar to the case against James Stewart here. 13 When the police, having witnessed breaches of the 14 peace, gave the crowd a proper order to disburse 15 within five minutes, the continued presence of the 16 accused was in defiance of the police order, and amounted to an obstruction of the police in the 17 18 execution of their duty.

19 And then the last case I 20 included was the case of Hills (ph) out of British 21 Columbia. The accused was convicted of obstructing a peace officer. The accused interfered with the 22 23 arrest of another person by a police officer in "the 24 execution of his duty." And there -- I've included 25 because the other cases were basically just 26 headnotes, but there I've included the actual full

1 decision from the B.C. Court of Appeal because, 2 again, it's similar to the cases before the Bar here 3 today, and I wanted to include all of the details 4 there. 5 MR. JAMES STEWART: Sweet Gainsborough, right on. MR. PASHOVITZ: Those are what I've included 6 7 in the Brief, Your Honour. 8 THE COURT: What --9 MR. PASHOVITZ: Turning --10 THE COURT: -- what --MR. PASHOVITZ: 11 -- now, to my review of the 12 evidence --13 THE COURT: Yes, please. MR. PASHOVITZ: 14 -- I just wanted to start, first of all, with The Police Act, 1990. That's 15 16 something that we have to all bear in mind, as well, Section 36 of that Act reads as follows: 17 too. 18 19 "Before entering on the duties of 20 a member, a member of a police 21 service shall take and subscribe 22 to an oath or affirmation." 23 And (2) indicates: 24 25 "A member has the power and the 26 responsibility to: 27 (a) perform all duties that are 28 assigned to constables or peace 29 officers in relation to: 30 (i) the preservation of peace; 31 (ii) the prevention of crime and 32 offences against the laws in force 33 in the municipality; and

1 (iii) the apprehension of 2 criminals, offenders and others 3 who may lawfully be taken into 4 custody." 5 So -- so peace officers do have that duty, Your Honour. So I had wanted to 6 7 just start my submissions with that, and then turn 8 to what Constable Keating on -- did on the evening 9 in question. So it's my recollection that what 10 Constable Keating was doing was, he was acting in 11 his role as a peace officer. He was a member of the 12 traffic unit here in the Saskatoon Police Service. He was driving on 8<sup>th</sup> Street here in Saskatoon. He 13 14 was following a vehicle, and he noticed that the 15 sticker on the plate looked different to him. I'm not sure if I can obtain 16 17 -- I should have asked for this before -- the 18 license plate exhibit in these proceedings. I'm not 19 sure if it could be pulled out, and then I'll just 20 continue on --21 MR. JAMES STEWART: Haven't we seen --22 MR. PASHOVITZ: -- while that's --23 MR. JAMES STEWART: Have we not --24 MR. PASHOVITZ: -- being done. 25 MR. JAMES STEWART: -- seen enough evidence? 26 Like --27 MR. PASHOVITZ: So I found it interesting 28 that Constable Keating was able to note that the

JAMES STEWART: 6 I am sorry, Your Honour. THE COURT: 7 -- and you have to be 8 polite --9 MR. JARVIS STEWART: Okay. 10 THE COURT: -- here. Okay? MR. JAMES STEWART: 11 (No audible response.) MR. JARVIS STEWART: 12 (No audible response.) 13 THE COURT: That's the way court works. 14 It's not a debating society. Okay, go ahead. 15 MR. We see that on the video. 21 When he runs the system, lo 22 and behold, what does 131 HFG come back to? 23 Registered to a Honda Civic. So then he -- I 24 believe he says, checks it again, just to make 25 sure. 26 Upon seeing that that plate

1 is actually registered to a Honda Civic, and he's 2 following a Toyota Celica, he decides, as is his 3 obligation, his right, his duty to do, his ability to do, to conduct a traffic stop of the vehicle that 4 5 he's following. That's a lawful traffic stop. He, 6 as he says, chirps his siren, puts his lights on, 7 pulls in-behind the vehicle in the parking lot in 8 question.

I -- I'll just use this 9 10 phrase now. It -- it should have just been a 11 traffic stop. That's all it should have been. But 12 as I believe Constable McAvoy testified when he was 13 arriving to the scene, I think his phrase was, "This 14 was not an ordinary traffic stop." Because we all 15 have heard what happened once that vehicle stopped 16 in that parking lot.

I -- we've all seen traffic 17 18 stops. I saw one the other night. I was driving 19 There was a police car stopped behind another home. 20 vehicle. The police officer was behind the wheel of 21 his vehicle. He was checking something in the The driver of the suspect vehicle was 22 system. 23 sitting behind the wheel of his vehicle. Everything 24 was getting done above board. 25 Here, what we see on the

26 video -- and I'll repeat this again -- is as soon as

these vehicles stop, the suspect vehicle and the police vehicle, we see James Stewart get out of the passenger side, walk straight away from that vehicle. And I'll refer to that in a moment, as far as that's consistent with what Constable Keating had to say.

7 Jarvis Stewart -- and I'll 8 repeat this in a moment, but I just wanted to make 9 sure that I start off with this -- would have this 10 Court believe that he was stopped by an unidentified 11 man, got out by the door of his vehicle, and just 12 stood there, basically with his hands-up, and he was 13 then tackled. I would respectfully submit that the 14 video shows otherwise. I would respectfully submit 15 that the video shows that James Stewart gets out of 16 the passenger side, walks straight away. I would respectfully submit that, just as Constable Keating 17 18 said that Jarvis Stewart got out of the door of the driver's side and did the same thing, walked 19 20 straight away. And that's when words started to be 21 exchanged. That's when lawful commands were made 22 and not abided by, by Jarvis Stewart, leading to the 23 confrontation that occurred, as far as his shoulders 24 being bumped, swear words being uttered, phrases 25 such as, "We don't have to comply with your laws," 26 or, "Are you a peace officer or a police officer?",

2 So that's -- that's what 3 Constable Keating was faced with on that evening. What looked like a traffic stop turned into 4 5 something as Constable McAvoy indicated that was not an ordinary traffic stop at all. So I wanted to 6 7 start my submissions with -- with that in mind 8 because, again, we've -- we've had testimony here 9 from Jarvis Stewart. We've had questioning by these 10 two individuals. And it's easy for me to look at 11 things from their side of things, but I just wanted 12 to try my best to try and see things through the 13 eyes of Constable Keating on this night, as far as 14 he spots this continuous sticker which looks 15 strange. He checks the plate. It doesn't match. 16 "I'm going to do a traffic stop," pull behind the 17 vehicle, and hopefully things will just go as every 18 other traffic stop should. 19 So with respect to my review

of Constable Keating's evidence, he turned on the lights of his vehicle. He followed the vehicle, he brought it to a stop. I would respectfully submit that the driver of that vehicle, who turned out to be Jarvis Stewart, may not at that point in time, right at the stop time of the vehicle, may not know why he had been stopped, but clearly he knew that

1 the police officer is engaged in the lawful 2 execution of his duty. If you have lights coming behind you, a siren chirping, as Constable Keating 3 4 said, again, at that moment in time, he may not know 5 exactly why he's being stopped, but he certainly knows that there's a peace officer behind him in the 6 7 -- engaged in the lawful execution of his duty. 8 I would respectfully submit 9 that there was a lawful basis for the stop. There was a lawful basis for then the demand for 10 11 identification and driver's license. Those are the 12 lawful commands that the Crown is alleging, and that 13 we submit have proven that James (sic) -- I'm sorry 14 -- Jarvis Stewart did not comply with. 15 I have referred to the case 16 of Mann and Papilion in my -- in my Brief. Again, I've repeated it twice. I don't want to repeat it 17 18 again, as far as essentially what those cases say, 19 as far as, if individuals do not comply with lawful 20 commands, that that would essentially thwart the 21 investigative process completely. 22 The police are able to detain 23 a suspect for investigative purposes according to 24 Again, that was used recently in the Papilion Mann. 25 case. 26 So with that as my preface, I

1 just wanted to get to my review of the case as a 2 whole. Your Honour, respectfully, it's my view of 3 this evidence that both James Stewart and Jarvis Stewart feel that they do not need to have driver's 4 5 licenses; feel that they do not need to register their vehicles. That's abundantly clear from the 6 testimony of Jarvis Stewart. And it's also clear 7 from the Right to Travel documents that were 8 9 obtained in that car.

10 So when I say that this 11 should have been an ordinary traffic stop, and then 12 it turned out to be anything but, I would 13 respectfully submit that that's because these were 14 two individuals who felt that they did not have to 15 comply with the traffic laws here in our province. 16 And that's what Constable Keating was faced with.

17 I just wanted to point to the 18 evidence that supports that theory. Again, we have 19 here a Toyota Celica vehicle that was being driven here on a highway in Saskatchewan, 8<sup>th</sup> Street 20 21 specifically, with a license plate on it that 22 matched a Honda. Inside that Toyota Celica 23 eventually were found Traffic Safety Act tickets 24 already marked, "Will not contract." There were 25 also, again, as I've indicated, already Right to 26 Travel documents inside that glove box. So,

1 respectfully, I would submit that what Constable 2 Keating was dealing with here were two individuals that felt -- just as he testified in the case, were 3 4 individuals who felt that the laws with respect to 5 driving in this province did not apply to them. 6 With respect to the testimony 7 that was heard yesterday, I just wanted to review 8 I've been reviewing what Constable Keating that. 9 had to say, and I'll get more to him closer to the 10 conclusion of my submissions, but with respect to 11 Jarvis Stewart's testimony, again, this would go to 12 -- to credibility. He says his car was registered. 13 The court has seen the documents that show that that car was not registered. As far as why this plate 14 15 was on his car, he stated, "It was a -- just a plate 16 that I put on my car." I think he justified that by saying that, that way, there's a plate on the car, 17 18 in case someone needs to identify it or tell me 19 where my car is, or something of that nature. I 20 believe his testimony was that he has a lot of 21 license plates, and this continuous sticker that 22 caught Constable Keating's eye was already on the 23 plate, that he didn't make it up at home, I think

25 The plate, of course, has
26 already been shown to match, not that Toyota Celica

was what I asked him.

at all, but a separate Honda Civic. And that,
 again, his car was not registered as he says it
 was.

4 Again, he referred to the 5 safety checks that were done on the Toyota Celica, as far as some justification that he operates cars 6 7 properly. Well, again, that safety inspection was 8 done a year earlier than the incident in question. 9 We have testimony that this vehicle was not 10 compliant with vehicle equipment regulations, 11 taillights taped or painted over, things of that 12 nature, as Constable Schaefer described.

13 With respect to his

14 testimony, he, I believe, testified that an unmarked 15 police car got behind him. He did not see flashing 16 lights. But, again, I did cross-examine him on the earlier statement that he voluntarily provided that 17 18 indicated that when he wrote that statement in 19 September, 2012, "That there were flashing lights 20 behind me." So that, I think is something else that 21 can be looked to, as far as judging his credibility, 22 with respect to one statement at one time, and, now, 23 a different statement before the Court yesterday. 24 Again, Jarvis Stewart 25 testified that he said that Constable Keating

threatened to pepper spray him. Again, I reviewed

26

his entire earlier statement with him in cross examination. Nowhere in that earlier statement does
 he say anything about being threatened about being
 pepper sprayed.

5 With respect to his testimony 6 yesterday, I believe he testified that he didn't 7 think anything was wrong because he knew he was in 8 the parking lot. Again, I cross-examined him about 9 his earlier statement. Nowhere in that earlier 10 statement did he say anything about thinking that he 11 was okay because he was in a parking lot. I would 12 respectfully submit that that's something that's 13 contradictory, as well, that the Court can look to, 14 as far as judging his credibility, in order to 15 decide exactly what happened with respect to the 16 traffic stop on the night in question.

And if I may, Your Honour, I 17 18 didn't put this case in my Brief. I know it's been 19 mentioned, the Saskatchewan Court of Appeal case of 20 The Crown and Lux. I would respectfully submit that 21 on these facts, it's distinguished because in that 22 case of The Crown and Lux, that was a pure, as it's 23 called, random traffic stop in the parking lot of 24 the Bella Vista Hotel in Humboldt, Saskatchewan. 25 That was it. That's what the Court of Appeal 26 pointed out.

1 Here, although the dealings 2 were on a parking lot, and whether it's a private 3 parking lot -- I don't think so. I've been in that parking lot. If they let me park there, I don't 4 5 think it's a private parking lot, but --6 It's not -- it's not a public THE COURT: 7 highway, but -- but the evidence was that the police 8 officer saw the offence on a public highway. 9 MR. PASHOVITZ: Exactly, Your Honour. That's 10 why I didn't put that in my Brief. 11 With respect to Jarvis 12 Stewart, he said he was never asked -- he testified 13 he was never asked because -- for his 14 identification, he was never asked for his driver's 15 license, that he just hears something -- some 16 commands that he doesn't understand over the 17 loudspeaker, and then he's tackled, right off the 18 bat. 19 Your Honour, as far as the 20 Court deciding what happened with respect to this 21 incident, I would respectfully submit that 22 everything is entirely consistent with what 23 Constable Keating had to say, as far as the reason 24 for the stop; haling, "Get back in your car"; asking 25 for a driver's license and identification; and not 26 being provided that; then having to arrest Jarvis

Stewart; then having to call for backup to deal with
 James Stewart, who is upset because Jarvis Stewart
 had been arrested.

4 And, again, this is all under 5 the umbrella of the fact that, again, these are two individuals, just as Jarvis Stewart said yesterday, 6 7 who believe that they do not need driver's licenses; believe they do not need to register their vehicle. 8 9 So I can easily see how it happened exactly as 10 Contable Keating testified, that he made the demand 11 for driver's license and registration, and was met 12 with the responses, "We don't have to follow your 13 laws," "F you," "Are you a peace officer or a police 14 officer?"

Again, I refer -- I've 15 16 referred to this earlier in my earlier submissions, but just reviewing the evidence that we heard 17 18 yesterday, I believe Jarvis Stewart testified that 19 he states he got out of the vehicle just like his 20 brother did, just got out and stand -- stood there. 21 And, again, we have the video that speaks for 22 James Stewart is certainly not just itself. 23 standing there. He gets out of the vehicle and 24 -- and walks, as we all know, towards the Shopper's 25 Drug Mart.

26

The video shows exactly what

happened. As you pointed out yourself yesterday,
 Your Honour, the video also shows clearly that
 Constable Keating's badge was visible.

4 Again, there was many 5 references to unidentified males, unknown places, being driven around in the back of the police car 6 with the radio up loud, being bounced around. All 7 8 of those seem to be squarely, with respect to, I 9 guess, the -- the attitude that this individual has 10 with respect to peace officers and people in 11 authority.

12 With respect to the testimony 13 of Jarvis Stewart yesterday, and when he was 14 questioned about what he was doing when Constable 15 Keating -- not what time it was or anything like 16 that, but just what he was doing when Constable Keating was calling for backup, he states he -- I 17 18 believe that he was already handcuffed. He was just 19 standing there. When guestioned about what James 20 Stewart was doing when Constable Keating was calling 21 for backup, he states, "He was just standing there 22 and questioning the arrest," words of that nature. 23 Again, Your Honour, when 24 you're deciding credibility issues and what exactly 25 happened on the parking lot, I'd respectfully submit 26 that that is inconsistent with what Constable

Keating ended up doing. Constable Keating called
 not once, but twice for backup. I question whether
 he would be doing that, if, again, this was just a
 routine traffic stop.

5 This, again, was not an 6 ordinary traffic stop. Swear words were being 7 uttered. An individual, James Stewart, Constable 8 Keating said, was swearing at him, was circling 9 around, was pacing around. That is entirely 10 consistent with a police officer, faced with that. 11 And, again, looking at it from Constable Keating's 12 eyes, faced with that, calling for backup, not once, 13 but twice. And Constable Hounsell testified that 14 he's only heard two such urgent requests for backup, 15 probably twice in his career. Hence, the response by the other officers. 16

I've referred to the badge 17 18 being visible with respect to Constable Keating; 19 lights being used by Constable Keating; the siren 20 being chirped by Constable Keating; sirens being 21 used by Constable McAvoy and Schaefer, when they arrived as the first backup vehicle. I'd all 22 23 -- respectfully submit that all of this goes to show 24 that Constable Keating was easily identifiable as a 25 peace officer, was in the lawful execution of his 26 duty, and that's a hurdle that's been crossed by the

-- by the Crown.

2 I -- I want to just touch on 3 this, with respect to, again, this being a trial, 4 the Court being allowed to judge credibility, being 5 allowed to makes its decision by what it's seen and heard here in the courtroom. Your Honour, in 6 7 cross-examination yesterday, I was met with my 8 question being met with being asked a question, it 9 was met with an individual asking why this is 10 relevant; it was met with an individual saying it's 11 ironic that I was asking him certain questions; was 12 met with an individual who had to be told by the 13 Court to answer a question. And I would 14 respectfully submit that that's also evidence that 15 can be used by this Court in order to decide what 16 happened, what was said, and how -- who was acting like what during this traffic stop. I would 17 18 respectfully submit that when you have that type of 19 response, as far as a question being answered with a 20 question, being asked why things are relevant, being 21 told things are ironic, and some questions not being 22 answered at all, to find an individual in a 23 respectful, controlled environment like a courtroom, 24 I can easily see that that same individual could be 25 confrontational to Constable Keating during a 26 traffic stop of this nature. I just wanted to put

1 that on the record, as well, Your Honour, as far as 2 your determination with respect to what happened in 3 the parking lot on the night in question.

4 With respect to my 5 submissions, Your Honour, this is not the type of case that deals with the sometimes intricate issue 6 of ability to arrest for a Traffic Safety Act 7 8 offence or anything like that. It's on all-fours 9 with the cases that I've referred to in my Brief, as 10 far as [police officer identifiable, engaged in the 11 lawful execution of his duty, a legal stop, a lawful 12 demand, that demand is not complied with. That's 13 obstruction, that's what the cases that I've 14 included in my Brief have said. And many of those 15 case are -- are of a much lower nature that what we 16 have here today, specifically the Supreme Court of 17 Canada bicycle case. It's a bylaw case. The other 18 case out of Saskatchewan, I think, was another city 19 bylaw case, as far as an individual walking his dogs 20 without a license or things of that nature. This is 21 a scale above that, being that this is a Provincial 22 Traffic Safety Act offence, driving is a privilege, 23 not a right. I don't want to harp on those comments 24 anymore, Your Honour, because you're well familiar 25 with them.

26

So the Crown respectfully

submits that there is sufficient evidence for this
 Court to return a verdict of guilty with respect to
 Jarvis Stewart and obstruction by failing to comply
 with the lawful demands by Constable Keating.

5 As well, with respect to James Stewart, similar to the cases which I've filed 6 7 in my Brief, interfering with a lawful arrest. The 8 evidence that we heard from Constable Keating was 9 that James Stewart was circling around, was 10 swearing. The evidence we heard from Constable 11 Keating was that, not just once, but there were two 12 times that Constable Keating had to lift his leg. I 13 believe he stated it was his right leg, to keep 14 James Stewart away from himself. Hence, the charge 15 against James Stewart, which I would respectfully 16 submit has been proven beyond a reasonable doubt. Some would even submit that 17 18 it could have been a charge of assault, based on the 19 definition of Section 265, with the threatening 20 gesture. I'm not arguing for any assault 21 convictions, of course, Your Honour, but I am 22 respectfully submitting that what we have here is 23 evidence beyond a reasonable doubt of obstruction by both Jarvis Stewart and James Stewart. 24

25And, again, if I can conclude26with this: It comes as no surprise. These are

They were 8 obstructive, in my mind, during the entire incident, 9 Your Honour. 10 MR. He's faced with an individual, as he said in his 15 16 testimony, circling, sweating profusely, clenched. And then not only that, but the individual 17 18 approaches him once. He's told to get back. Does 19 he do it? Yes. But then he comes at him again, to 20 the point that he has to lift his leg a second 21 time. 22 The phrase that's used in the 23 Information is appropriate, Your Honour, as far as 24 interfering with a lawful arrest. It's not that he 25 assaulted Constable Keating. No. It's an 26 obstruction count by interfering with the lawful
