

**\*\*COMPLETING YOUR FORMS FOR TUITION ASSISTANCE\*\***  
**(please read completely – new info!)**

We realize that many parents, desiring a private, Christian Education for their child - after budgeting, prioritizing, and sacrificing - still come up short when it comes time to pay tuition. **Each family must be diligent in filling out the forms, providing the tax information necessary to apply for TUITION ASSISTANCE and turning them in BEFORE the due date!**

In the past, some families have missed out on tuition assistance because forms were filled out incorrectly/incompletely, missing correct supporting documentation, mailed to the wrong address or mailed after the deadline. Katie and Carol have also spent countless hours making phone calls, sending emails and texts when applications are incorrect, incomplete and/or late.

**\*WE WILL HELP YOU FILL OUT YOUR FORMS!!\***

This year two opportunities will be made available to families to assist them in filling out and turning in their assistance forms. **Stay tuned for the dates and times** when Katie Anderson, financial administrator, and Carol Novy will be available at the school, to answer questions and help you fill out your paperwork or apply online. We will then make sure your applications get to the appropriate places.

**\*\*Please don't be embarrassed in seeking tuition assistance, we are here to help! The majority of HIS Kids families qualify for some assistance – you are not alone!\*\***

**Do I Qualify??**

The qualification guidelines to receive EITC funds are as follows:

Annual gross income is less than \$108,444 plus \$19,088 per dependent child.

So qualifying levels would be:

With one dependent child = \$127,532

With two dependent children = \$146,620

With three dependent children = \$165,708

With four dependent children = \$184,796

**What to Bring:**

1. This packet of tuition assistance applications – you can fill them out ahead of time or when you come. We can complete online applications at the school.
2. One copy of the family **2023 Federal Income Tax Return (form 1040) pages 1&2 (front & back)** only of the person that claims the children applying for tuition assistance.  
We can make additional copies for you.+

**+If no taxes were filed, you must provide proof of whatever income you have (SSI, Child Support, Food Stamps, etc).**

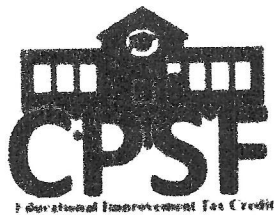
## TUITION ASSISTANCE APPLICATION CHECKLIST

- Central Pennsylvania Scholarship Fund (EITC Scholarship)**
  - Fill out completely all information requested on application.
  - Attach copy of pages 1-2 of 2023 IRS Form 1040\*.
  - Mail completed application and documentation to Katie Anderson.
  
- Community Foundation (EITC Scholarship) – must be completed online only. Online registration begins March 18, 2024.**
  - Website is [www.servingtheheart.org](http://www.servingtheheart.org) – click on the “Tuition Assistance” dropdown.
  - After the application process is completed, you will receive an email confirmation. Please make a copy of that confirmation and send it in to Katie Anderson.
  - If you need computer assistance, please let us know!!
  
- HIS Kids – Application for Tuition Assistance**
  - Complete the application process for both EITC scholarships.
  - Fill out completely all information requested on application.
  - Mail completed application to Katie Anderson.

**\* If no taxes were filed, you must provide proof of whatever income you have (SSI, Child Support, Food Stamps, etc).**
