### 3. What we've been doing and our plans

Beavers – Aquila

No one was present from the Beavers. However, the colony is well placed with good numbers. A new assistant leader is joining on the 28<sup>th</sup> March.

Cubs – Pegasus

Pegasus have recruited 2 new helpers who are fully engaged. A third individual is signed up to cover Karen Allaway whilst she's in hospital.

Cubs – Gemini

The pack has 24 on the books lead by 3 leaders, 2 young leaders, a regular parent helper & supported by a weekly parent rota.

During the last 12 months, 390 badges were awarded of which 10 were the Chief Scouts Silver award. Over the same period, 88 nights were spent under canvas. Young people attended on 747 occasions; young leaders attended 56 occasions & leaders on 90 occasions.



Scouts - Orion

The 37 strong unit is led by 5 leaders, 1 young leader & Rob.

There have been 10 camps over the last 12 months with 4 gold awards, 290 badges given & 3 YouShape awards completed.

A water activity weekend is planned as is an astronomy night at a local observatory

## Explorers – Polaris

The unit is led by Jez Green; Paul has both stepped down from being the leader in charge, but remains in the section, Jinx has stepped down from being a leader. The Unit has been able to recruit a new leader.

Young people numbers are good (a few leaving, but others joining) & attendance is good. The young people have enjoyed a few camping nights, but these aren't as frequent as pre-Covid. Although, a great trip to South Wales was had.

Of the regular Friday evening sessions, orienteering, teamwork challenges, debating and problem solving have been enjoyed. The plan is to undertake more camping nights & award more badges.

#### General

There is a long waiting list across the whole age range. With the new leaders, this should cut the list.

Scouts is the greatest issue. There are too many young people! As it stands, there is little capacity for the present cubs to move to Scouts and many will have to be placed on the waiting list unless more Scout leaders can be found.

There is a chance of obtaining use through purchase (costing £1) of a church building in Upper Saxondale that would be used as a group headquarters. There are some elements (covenant, change of use, structural survey) that would need to be overcome.

If successful, this would provide a building for all levels of the scouting community to use & potentially be available to rent out to other clubs as a form of income.



## 4. Money

It was reported that over the last 12 months, incomings & outgoings have balanced, with a small overall surplus of £39.22. The money that comes in covers the various rent costs that are paid. However, the account is healthy with a balance of £10,181.26.
