The DPA has \$1 Million in revenue which is a 65% increase.

Anna Morshedi with Moms Demand Action presented information about the organization. Moms is working to end gun violence. It is not an anti-gun organization, it is an anti-gun violence organization. They provide a gun safety module called the BE SMART program website <a href="https://besmartforkids.org/">https://besmartforkids.org/</a> explains the program.

S - Secure all firearms in your homes and vehicles

M - Model responsible behavior around firearms

A - Ask about the presence of unsecured firearms in other homes before you let your kids go visit other homes.

R - Recognize the role of firearms in suicides

T - Tell your peers to BE SMART.

Ms. Moreshedi shared that there are more firearms than humans. The number one cause of death in children and young adults from the age of 0-22 is gun violence.

-13 million households have at least one gun present.

-Children know where the guns are located

-41% of child suicide is by guns.

-Moms provides Pulaski County Schools with the SMART program which provides information to students to bring home to their parents and it talks about safe gun storage. Moms would put these materials in Saline County schools if given the opportunity.
