**ACCEPTANCE OF ENTRIES:** All entry blanks must be completed showing the name of the horse, rider, owner and the classes being entered and be signed by all parties listed. Parents or guardians must sign for minors.

An open check must be left with the secretary before a number will be given to an exhibitor.

**Class Fee:** \$20 per class.

**Ticketed Rounds:** \$20. Tickets must be used before the start of the division you are showing in. They may not be used before equitation classes #62, #75 to #84 and #134.

**Schooling Rounds:** \$20, Thursday afternoon and Friday morning.

**Late Fee:** \$20/horse for entries received after the closing date above.

**Stall Fee:** \$20 per day (sawdust included but not feed). Please call 801.518.3591 **on or before September 5, 2023**, to reserve a stall.

**Returned Check Fee:** \$20. Additional fees may apply if the returned check is not handled in a timely manner.

**HEADGEAR:** It is compulsory for all persons at hunter, jumper or hunter/jumper competitions when mounted anywhere on the competition grounds, to wear properly fastened protective headgear which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. It must be properly fitted with harness secured.

Rose Ranch and all of its show employees, officials, volunteers, show management and the UHJA and its officers and board of directors will in no case be responsible for any harm, loss, damage, accident or injury that may occur during the show due to any cause or circumstances. It will be a condition of entry that each exhibitor, owner, trainer, agent or any other interested parties shall hold harmless and indemnify Rose Ranch and all of its show employees, officials, volunteers, show management and the UHJA officers and board of directors for any damage or loss that may occur to any person, animal or property. Rose Ranch and all of its show employees, officials, volunteers, and show management will not be responsible for any article of any kind or nature brought onto the show grounds that may be lost, destroyed, damaged or stolen. Parents or guardians of minor exhibitors shall also agree to the above.

The Horse Show Management reserves the right to refuse, accept conditionally or to cancel any entries and to prohibit any person from showing a horse in the ring and to remove any exhibitor, groom and/or horses from the show without being liable for claims for damages. The show will honor all suspensions imposed by the UHJA and by the USEF. Any exhibitor not complying with any of the rules of this show and/or of the UHJA or the USEF may be prohibited from showing in further classes and may forfeit any awards won at this show. All participants (including but not limited to: riders, owners, grooms, coaches, trainers, and guardians of a junior exhibitor) will be held responsible for any damage incurred by them, their agents or their employees to stalls, buildings or other properties on the show grounds and will be billed accordingly. Control of horses on the show grounds will be in the hands of the show's management and employees. The show's management, employees and/or its judge reserves the right to excuse any person from the show ring or the schooling areas if they think that the person is creating an unsafe or disruptive situation. All attendees of horses will also be subject to their orders.
