## **Pearl Holdings Acquisition Corp Announces the Separate Trading of its Class A Ordinary Shares and Redeemable Warrants Commencing February 4, 2022**

NEW YORK, Feb. 03, 2022 (GLOBE NEWSWIRE) -- Pearl Holdings Acquisition Corp (Nasdaq: PRLHU) (the "Company") today announced that, commencing February 4, 2022, holders of the units sold in the Company's initial public offering of 20,000,000 units may elect to separately trade the Class A ordinary shares and redeemable warrants included in the units. Those units not separated will continue to trade on the Nasdaq Global Market ("Nasdaq") under the symbol "PRLHU," and the Class A ordinary shares and redeemable warrants that are separated will trade on Nasdaq under the symbols "PRLH" and "PRLHW," respectively. No fractional warrants will be issued upon separation of the units and only whole warrants will trade. Holders of units will need to have their brokers contact Continental Stock Transfer & Trust Company, the Company's transfer agent, in order to separate the units into Class A ordinary shares and redeemable warrants.

The Company is a blank check company formed for the purpose of effecting a merger, share exchange, asset acquisition, share purchase, reorganization or similar business combination with one or more businesses. The Company intends to focus its search for a target business in global consumer-focused industries, including companies that participate in the lifestyle, technology, healthcare and wellness sectors.

The units were initially offered by the Company in an underwritten offering. Morgan Stanley & Co. LLC ("Morgan Stanley") acted as sole book-running manager.
