Action Discussion

County of San Diego Groundwater Regulation Update

Leanne Crow from the County of San Diego presented to the Board on the proposed update to its groundwater regulations. The purpose for the update is to ensure consistency with SGMA, CEQA and a recent judgement in the Borrego Springs Basin. The new regulations will 1) require that all projects located within SGMA basins demonstrate that the projects are consistent with adopted groundwater sustainability plans and 2) Requires consultants to be CA Professional Geologist (PG) in lieu of two-step requirement to be a PG on the County CEQA Consultants list.

Required Annual Audit.

Administrator rate discussed the requirement to conduct an annual audit due to the status of the Authority now being a public agency. The Board directed the Administrator to obtain quotes for services from reputable audit entities and bring those quotes to the Board for a decision.

Proposed Resolution Recommending Yuima Municipal Water District to Approve the Plans and Specifications, and other Contracted Documents for and Authorizing the Advertisement of Invitation for Bids for the Pauma Valley Upper Subbasin Monitoring Well.
