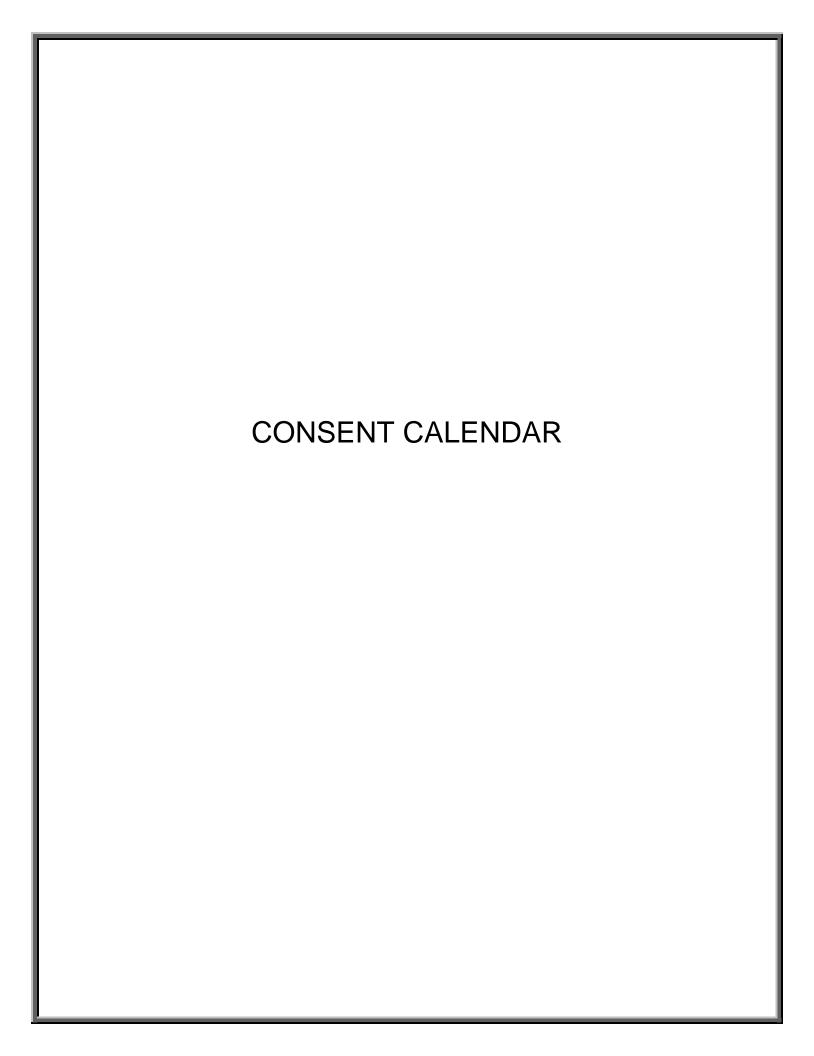



#### **RESOLUTION NO. 11-2023**

RESOLUTION OF THE BOARD OF DIRECTORS OF THE UPPER SAN LUIS REY GROUNDWATER MANAGEMENT AUTHORITY (USLRGMA) RE-ADOPTING AND RATIFYING THE UPPER SAN LUIS REY VALLEY SUBBASIN GROUNDWATER SUSTAINABILITY PLAN PREPARED BY THE PAUMA VALLEY GROUNDWATER SUSTAINABILITY AGENCY

A. WHEREAS, in August 2014, the California Legislature passed, and in September 2014 the Governor signed, legislation creating the Sustainable Groundwater Management Act ("SGMA") "to provide local groundwater sustainability agencies with the authority and technical and financial assistance necessary to sustainably manage groundwater" (Wat. Code, Section 10720, subd. (d)); and

- B. WHEREAS, groundwater sustainability under SGMA is to be achieved through groundwater sustainability plans ("GSPs"), which can be a single plan, or multiple coordinated plans, developed by one or more groundwater sustainability agencies {"GSA") that are created by memorandum of understanding, joint powers agreement, or other legally enforceable agreement (Wat. Code Section 10727); and
- C. WHEREAS, SGMA requires that one or more GSAs manage groundwater in all basins designated by the Department of Water Resources ("DWR") as a medium or high priority, including the medium priority Upper San Luis Rey Valley Groundwater Subbasin (designated basin number 9-007.01, alternatively referenced as the "Pauma Valley Sub-Basin"); and
- D. WHEREAS, on June 27, 2017, the Parties to the Memorandum of Understanding for Development of a Groundwater Sustainability Plan for the San Luis Rey Valley Groundwater Basin (hereinafter the 2017 MOU") executed the 2017 MOU and agreed to form a GSA, hereinafter the "Pauma Valley GSA," in accordance with the terms and process specified in the 2017 MOU, and the GSA so formed would work through an Executive Team to facilitate the preparation of a GSP for the Upper San Luis Rey Valley Groundwater Subbasin ("USLR GSP") per the timelines and in accordance with the requirements of SGMA; and
- E. WHEREAS, the 2017 MOU, as amended, included as members the Yuima Municipal Water District ("Yuima"), Pauma Valley Community Services District ("PVCSD"), Pauma Municipal Water District ("PMWD"), Upper San Luis Rey Resource Conservation District ("USLRRCD"), and the San Luis Rey Municipal Water District ("SLRMWD") (hereinafter "GSA Members") as members of the Pauma Valley GSA, each GSA Member a SGMA eligible "local agency" per Water Code Section 10721 (n) with water supply and/or water management responsibilities within the Subbasin, and each GSA Member having appointed one or more representatives to the Pauma Valley GSA Executive Team ("Executive Team") created by the 2017 MOU, so as to allow such representatives of each Member to make major decisions regarding the development and approval of the USLR GSP for the Upper San Luis Rey Valley Groundwater Subbasin (subbasin number 9-007.01) ("Subbasin"); and
- F. WHEREAS, Pauma Valley GSA, through Yuima serving as the lead agency, per the process specified in the amended 2017 MOU, prepared and adopted a GSP for the entire Subbasin

- upon the recommendation of the Pauma Valley GSA Executive Team and upon receipt of resolutions of support from the each of the GSA Members. (Wat. Code,§ 10725 et seq.); and
- G. WHEREAS, on January 21, 2022, the Pauma Valley GSA Executive Team created by the 2017 MOU, as amended, met in a publicly noticed meeting, with one or more representatives from each GSA Member present, and at said meeting the Pauma Valley GSA Executive Team voted unanimously to recommend to the Yuima Board of Directors that: (i) Yuima approve the GSP, (ii) and after taking all required actions to correct and finalize the GSP, submit the GSP to DWR; and
- H. WHEREAS, Pauma Valley GSA's jurisdictional area overlies the Subbasin identified in California Department of Water Resources ("DWR") Bulletin 118, as its boundaries may be modified from time to time as provided by law, and DWR has designated the Upper San Luis Rey Valley Groundwater Subbasin as medium priority, thereby requiring submission of a GSP to DWR by January 31, 2022; and
- I. WHEREAS, the purpose of Yuima serving as lead agency of Pauma Valley GSA, prior to the creation of the USLRGMA, was to coordinate procurement and development of a GSP, to implement with the GSA Members SGMA's requirements within the Subbasin, and to achieve the sustainability goals provided in SGMA, by developing, adopting, submitting, implementing, enforcing, and revising a GSP for the Subbasin, and thereafter, with the other GSA Members, to exercise all powers and authorities of a GSA under SGMA; and
- J. WHEREAS, Yuima coordinated with the GSA Members, through the Executive Team and extensive stakeholder outreach, to draft one GSP entitled the Upper San Luis Rey Valley GSP, referenced herein as USLR GSP; and
- K. WHEREAS, on October 15, 2021, notice of a public hearing to consider adoption of a GSP for the Subbasin was provided to the County of San Diego located within the Upper San Luis Rey Valley GSP Plan Area and the Pauma Valley GSA reviewed and considered any comments received from the County as a result of same; and
- L. WHEREAS, on November 23, 2021, public notice of the availability of the draft Upper San Luis Rey Valley GSP was posted by Yuima on the website for the Pauma Valley GSA along with the draft GSP and associated exhibits, and public comments were accepted for 45 days from the date of posting of the draft GSP; and
- M. WHEREAS, the Pauma Valley GSA, together with staff and its GSP consultant, after extensively seeking comments and participation in the development of the GSP from the Upper San Luis Rey Indian Water Authority (USLRIWA) and other members of the public in and around the Subbasin, reviewed and considered all comments received on its draft GSP, and made revisions to the Upper San Luis Rey Valley GSP as appropriate in response to comments received; and
- N. WHEREAS all Members of the Pauma Valley GSA, previously approved the GSP by duly approved board resolution, true copies of which are attached as exhibits hereto to this resolution; and
- O. WHEREAS, after submitting the GSP for the Subbasin to DWR on or about January 30, 2022, the Pauma Valley GSA began the process of implementing the submitted GSP within the Subbasin;

- P. WHEREAS, after Yuima (per the direction of the GSA Executive Team), submitted the Pauma Valley GSP receiving feedback from interested persons within the Subbasin, and desiring to create a permanent structure for the Bands of the USLRIWA to formally participate (if they desired) in the governance of the GSA, and the implementation of the GSP, within the Subbasin, the GSA Members determined that sustainable and equitable groundwater management decisions within the Subbasin could more effectively and efficiently be accomplished by changing the governance structure of the GSA to that of a joint powers authority ("JPA") consistent with Section X.1 of the 2017 MOU by transforming, restating and amending the 2017 MOU into a joint powers authority agreement ("JPA Agreement") between the same GSA Members, and transitioning the obligation to implement the GSP from Yuima (as GSA Lead Agency) to the newly created JPA; and
- Q. WHEREAS, on May 1, 2022, the same GSA Members that were parties to the 2017 MOU, and who previously passed resolutions authorizing submission of the USLR GSP to DWR, amended and restated the 2017 MOU a fourth time to create the Upper San Luis Rey Groundwater Management Authority, a JPA with the same members as the Pauma Valley GSA; the JPA so approved also included two voting seats for USLRIWA, and unlike the other GSA Members, the USLRIWA could take those voting seats without any obligation to fund the administration of the GSA or the implementation of the GSP; and
- R. WHEREAS, the JPA Agreement provided that the JPA created the Upper San Luis Rey Groundwater Management Authority ("USLRGMA") that would succeed to all of the obligations of the GSA, and USLRGMA would thereafter implement the USLR GSP within the Subbasin, with the same GSA Members making decisions through their appointed representatives to the JPA Board rather than through their appointed representatives to the Executive Team<sup>1</sup>; and
- S. WHEREAS, since the creation of the USLRGMA, the JPA has continued to administer the GSA in much the same manner as occurred prior to the creation of the JPA, with Yuima serving as administrator of the JPA, much as Yuima administered the Executive Team prior to the creation of the JPA, and with USLRGMA taking responsibility for implementing the GSP; and
- T. WHEREAS, because USLRGMA, the successor in interest to the Pauma Valley GSA and a public entity created by the amendment and restatement of the 2017 MOU, did not exist at the time the USLR GSP was timely submitted to DWR, USLRGMA has not taken specific action to approve the USLR GSP since its predecessor in interest, and all of the GSA Members thereof, already took action to approve the USLR GSP on or about January 2022; and
- U. WHEREAS, out of an abundance of caution, and to reaffirm USLRGMA's authority and intent to implement the GSP within the Subbasin, the USLRGMA hereby re-adopts the USLR GSP and ratifies the prior adoption of the USLR GSP by the GSA Members through the Pauma Valley GSA Executive Team.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the USLRGMA:

1. The above Recitals are true and correct and the Board of Directors of the USLRGMA so finds, orders, and determines.

See JPA, Recitals K and N, and sections 1.1, 5.7

- 2. The Board of Directors of the USLRGMA hereby approves and re-adopts the USLR GSP for the Subbasin in the form presented, which is identical to the USLR GSP that was submitted to DWR by Yuima, after obtaining approval by all GSA Members, on or about January 30, 2022; and
- 3. The USLRGMA Board of Directors ratifies the prior actions of Yuima to approve and submit the USLR GSP to DWR after obtaining the unanimous vote of the Executive Team and resolutions of approval from all GSA Members in or prior to January 2022 and committing USLRGMA to implement the USLR GSP, and SGMA, within the Subbasin.
