The puppy, hereafter referred to as "puppy" or dog is guaranteed to be AKC purebred and is sold as a pet with limited registration.

## Deposit and Hold

Deposit: \$400 Remaining Balance: \$1000

You have understood and agreed to our deposit and hold policy described as follows:

Owner is making a non-refundable (unless the condition listed below occurs) deposit in the amount of \$400 to reserve a puppy. Once the deposit is received along with the contract of ownership, Brame Puppies is bound by this contract to reserve a puppy solely for owner except upon availability due to death, health concerns of the puppy, or Brame Puppies has not received payment in full by the time the puppy is eight weeks of age. If for any reason the owner decided they no longer wish to take possession of the puppy, except for the reason listed below in the refund condition, the deposit will NOT be refunded to the owner. If after the puppy has reached eight weeks of age and the owner has not paid in full, Brame Puppies no longer bound by this contract to reserve the puppy or any other puppy for the owner.

## Refund Condition

The deposit is refundable if the specified puppy is not available due to health concerns or death prior to the owner's possession.

## Selection

Owners select their puppy in the order in which deposits are received. Brame Puppies allows people to begin choosing their puppy at five weeks of age beginning with the first deposit received. Brame Puppies will contact the owner with pictures and video in which the owner can make their selection.

## Payment Options

- Owner has the choice of making the deposit via PayPal (by using the friends and family option), Venmo, or personal check.
- The remaining balance, due at pickup, needs to be made via cash.
- Brame Puppies does not accept personal checks on the day the owner takes possession of the puppy.

Delivery charges may apply to transfer the puppy to the owner. Delivery costs are additional charges not included in the purchase price of the puppy. Arrangements must be made to utilize this service which is not always an option.

## Health Guarantee

Brame Puppies strives to provide a happy, healthy puppies to our customers while maintaining good relationships through the life of the dog. The puppy will be released to the owner with a clean bill of health or instruction on medication or care of a minor condition the owner has agreed to manage. Parasite or worms will be treated prior to the transfer of the puppy. However, parasite and worms are common in puppies and can be brought on by stress. Brame Puppies will notify the owner of any medical issues before taking ownership of the puppy.

The puppy will have a one year health guarantee. This includes anything the puppy was born with and NOT something the puppy contracted while in the owner's care (this includes but not limited to parvovirus, distemper, coccidia, giardia, or other forms of worms or parasites) or an accident that occurs after the owner takes possession of the puppy. The puppy will be given all age appropriate vaccines (rabies vaccine cannot be administered until after 12 weeks of age) and dewormer while in the care of Brame Puppies. The puppy will not be fully vaccinated until it has completed a series of vaccines near the age of sixteen weeks. Taking your puppy to public places or around other dogs until that time will be at the owner's risk.

## Owner Responsibilities

The owner agrees to have the puppy examined by a licensed veterinarian within five weeks from the date of transfer. If the veterinarian detects a genetic or congenital health problem within that period, Brame Puppies will supply a full refund of the purchase price or a replacement puppy of equal value if one is available upon the return of the puppy and registration papers. The owner must provide a written statement from the examining veterinarian detailing the congenital or genetic health condition. If the owner fails to provide a veterinarian examination within five weeks from the transfer of ownership or if the owner decides to retain ownership of the puppy after discovering a health problem, Brame Puppies will not be responsible for any future veterinarian costs.

The owner agrees to treat the puppy as a household pet and give proper love and care at all times. The owner further agrees to provide veterinary care when necessary for the life of the puppy. The owner agrees to take responsible care of the puppy with proper feeding and housing.
