2018 POA DUES

Are you current on your 2018 dues?? For the POA to best serve the community and properly maintain our amenities, POA dues are to be paid promptly. Non-payment of dues severely impacts our community, as we cannot maintain the common areas, clubhouses, parks, pool and tennis court without your dues. Therefore, non-payment of dues will restrict your use of community amenities as it is not right to allow usage if you are not paying for the upkeep. The invoices were mailed in November 2017. Block Captains are residents who volunteer their time and efforts to The community to serve as "point persons" between the residents, the POA Board, its committees and The property management team.



If for any reason a household has too much trash to fit inside the black garbage bin, residents can purchase city stickers to place on the outside of large plastic garbage bags. The stickers can be purchased from Fiesta or Seller's Brothers customer service windows or at hardware stores. The stickers MUST be visible street side, or the bags will not be picked up.

Residents with physical limitations can contact 311 and complete a Solid Waste Pickup Request Form (for either regular trash or recycles, or both) to qualify for special pick up services. If qualified, city services will then pick up from the residents' specified locations and return them to the same location when emptied. The location MUST be out of sight from the street, but accessible to the city services (ie, behind unlocked fence gate).

PROTECTING YOUR CREDIT JUST GOT EASIER!

President Trump recently signed a bill into law which includes a provision that requires credit bureaus to let consumers freeze their credit for free. Up to now, each of the three credit bureaus would charge you if you wanted to put a freeze in place (usually around \$10 at each bureau). Then you often had to pay again to unfreeze or thaw your credit if you wanted to do something that required a credit check, like applying for a new loan. However, after last year's massive Equifax data breach, consumer advocates called on Congress to provide free access to credit freezes.

What does freezing my credit do? When you freeze your credit, the credit reporting bureaus cannot give any information to someone who makes an inquiry about you. Typically, businesses inquire about your credit when you (or someone posing as you) are trying to, for instance, open a new credit card, buy a car or rent an apartment. The credit check helps the business determine if they want to lend or rent to you, and it can help set your rates and lending terms for loans and credit cards. When your credit is frozen and the business cannot get any information about you, it stops the process — which means a fraudster will be unable to open an account while using your identity.

If it is free now, why shouldn't everyone just freeze their credit? While freezing your credit won't guarantee safety, it's a pretty strong defense against identity theft. But remember — you still need to unfreeze your credit if you legitimately want to apply for a loan or line of credit. You do that with a PIN that you get when you freeze it. While it's not a heavy burden, it does add extra steps anytime you do something that requires a credit check.

You could opt for credit monitoring instead of a full freeze. You can request a free copy of your credit report annually from each of the major credit bureaus, and check it for any activity you don't recognize. If you find anything suspicious, report it immediately and take steps to lock down your credit through a fraud alert or credit freeze.

You can also pay for a credit-monitoring service, which alerts you about any activity involving your credit report. This can quickly bring a potential problem to your attention — but it's not preventative, so you won't know if someone has used your identity until after it happens.

How do I freeze my credit? If you want to freeze your credit, you need to contact each of the credit bureaus: Equifax (1-800-349-9960), TransUnion (1-888-909-8872) and Experian (1-888-397-3742). If you request a freeze, be sure to store the PIN to unfreeze your accounts in a safe place.

Whether or not you choose to freeze your credit, fraudsters could still take advantage of you by getting things like your credit card number(s) or passwords to online accounts. So you will need to continue to ensure you take proper steps to secure your information so that it doesn't fall into the wrong hands.





ICE CREAM SANDWICH CAKE

This recipe made without variations tastes exactly like a Dairy Queen Peanut Buster Parfait!

24 plain ice cream sandwiches

1 to 2 jars of hot fudge sauce (or one very large one) – NOT heated 1 to 2 small containers of Spanish peanuts (aka, Redskin) 1 large container Cool Whip, thawed

Unwrap 12 ice cream sandwiches and place them in the bottom of a 9 X 12 pan, cutting to fit if needed (keep the other 12 in the freezer for now). Spread with hot fudge sauce (straight out of the jar, NOT heated) on top of the ice cream sandwiches. Sprinkle 1/2 of the peanuts on top of the fudge sauce (if you like a lot of peanuts, use one small container now, save second container for top).

Unwrap remaining 12 ice cream sandwiches and layer on top of the peanuts. Can spread with more fudge sauce if preferred, opening second jar if required. Top with cool whip. Sprinkle more peanuts on top. Wrap with plastic wrap and keep in freezer until ready to serve.

VARIATIONS:

- (1) Use Neapolitan or "Mississippi mud" sandwiches (if using the Mississippi mud ones, cut down on the amount of the fudge sauce).
- (2) Counting calories? Make "lighter" version by using diet ice cream sandwiches, sugar free fudge sauce and light Cool Whip.
- (3) Substitute almonds or other nuts instead of Spanish peanuts (note, regular jarred peanuts are not as good as the Spanish ones)
- (4) Nut allergy concerns? Use sliced strawberries, crushed Oreos or crushed Girl Scout Thin Mints, or leave out altogether and just use fudge sauce and plain or Neapolitan ice cream sandwiches.

THE IMPORTANCE OF CURB APPEAL

Your home is one of the most major investments you will make in your lifetime. Maintaining a home from the inside out is critically important to retaining its value over time. The more mature your home becomes, the more important it is to maintain it. This applies to your curb appeal as well.

Curb appeal is very important, not just for the appearance of your home, but for the entire neighborhood. Keeping up the appearance of the exterior of your home may not be as exciting as decorating the interior, but in many ways it is much more important. If a majority of the homes in the neighborhood are allowed to fall into poor condition, this screams "we don't care about our homes".

Attached to this newsletter is some further information about curb appeal. It should start with the condition of your house, the grass, landscaping, plants, fencing, etc. Little things like keeping bins out of sight, cleaning leaves out of the gutters, power-washing mold and fungus off the bricks or hosing the driveway may seem insignificant, but it all adds up to an attractive, well-kept appearance. Things like loud exterior paint colors, broken down cars, piles of trash, boats in driveway, falling gutters, broken fences can make your house look trashy and ill-maintained... and makes the entire neighborhood look trashy and ill-maintained. Worn down houses invite things like rodents, snakes and crime!

Your POA Board is charged with protecting the overall value and appearance of the neighborhood. Their duty is to ensure all homeowners follow the deed restrictions. The Board and property management company are not being "mean" by enforcing the rules and regulations - they are doing it because they care about the community and wish to protect not only your home values, but our neighbors as well. A poorly maintained community is a magnet for the criminal element. So by simply maintaining your home, inside and out, you are actively participating in maintaining your home value, the overall home values in the neighborhood and helping to reduce crime. Therefore, please do your part by respecting the rules and regulations of WBPOA. REMINDER: any improvements or major exterior work to your home (front and back) including painting, landscaping, etc. must be approved by the ARC Committee. The ARC Committee approval form is located at the back of this newsletter.

Texas Transportation Code - TRANSP § 545.302

Stopping, Standing, or Parking Prohibited in Certain Places

The City of Houston and the WBPOA are very strict about enforcing the State's neighborhood parking regulations. Non-adherence to these regulations will result in a parking violations / fines from the City, as well as violation notices from WBPOA. The homeowner illegally parked or whose tenants are illegally parked will be financially responsible for any resulting fees incurred by the WBPOA to enforce the regulations.

Under 545.302(a), An operator may not stop, stand, or park a vehicle in the following manners:

- on the roadway side of a vehicle stopped or parked at the edge or curb of a street;
- 2. on a sidewalk;
- 3. in an intersection;
- on a crosswalk;
- between a safety zone and the adjacent curb or within 30 feet of a place on the curb immediately opposite the ends of a safety zone, unless the governing body of a municipality designates a different length by signs or markings;
- alongside or opposite a street excavation or obstruction if stopping, standing, or parking the vehicle would obstruct traffic;
- 7. on a bridge or other elevated structure on a highway or in a highway tunnel;
- 8. on a railroad track; or
- 9. where an official sign prohibits stopping.
- (b) An operator may not, except momentarily to pick up or discharge a passenger, stand or park an occupied or unoccupied vehicle:
- 1. in front of a public or private driveway;
- 2. within 15 feet of a fire hydrant;
- 3. within 20 feet of a crosswalk at an intersection;
- 4. within 30 feet on the approach to a flashing signal, stop sign, yield sign, or traffic-control signal located at the side of a roadway;
- 5. within 20 feet of the driveway entrance to a fire station and on the side of a street opposite the entrance to a fire station within 75 feet of the entrance, if the entrance is properly marked with a sign; or
- 6. where an official sign prohibits standing

REFRESHING WATERMELON PUNCH

1 oblong seedless watermelon (about 10 pounds), washed completely 1 (12 oz.) can frozen lemonade, thawed 2 cups unsweetened pineapple juice

Cut the top of the watermelon off about 1/6 of the way down. Cut the bottom end enough to make sure the watermelon will stand on its own. Scoop out flesh and put in a blender. Process until smooth. Strain through a fine-mesh strainer; discard solids. Return watermelon to the blender. Add lemonade concentrate and pineapple juice and blend well. Transfer to watermelon bowl. Served chilled over crushed ice. To make sure all ingredients are combined, give the punch a little stir before you enjoy it.

This App Can Tell You If A Criminal Is Trying To Skim Your Credit Card

Criminals have plenty of different ways to get their grubby little mitts on your credit card numbers. Sometimes they steal them in bulk from vulnerable servers, like the ones that were breached at Equifax. Other times they snatch them from ATMs, gas pumps and other point-of-sale terminals using something called a skimmer. A skimmer is a small electronic device that a criminal physically hacks into (or onto) a payment card reader. They're designed to be installed quickly (often in less than 30 seconds) so that the crook can get in, make the modification, and get out without raising suspicions.

Some skimmers can simply be stuck on top of a card reader. They're somewhat easy to spot if you're exercising caution when you use a card. There might be a slight difference in the color of the plastic, for example. It might move -- or even pop right off -- if you give it a little tug, too.

At the gas pump, however, a skimmer can be nearly impossible to detect. That's because criminals will often open a pump with a master key and install the skimmer *inside* the pump. There often aren't any clues on the outside that would clue you in to the skimmer's presence... except the Bluetooth signal that criminals use to stealthily retrieve stolen card data.

Fortunately for the rest of us, that signal can also set off the alarm bells on a brand new security app called Skimmer Scanner. The app, created by the white hat hardware hackers over at Sparkfun, scans for those Bluetooth transmissions, communicates with the source, and figures out whether it behaves like a skimmer would.

If suspicious behavior is detected, you'll see an alert like the one above. It's pretty unlikely that Sparkfun's app would show you one for a non-malicious device that happened to be in the vicinity. They've worked on skimmers for law enforcement agencies numerous times and their engineers have a firm handle on how skimmers behave.

Those of you looking for a little extra protection when you pay at the pump can grab Skimmer Scanner from Google Play. Sorry, iPhone users... there's no iOS version yet. Note from newsletter editor: after checking the scanner, remember to put your cell phone away before you start pumping gas to avoid risk of severe injury.

Apple Iphone User? Or simply prefer not to use the app? You can still avoid card skimmers!!

- First and foremost: PAY ATTENTION to your surroundings.
- Avoid going to the ATMs or getting gas at night.
- Choose gas pumps closest to and within sight of cashiers.
- Use ATMs in well-lit, secure locations. Avoid standalone ATMs in corners of stores or out-of-the-way areas.
- At both ATM and pump: check for tampering and wiggle everything. Look at the card reader slot and surrounding areas for anything that looks out of place, mismatched, or loose. At gas station, if the security seals are broken or if the pump's face plate is loose, rickety or open, don't use it.
- Make sure no one is watching you enter your PIN, or filming you on a cell phone.

WBPOA residents who are current on POA dues can request vacation watches from Constable Precinct 7 for vacation planning needs. You can register for a deputy vacation watch by visiting the Precinct 7 website https://constable7.harriscountytx.gov and select "Vacation Watch". You can also call (713) 643-6118 and request a watch.

We have a great team of deputies who watch over our neighborhood, but one person cannot watch over 800 homes at once. So let's do our part!! Report criminal offenses to the authorities. Take note of suspicious activities that occur inside and outside your neighborhood. Contact the police with eyewitness information such as a suspect description to assist law enforcement in their crime prevention efforts. Avoid looking the other way when criminal offenses occur. You could find yourself in need of another citizen's assistance if you become a crime victim. Secure your valuables. Use monitored alarm systems to protect your home and vehicle. Avoid leaving high-priced items in plain view of others. Store yard and portable items in your garage. Use a heavy duty lock to protect your bicycle from theft. Never flaunt large amounts of cash or jewelry. Travel with a group. Use the strength of numbers to help prevent crime. Never go to unfamiliar places by yourself, especially at night. Bring a cell phone and extra money for emergency use. Walk along well-lit paths when traveling outside. Never try to apprehend a suspect. Let the police handle this responsibility. Never assume that any location is totally safe. Always remain cautious of suspicious people and activities. Also, be sure to have the Constable Dispatch the first law enforcement contact for your home alarms. As always, if you see something suspicious, be sure to report it immediately – you do not have to endanger yourself as our patrol officers are quick to respond and will address issues ASAP. If you plan a trip out of town, please get registered with Precinct 7 for a vacation watch – our patrol officers will be happy to help keep an eye on your home.

GIVING YOUR HOME CURB APPEAL

Curb appeal refers to the first impression a guest gets when they drive up to your home. You want your home to have curb appeal, and there are several aspects of your home's outward appearance that you'll want to look their best:

Home Exterior and Siding

A good practice is to walk your neighborhood and compare other homes' exteriors with your own. Does your home look dirty? Do the siding colors look faded? If so, and you have wood or fiber-cement siding, you may consider a paint job. In choosing paint, in most cases you'll want your colors to be neutral and to conform to other homes in the neighborhood. This is not usually a good time to consider bold or garish colors, especially if it violates **deed restrictions**. If your existing paint looks acceptable, you'll still likely want to do paint touch-up – especially on the front of the home, and in eye-level areas.

If you have vinyl, brick or stone siding, you'll want to consider pressure washing. A good pressure washing job is a relatively inexpensive way to help restore the clean look of your home's exterior.

Does your front door look inviting? If not, you may want to think about a new coat of paint, new door hardware or other remedies to give your door more appeal. The rest of your front porch and entryway should also look neat and tidy. If you don't have a plush door mat, this is a good time to consider buying one.

How do your windows look? Windows are a key feature that people notice as they approach and walk through homes. So you'll want your windows to look clean – not only the glass, but also the trim.

Landscaping

Take a fresh look at your landscaping. Are there cost-effective things that you can do to improve the landscaping around your home? Does your grass need re-seeding in certain areas? If so, talk with people at your local landscaping store about the right products to improve your grass. Do you have enough plants or bushes to prevent your yard from looking barren? If so, consider buying and planting some inexpensive bushes. However, we don't recommend paying a lot of money to plant trees – you may not get your money back.

Beyond planting new grass, flowers and bushes, a more cost-effective method to improve your landscaping can be to simply make the most of what you already have. Making sure your bushes are trimmed, grass is well cut and dead plants are removed can go a long way in giving your home's exterior a neat appearance.

Backyard

You'll want your backyard to appear neat and spacious. If you have a lot of extraneous items in your backyard – such as swing sets, kids' toys, etc. – you'll likely want many of these things removed. Such items can be distracting and can make your yard look smaller than it really is. In addition, if you have a deck or screen porch, you'll want to thoroughly wash this before you begin showing your home. Finally, if you have a pool, you should also make sure it looks as neat and clean as possible.
