## ENROLLMENT AGREEMENT AND RELEASE

J. Park Taekwondo LLC, hereinafter called the School, will use its best effort to assist the Student to obtain his/her maximum potential in the martial arts. The School is committed to providing and maintaining competent instructors, suitable facilities, and a varied and regular class schedule. The Student recognizes that class schedules may be adjusted periodically to further the School's goal of matching students of generally similar size and ability. The Student realizes that leadership training is an integral part of the discipline of the martial arts, and therefore students of higher belt levels may occasionally assist instructors in providing instruction and supervision in classes. Official belt recognition will be issued to the Student by the School upon the successful completion of an examination and the requirements thereof.

While a member of the School, the Student agrees to comply with the rules and regulations of the School and the traditions of the martial arts. The Student recognizes that regular class attendance is important to the Student's progress and understands it is the Student's responsibility to attend the classes. The Student, or the parent or legal guardian on behalf of the Student, acknowledges that there have been no representation, promises or inducements made by the School with respect to this Agreement, other than expressly set forth herein, and that this Agreement contains the entire understanding between the parties. Failure to take the lessons in the allocated time will result in the forfeiture of the Student's right to such lessons. In case of accident, illness, or vacation time, a maximum of three months extension will be granted on each year of the Agreement. Extension will not be granted without written request from the Student, and written approval of the School. It is further understood that failure to complete these lessons does not relieve the Student of the obligation to pay the tuition in full. The Student recognizes that the School has made substantial commitment in terms of staff and facilities in order to provide competent levels of instruction in the martial arts, and therefore acknowledges a corresponding commitment to fulfill the Student's obligations under this Agreement. These obligations include payment of the tuition set forth on the other side of this Agreement. Upon the Student's failure to do so, the School shall be entitled to enforce the Promissory Note contained herein according to its terms, and the Student will be responsible for expenses incurred by the School, including reasonable attorney fees. The Student further agrees to waive trial by jury in the event suit be brought to enforce any part of this Agreement.

Lessons scheduled may be modified from time to time, at the discretion of the School, for holidays, tournaments, examinations, and other School activities. The School shall give prior notice of such modifications by general announcements. The course shall expire on the date shown on this Agreement or upon attainment of the belt level, which event occurs first.

The Student, or the parent or legal guardian on behalf of the Student, acknowledges and is fully cognizant of the inherent dangers in connection with the practice of martial arts, and acknowledges that the practice of martial arts requires physical exertion and contact and realizes that there is a risk of physical injury which may be incurred while engaging in this activity. Protective equipment, required by the School, is designed to lessen the likelihood of injury. However, the School does not warranty the protective equipment. It is the Student's responsibility to purchase such equipment.

In consideration of being allowed to enroll in this course, the Student, or parent or legal guardian on behalf of the Student, hereby assumes all risks of bodily injury, death, or property damage due to negligence of the School, its principals, agents, employees, instructors, fellow students, or others in connection with the activities undertaken in the teaching, practice, training, testing, and competition involving martial arts; and further for himself, his spouse, legal representatives, heirs and assigns, hereby releases, waives, discharges, and agrees to save and hold harmless the School, its principals, agents, employees, instructors, and fellow students, for any injury or damage whether foreseen or unforeseen any claim resulting therefrom whether caused by the negligence of the School, its principals, agents, employees, instructors, and fellow students arising out of the enrollment or participation in this course.

The Student, or parent or legal guardian on behalf of the Student, further states that he is of lawful age and is legally competent to sign this Agreement and Release, and understands that

The Student, or parent or legal guardian on behalf of the Student, warrants that the Student has had a medical examination to assure himself, and assume his own responsibility of physical fitness and capacity to perform under this program, and is physically fit as attested to by the medical examination.

In the event the School's classroom is relocated further than ten miles from its present location, and there is no other branch of the School available, the Student may terminate this Agreement upon written notice to the School within ten (10) days after such relocation.

This Agreement is non-transferable without express written consent of J. Park Taekwondo LLC. Absolutely no refund on any program after seventy-two (72) hours. For purposes of this Agreement, reference to the Student is without gender and applies to men, women, boys, and girls alike. REBATE AND DEFAULT any unpaid balance may be paid at any time without penalty and any unearned charge will be refunded based on the "Rule of 78's". We reserve the right to refuse service to anyone at anytime.

The J. Park Program is a free to come and go program just like all of the other martial arts programs offered. We officially are not a daycare and our stock in trade is not supervision and care but rather our intent is to teach martial arts physical and philosophical character building skills. We are in the talent and skill business.
