Vendor Rules and Regulations

Event Schedule:

Event hours are Thursday, June 7, 2018, 6 pm - Sunday, June 10, 2018, 2 pm. Setup will take place from Thursday, June 7, 4 pm to 5:30 pm. Breakdown will begin at 2 pm on Sunday, June 10, 2018 and **must** be completed by 4 pm on Sunday, June 10, 2018.

***No cars or golf carts will be allowed into the festival area until Event organizers have cleared pedestrians on Sunday, June 10, 2018.**

Check - In:

All vendors must sign in at the "Vendor Sign - In" located at the Fairgrounds. This is where vendors will receive space assignments and hospitality packets. Space assignments will **not** be given out prior to the event. Special requests for locations can not be guaranteed and are based on availability and layout.

Security:

The Fairgrounds will remain open throughout the event. Vendors may wish to leave their booths overnight on Thursday, June 7th, Friday, June 8th and Saturday, June 9th, 2018. In doing so, vendor acknowledges that Hog Happenin' Foundation, Inc. and American Legion Post #48, nor any partnering agencies will be held responsible for damage to or loss of goods.

Restrooms:

Public restroom facilities will be located throughout the event.

Pets:

No pets are allowed in the festival area.

Refunds:

We reserve the right to deny any application. If your application is not accepted, your application fees will be refunded. **Refunds will not be given to vendors who cancel their registration after Tuesday, May 1, 2018.**

Inclement Weather:

This event will go on rain or shine; however, if Hog Happenin' Foundation, Inc. dictate cancellation of the event due to severe weather, Hog Happenin' Foundation, Inc not any partnering agencies will be bound to reschedule the event, nor will the aforementioned entities be bound to reimburse entry fees.

Electric:

Electricity is not available. If you need electricity, please plan to bring a QUIET generator. Loud generators will not be allowed and violators will be asked to leave.

Vendors Insurance

Vendors are asked to please provide your own Vendor insurance. As a concessionaire, exhibitor or vendor, specialty vendor insurance can help protect you against lawsuits. Your business will be protected against bodily injury and property damage claims that may arise from operations, premises, products, completed operations, advertising or personal injuries. Products and completed operations coverage includes all bodily injury and property damage to a third party that occurs after your product or work leaves your possession. For more information please contact the insurance company of your choice. The organizers may ask you to provide a copy of your Vendor Insurance information.

Parking:

Vehicles are not allowed within the event area unless pre-approved by the Hog Happenin' Foundation, Inc. Parking is available OUTSIDE of the event area.

All vendors are responsible for providing their own equipment; example: tents, tables, etc.

IMPORTANT - Please keep in mind the organizer of this event does NOT own the property where the event is held. We ask that you take all of your waste and belongings back home with you and leave the site as it was when you arrived.
