DAVIDSON COUNTY BOARD OF ELECTIONS

November 7, 2023

The Davidson County Board of Elections met on Tuesday, November 7, 2023 at 2:00 p.m. in the Board of Elections office located at 945 N. Main Street, Suite A, Lexington, North Carolina 27292.

Mr. Cunningham called the meeting to order at 2:00 p.m. with the following members present: Belinda Clark, Kathy Hunt, Chad Freeman, and Richard Johnson. Director Andrew Richards and Deputy Director Adam Moore were present. There were no visitors present.

Ms. Clark read the minutes from the October 31, 2023 board meeting. Mr. Freeman made a motion to accept the minutes and seconded by Ms. Hunt. It was unanimously approved.

Deputy Director Adam Moore presented the board with 16 Civilian Absentee Ballots recommended for approval for the November 7, 2023 Municipal Elections. After review, Ms. Clark made a motion to approve the 16 Civilian Absentee Ballots and was seconded by Mr. Johnson. It was unanimously approved.

Deputy Director Adam Moore presented the board with 4 Civilian Absentee ballots that had the copy of their photo ID inside the return envelope with the ballot. After review, Mr. Freeman made a motion to approve the 4 Civilian Absentee Ballots and was seconded by Mr. Johnson. It was unanimously approved.

Deputy Director Adam Moore presented the board with 1 Overseas ballot recommended for approval for the November 7, 2023 Municipal Elections. After review, Mr. Freeman made a motion to approve the Overseas ballot and was seconded by Mr. Johnson. It was unanimously approved.

Director Andrew Richards ran the tabulation of the 36 total Absentee Ballots that were approved for the November 7, 2023 Municipal Election. Mr. Johnson made a motion to approve the tabulation for the Absentee ballots and was seconded by Ms. Clark. It was unanimously approved. The tabulation results tapes were signed by each board member.

Deputy Director Adam Moore ran the tabulation for the Thomasville Library One-Stop Early Voting site for the November 7, 2023 Municipal Elections. Mr. Freeman made a motion to approve the tabulation for the Thomasville Library Early Voting site and seconded by Mr. Johnson. It was unanimously approved. The tabulation results tapes were signed by each board member.

Deputy Director Adam Moore ran the tabulation for the Board of Election One-Stop Early Voting site for the November 7, 2023 Municipal Elections. Ms. Clark made a motion to approve the tabulation for the Board of Elections Early Voting site and seconded by Ms. Hunt. It was unanimously approved. The tabulation results tapes were signed by each board member.

Deputy Director Adam Moore presented the board with 2 Same-Day Registration voters during the Early Voting period that came back as not having their voting rights restored yet due to a felony conviction. Mr. Freeman made a motion to conduct a board-initiated challenge to the 2 Early Voting ballots and seconded by Ms. Hunt. It was unanimously approved.

Deputy Director Adam Moore presented the board with 5 ballots from voters during the Early Voting period that received the incorrect ballot style and proceeded to vote a Provisional Ballot. Ms. Clark

made a motion to conduct a board-initiated challenge to the 5 Early Voting ballots and seconded by Ms. Hunt. It was unanimously approved.

Director Andrew Richards presented a list of emergency judge appointments for precincts used in the November 7, 2023 Municipal Elections. After review, Mr. Freeman made a motion to approve the emergency judge appointments as presented by staff. It was seconded by Mr. Johnson and unanimously approved.

Mr. Freeman made a motion to adjourn at 3:06 p.m. and was seconded by Ms. Clark. It was unanimously approved.
