

DAVIDSON COUNTY BOARD OF ELECTIONS

November 2, 2022

The Davidson County Board of Elections met on Wednesday, November 2, 2022 at 6:00 p.m. in the Board of Elections office located at 945 N. Main Street, Suite A, Lexington, North Carolina 27292.

Mr. Cunningham called the meeting to order at 6:00 p.m. with the following members present: Belinda Clark, Secretary, Board Members Kathy Hunt, Chad Freeman, and Richard Johnson. Director Andrew Richards and Deputy Director Adam Moore were also present.

Ms. Clark read the minutes from the October 25, 2022 board meeting. Mr. Johnson made a motion to accept the minutes and seconded by Ms. Hunt. It was unanimously approved.

Director Andrew Richards presented the Board with Site-Specific Observers List for Election Day from the Davidson County Republican Party. Mr. Freeman made the motion to accept the list of Site-Specific Observers and seconded by Ms. Hunt. It was unanimously approved.

Director Andrew Richards presented the Board with precinct judge appointments for the November 8, 2022 General Election. Mr. Freeman made a motion to accept the Precinct Judge appointments and seconded by Mr. Johnson. It was unanimously approved.

Director Andrew Richards and Deputy Director Moore provided an update on One-Stop Early Voting in Davidson County. Ms. Hunt made a motion to accept the Early Voting numbers and seconded by Mr. Johnson. It was unanimously approved.

Director Andrew Richards presented the Board with 485 Civilian Absentee Return Envelopes that were returned for the November 8, 2022 General Election to be reviewed and approved by the Board. After review, Ms. Clark made a motion to accept all 485 Civilian Absentee Ballots and seconded by Mr. Freeman. It was unanimously approved.

Director Andrew Richards presented the Board with 7 Overseas Absentee Ballot Return packets that were returned for the November 8, 2022 General Election to be reviewed and approved by the Board. After review, Ms. Clark made a motion to accept all 7 Overseas Absentee Ballots and seconded by Ms. Hunt. It was unanimously approved.

Director Andrew Richards presented the Board with 5 Military Absentee Ballot Return packets that were returned for the November 8, 2022 General Election to be reviewed and approved by the board. After review, Ms. Hunt made a motion to accept all 5 Military Absentee Ballots and seconded by Mr. Johnson. It was unanimously approved.

Director Andrew Richards also presented the Board with 6 Absentee Ballot Return Envelopes that did not meet the necessary requirements for approval. After review of the Absentee Ballot Return Envelopes, Ms. Hunt made a motion to reject the 6 ballots and seconded by Mr. Freeman and it was unanimously approved. Director Richards told the board that Absentee cures have already been sent to those voters.

The Board began tabulation of the approved ballots from the November 2, 2022 Absentee Board Meeting. Tabulation concluded with 1359 total ballots being tabulated for the November 8, 2022 General Election. Ms. Clark made the motion to accept the tabulation of all 1359 ballots and seconded by Ms. Hunt and it was unanimously approved.

Mr. Freeman made a motion to adjourn at 9:06 pm and seconded by Mr. Johnson and it was unanimously approved.
