Privacy Policy

This Privacy Policy ("Policy") applies to SMS text messaging, and Finger Lakes Mobile Veterinary Services PLLC ("Company") and governs data collection and usage. Collection of your Personal Information

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

- -Exercise free speech, ensure the right of another consumer to exercise his or her right of free
- -Comply with the California Electronic Communications Privacy Act;
- -Engage in public or peer-reviewed scientific, historical, or statistical research in the public ir
- -Enable solely internal uses that are reasonably aligned with your expectations based on your
- -Comply with an existing legal obligation; or
- -Otherwise use your personal information, internally, in a lawful manner that is compatible wi
