Dear Judge Bedell:

In accordance with paragraph 7 on pages 14 and 15 of the January 18, 2011 Order respecting Medical Monitoring, please consider this letter to nominate the In-Class Area Members for the Claimants Advisory Committee.

In arriving at the nominations, your Claims Administrator met with the Class Representatives on February 1 and discussed this topic with Meredith McCarthy, Esq., the Guardian Ad Litem for Children, on February 4. Your Claims Administrator has also discussed this issue with the Class nominee on the Finance Committee, who has provided her input. The following are nominated without reservation:

Lenora Perine Reverend Joe Bradshaw Carolyn Holbert Mary Luzader Richard Desist

All of the above nominees except Richard were Class Representatives in the <u>Perrine v. DuPont</u> litigation, and have intimate knowledge of this case. We ask the Court to take judicial notice

of the fact that Richard's Father is a Class Representative and is having health concerns, but that Richard wishes to serve on the Advisory Committee in his stead. Richard has monitored the case and is also very familiar with the Settlement, and has agreed to serve.

The below two additional Class Representatives have expressed an interest in serving upon the In-Class Area Advisory Committee, but they are Plaintiffs in separate litigation for alleged personal injury against DuPont:

Ms. Waunona Crowser Ms. Rebecca Morlock

Your Claims Administrator is concerned that, should these two nominees serve on the Advisory Committee, DuPont may not be able to attend Advisory Committee meetings and provide input on Settlement design, with DuPont both trying to aid your Claims Administrator and the Court in carrying out this Settlement and being in litigation with these two nominees.

In order to provide these two additional potential In-Class Area Advisory Committee Members procedural due process, this letter suggests that the Court invite them to provide a written statement to the Court by February 20 to address this issue. DuPont may then be invited to provide a reply, if any, by February 28, with the matter then deemed to be submitted to the Court.

Your Claims Administrator also recommends without reservation that Meredith McCarthy, the Guardian Ad Litem for Children, serve on the Claimants Advisory Committee as a Member at Large, and to represent the interests of both In-Class Area and Out-of-Class Area children Medical Monitoring Class Members in this settlement.

At the town meetings, we will be asking for nominees for Out-of-Class Area Advisory Committee Members, and we will provide a report to the Court with a recommendation shortly thereafter.
