**AFFIDAVIT OF ROBERT E. SMITH, JR.**


COMES NOW the affiant, Robert E. Smith, Jr., after having been duly sworn and states as follows.

**AFFIDAVIT OF AUSTIN R. HEADLAND, III**

COMES NOW the affiant, Austin R. Headland, III, after having been duly sworn  
and states as follows.

1. My name is Austin R. Headland, III. I have served as the Comptroller for the law firm of Cochran, Cherry, Givens, Smith, Lane & Taylor, P.C., since 1993. As Comptroller, my duties include but are not limited to managing accounts payable, accounts receivable, and trust accounts. Specifically, I am responsible for overseeing receipt and payment of invoices related to case expenses.
2. Attached hereto is "Spelter Cost Detail" dated December 9, 2010. I compiled this detailed report reflecting all expenses related to the above styled matter that were incurred and paid by the law firm of Cochran, Cherry, Givens, Smith, Lane & Taylor, P.C. This report is based on the business records maintained in the

regular course of our business from April 2004 through November 2010. The report contains the date, reference, payee, and amount for each expense incurred by Cochran, Cherry, Givens, Smith, Lane & Taylor, P.C., and Cochran, Cherry, Givens & Smith, P.C., related to the above-styled case.

3. The designated categories are categories identified and maintained as a result of our accounting software. Attached to the Cost Detail Report is a list of the categories and description of each. Specifically, I have included the following categories of expenses:
  - a. **Court Costs/Filing Fees** represents any expenditures related directly to the Court and includes payment for the discovery commissioner's time, pro hac vice admissions, and filing fees.
  - b. **Color Copies** represents the cost of reproducing photos and other exhibits in color and used as exhibits for hearings, depositions, trial and appellate proceedings.
  - c. **Communication Costs** represents long-distance telephone costs and investigator cellular expenses.
  - d. **Contract Labor** represents the cost of outsourcing tasks that could not be handled in-house, such as scanning documents produced in discovery (e.g., On-Site Sourcing, Inc.) and additional legal research assistance (e.g., Christopher Mislow).
  - e. **Copies** represents the cost of reproducing documents. It is my understanding there were hundreds of thousands of pages of documents produced in this


matter and hundreds of thousands of pages of documents generated in this matter.

- f. **Court Reporting** represents the cost of obtaining depositions and hearing transcripts.
- g. **Expert Fees** represents the amounts charged by the experts retained by Plaintiffs for investigation, research, summaries and testimony in this matter.
- h. **Express Mail** represents the costs related to using private or commercial package handlers for shipments, such as UPS or Federal Express.
- i. **Fax** represents the costs of transmitting facsimiles.
- j. **Investigative Fees** represents the costs incurred by investigators for various work such as serving subpoenas, taking statements, etc.
- k. **Interest** represents the interest incurred by the law firm as a result of advancing case expenses from the firm's credit line.
- l. **Mediation Fees** represents the costs of a third-party alternative dispute specialist.
- m. **Miscellaneous** represents various expenses that do not necessarily fit within the other categories and are usually incurred when a staff or lawyer is on the road. I have included a comment section on the attached cost detail reflecting the nature of the expense. For example, miscellaneous expenses include payment to Case Logistix (a case management system) for user licenses, payment to Xpress Solutions for color copier rental during trial, and Paradoocs for digital production of appellate briefs.

- n. **Photographs** represents the cost of reproducing photos used as exhibits for hearings, depositions, trial and appellate proceedings.
  - o. **Postage** represents the cost of mail using the United States Postal Service.
  - p. **Publication costs** represents the costs related to notice to the class, including payment to Analytics, Inc., to identify property owners and costs of providing notice to the class.
  - q. **Research** reflects the costs of obtaining legal research, generally through Westlaw or on-line libraries.
  - r. **Travel Expenses** reflects the costs related to travel for investigation, depositions, hearings, document review, client meetings, trial, appellate work, etc. Generally, travel expenses are reimbursed to the lawyer or support staff after he or she has incurred that expense.
4. There are two categories (Costs/Cost Deposit and Expense Transfer) included in the attached "Spelter Cost Detail" that do not reflect expenses per se. These categories are internal devices used to account for payments and/or reimbursements from co-counsel. They have no bearing on the other expenses itemized in the Report.
5. The attached report is a true and accurate accounting of the expenses incurred by the law firm of Cochran, Cherry, Givens, Smith, Lane & Taylor, P.C. All entries are based on documents kept and maintained in the regular course of our business. These documents can be made available for the Court's inspection should the Court so desire.

6. Additionally, I am prepared to testify as to the accuracy and authenticity of the attached report. If called to testify, I will present the information contained in the attached report.
