FINAL ORDER APPROVING THE ELEVENTH ADMINISTRATION BUDGET FOR THE SETTLEMENT

Presently pending before the Court is the Eleventh Budget for the Settlement Medical Monitoring Program (for the twelve months beginning September 1, 2020 and ending August 31, 2021) (the "Eleventh Settlement Administration Budget" or the "Budget"), submitted to the Court and The Finance Committee, on August 25, 2020 with no objections being received.

The Court notes that the Settlement Medical Monitoring Fund Budget is to be funded by the Medical Monitoring Fund Account created by a Court-ordered DuPont contribution on October 31, 2011, and by additional contributions from DuPont, if necessary. According to the Claims Administrator's August 25, 2020 Report to the Court, no additional DuPont funding of the Medical Monitoring Fund Account is required at this time, as the projected Account balance at August 31, 2020 will be approximately \$202,500, and projected Medical Monitoring expenses for the Budget period are approximately \$166,000.

After a careful review of the Eleventh Settlement Administration Budget, and in consideration of the applicable law, the Court **ORDERS** that the same is hereby **APPROVED** and shall be used in the administration of the Settlement, and that DuPont shall issue no payment to the Medical Monitoring Fund.

Lastly, pursuant to Rule 54(b) of the West Virginia Rules of Civil Procedure, the Court directs entry of this Order as a Final Order as to the claims and issues above upon an express determination that there is no just reason for delay and upon an express direction for the entry of judgment.
