**FINAL ORDER APPROVING THE
TWELFTH ADMINISTRATION BUDGET FOR THE SETTLEMENT**

Presently pending before the Court is the Twelfth Budget for the Settlement Medical Monitoring Program (for the twelve months beginning September 1, 2021 and ending August 31, 2022) (the "Twelfth Settlement Administration Budget" or the "Budget"), submitted to the Court and The Finance Committee, on August 18, 2021 with no objections being received.

The Court notes that the Settlement Medical Monitoring Fund Budget is to be funded by the Medical Monitoring Fund Account created by a Court-ordered DuPont contribution on October 31, 2011, and by additional contributions from DuPont, if necessary. According to the Claims Administrator's August 18, 2021 Report to the Court, an additional DuPont funding of the Medical Monitoring Fund Account is required at this time, in the amount of \$65,000.00, as the projected Account balance at August 31, 2021 will be approximately

\$134,000, and projected Medical Monitoring expenses for the Budget period are approximately \$199,000.

After a careful review of the Twelfth Settlement Administration Budget, and in consideration of the applicable law, the Court **ORDERS** that the same is hereby **APPROVED** and shall be used in the administration of the Settlement, and that DuPont shall issue payment to the Medical Monitoring Fund in the amount of \$65,000.00 within sixty days from the date of this Order.

Lastly, pursuant to Rule 54(b) of the West Virginia Rules of Civil Procedure, the Court directs entry of this Order as a Final Order as to the claims and issues above upon an express determination that there is no just reason for delay and upon an express direction for the entry of judgment.

IT IS SO ORDERED.


