## ORDER SETTING FAIRNESS HEARING

Presently pending before the Court is the issue of the implementation of the property remediation portion of the settlement, including the level of soil contamination in Zone 1A and house or commercial structures contamination throughout the Class Area, with cadmium, arsenic, zinc or lead which justifies remediation, and the results of the Claims Administrator house and soil verified testing to date. To allow Class Area property owners and concerned citizens a chance to comment on the implementation of the property remediation portion of the Settlement, the Court hereby ORDERS that a Fairness Hearing will be held on Tuesday, May I, 2012 and Wednesday, May 2, 2012.

The Fairness Hearing will be held in Judge Bedell's Courtroom on the Fourth Floor of the Harrison County Courthouse. The May 1 Session of the Hearing will begin with registration for interested persons to speak from 8:00-8:30 AM, and the Hearing will begin at 8:30 AM. The May 2 Session of the Hearing will begin with registration for interested persons to speak from 8:00-8:30 AM, and the Hearing will begin at 8:30 AM; the Court will attempt to allow all interested persons an opportunity to address the issues related to the property remediation program during the two-day Hearing.

Both Sessions of the Hearing will begin with a presentation of the issues by the Claims Administrator, Edgar C. Gentle, III, and the Court will consider the opinions presented on either day of the Hearing equally.

Anyone can attend and speak at either day of the Fairness Hearing, but the Court suggests that people with a last name beginning with the letters A through L attend the May 1 Session of the Hearing, and that people with a last name beginning with the letters M through Z attend the May 2 Session of the Hearing.
