**ORDER FOR THE DISTRIBUTION OF THE
FINAL REMEDIATION PROGRAM FUNDS**

Presently pending before the Court is the Claims Administrator's Report proposing the issuance of a donation of approximately \$1,529.48, to the Spelter Volunteer Fire Department, submitted to the Court and the Finance Committee on May 13, 2019, with no objections being received.

After a careful review of the Claims Administrator's Report concerning the issuance of a Property Remediation Program Final Third Dividend, and in consideration of the applicable law, the Court **ORDERS** that the same is hereby **APPROVED**.

The Court hereby **ORDERS** that:

1. The Court has the jurisdiction and discretion to determine the usage of the remaining Property Remediation surplus funds, which total approximately \$1,529.48.
2. This Court entered its "Order for the Distribution of the Final Third Remediation

Surplus,” on June 21, 2018, wherein the Court ordered that the remaining \$187,000 Property Remediation surplus be distributed to the Property Class Members under the same Rules previously set by the Court in its “Final Order Determining the Final Surplus Payment Program Calculations,” entered on November 28, 2016.

3. The Court finds that the Claims Administrator, on August 22, 2018 and August 23, 2018, issued the final dividend payments accordingly.
4. The Court finds that there are 22 outstanding Claimant final dividend payments, for which the Claims Administrator and his staff has done their due diligence in order to locate the Claimants to deposit or cash the payments, to no avail.
5. The Court Orders, Directs, and Decrees that the remaining Property Remediation surplus funds shall be distributed to the Spelter Volunteer Fire Department.
6. Provided the Claims Administrator acts strictly in accordance with the protocols and the directives of this Order, he and his staff are granted Judicial Immunity.

Pursuant to Rule 54(b) of the West Virginia Rules of Civil Procedure, the Court directs entry of this Order as a Final Order as to the disposition of the Remediation surplus funds and makes the express determination that there is no just reason for delay and expressly directs the entry of judgment on that issue.




