### ARTICLE I - NAME

The name of the Corporation is:

# **ARTICLE II - PURPOSES**

The purposes for which the Corporation is formed are:

TO PROMOTE GOOD RELATIONS AND HARMONIOUS RELATIONSHIPS BETWEEN OWNERS AND RESIDENTS OF LOTS IN THE VALLEY OF THE PINES; TO CARE FOR, MAINTAIN, AND CLEAN ALL ROADS IN THE SUBDIVISION KNOWN AS VALLEY OF THE PINES AND ALL ADDITIONAL AREAS PLATTED THERETO.
