If you need a permit, call me at 579-9582. Leave Sue a message and she will call you back.

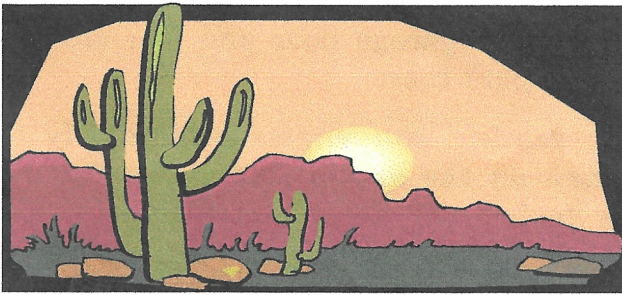




## PLEASE HELP KEEP OUR NEIGHBORHOOD BRIGHT AND SAFE !
