from the Mayor's desk --

The Council seat that has been vacant since May was appointed at the September meeting. Linda Clark accepted appointment to Council effective at that meeting and the Village Council is complete with the six current members.

No further changes to Village administration will be necessary until the January 2020 Council meeting when two Council seats will be available (due to no November election candidates) for appointment by Council for the upcoming 4-year terms for each seat. Anyone who has interest to be appointed to Council should attend the January meeting. At the January meeting, the President of Council will serve also as acting Mayor (due to no November election candidates).

Congratulations to FoWL for a successful *Run the Lakes!* 5K Race, looking forward to the 2nd annual Hog Roast event on Sunday, September 29th. The Village is a better place with FoWL support.

With updated financial understanding for future years, Council has approved moving forward with initiating a contract agreement to purchase the 1052 Main Drive property currently being used for the Village Office. The real estate contract is being drafted, with an anticipated Council decision for whether to enter into that contract possibly at the October Council meeting. Contact a Council member if you have questions.

Two other Council decisions scheduled to be made yet this year are for the Beach in 2020 and Phase II of the Sewer Project. For each, and for all other Village business, let Council members know your thoughts to guide their decisions to be representative of the residents and property owners in Wayne Lakes.

Council has approved a trial-run Wayne Lakes Fall Leaves-only Cleanup (leaves only) scheduled for October 25-27 and November 1-3. See details before the calendar in this newsletter, and start your leaves collecting now. For space considerations, mulch them first if possible.

The roads patching project has been completed, Council approved a renewed snow removal contract for this winter, and street sweeping preparation for the FoWL-sponsored 5K race all have positioned the Village well for roads conditions.

Good things continue... by year end, I hope we all can agree that 2019 has been a good year for the Village.

A Village-provided dumpster available for **leaves only!** will be available during daylight hours only for **leaves only!**




The dumpster will be located in the *Beach* parking lot where functional cameras will be recording.

This dumpster is intended only for **leaves only!** that are collected within the Village.

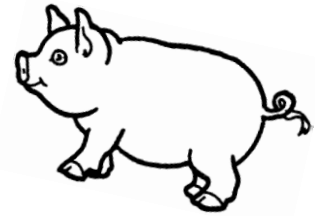

CodeRED
New Emergency Notification System

On Monday, August 12, 2019 the Darke County Commissioner's signed a contract with Onsolve for the CodeRED Emergency Notification System.

CodeRED is an emergency notification system that includes automated weather alerting to those who choose it and can also be activated for other situations in which notifying the public is warranted. CodeRED also has a mobile app that can be downloaded to any smart phone to receive notifications and will also "travel" with the user if they allow location services on their device. For example, if I register for an account and live in Greenville, I will receive all alerts that include that area. If I have the app and I am in another part of the County, I will receive alerts based on my physical location also.

This notification system may also be used for things like 911 outages, boil water alerts, missing persons etc.

Right now the most important thing is we get people and businesses to register for an account. This can be done through darkecountyema.org, darkecountysheriff.org or text "DARKE" to 99411 for a mobile friendly enrollment form.
