- 3. Jennifer #1104 Suggests better insulating the attic space to stop icicles. Unit owners can hire someone to insulate their attics if they have access. Submit request to Michelle
- 4. David #210 We need gutters. Buildings with gutters appear to have less icicles.
- 5. Jennifer #1104 Has a layer of solid ice on her deck and has tried to shovel it. Suggested using a bit of salt to help break up the ice and try shoveling it again
- 6. Justin #610 Commented that today is the first day he was able to shovel the ice from his deck

- 8. Karen #110 Sent an email with pictures regarding her neighbor allowing her dog to poop and urinate on the upper brand new deck Neighbor will be receiving a fine.
