Dear JEREMY MALONE:

The information provided below serves as notification of registration of the pesticide-producing establishment(s) for which you applied, pursuant to Section 7 of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA). <u>Each registered establishment is assigned a unique establishment registration number</u>. This establishment registration will remain in effect, provided pesticide reports on production and sales or distribution amounts are submitted annually as required. (See computer printout on Page 2).

Part 167 of the Code of Federal Regulations (40 CFR) requires your company **to submit an Initial report for Pesticide-Producing Establishments, EPA Form 3540-16 within 30 days of receipt of this letter.** EPA Form 3540-16 can be completed electronically, instructions for completing the form electronically can be found at https://www.epa.gov/compliance/electronic-reporting-pesticide-establishments. In addition, you have the option to submit your company's Initial Report(s) and subsequent annual report(s), <u>electronically!</u> EPA has created an optional electronic reporting system for pesticide establishments using the Section Seven Tracking System (SSTS) through EPA's Central Data Exchange (CDX). (See Page 3 for more details).

Failure to submit your Initial report(s) within 30 days may subject your establishment(s) to an administrative civil penalty.

After the Initial Report(s), future reports must be submitted on a <u>yearly basis</u>. Production reports for establishments registered to produce pesticides and pesticidal devices are due by **March 1st** as long as the establishment is active, regardless of whether or not production has occurred (regulations pursuant to Section 7 of FIFRA).

Parts of the 40 CFR which apply to pesticide establishments are: (1) Part 167-Registration of Pesticide and Active Ingredient Producing Establishments, Submission of Pesticide Reports and (2) Part 169-Books and Records of Pesticide Production and Distribution.

Changes in name, address, or ownership of the company or any establishments are to be reported to this office within thirty (30) days of the change. If your company decides to cease production of all pesticides and pesticidal-devices, you may request inactivation of the establishment(s). Requests for inactivation of establishments are also to be sent to this office.

The container of each pesticide product which is released for shipment must bear the EPA Establishment Number assigned to the establishment in which it was produced. This number, which is to be preceded by "EPA Est.", may appear in any suitable location on the label or immediate container. It must also appear on the outside container or wrapper of the package if the EPA Establishment Number on the immediate container cannot be clearly read.
