The start of Cody's Herding adventure was when we took him to Nolan Rivers in January 2010. He earned his Herding Instinct title and both judges told me he had a lot of natural talent, but I wanted to finish his Championship (all he needed was his majors). He got the first one on Friday at our specialty in March and the second major the next day in Fort Worth.

I was so very happy that was finished, but I had also started on his Rally title since he was going to dog shows might as well kill two birds with one stone when you can.

Herding needed to wait a little longer so, off to Oklahoma for four days of rally only needing two legs. We weren't planning to put Cody out as a special but his handler was going to be there to show him in best of breed for the four days while we were going to be there anyway. He got the two legs he need for the rally title, but he also went best of breed all for days. I did not know that AKC had just started a new conformation title the Grand Championship. Another person showing with us pointed out the he had gotten a 4 point major on Thursday and 5 point majors on Friday, Saturday and Sunday. So he had 19 of the 25 points and all his majors for his Grand Championship.

So herding had to be put off a little longer.

We needed to finish the Grand Championship and it was summer, so I didn't want to start herding then. He finished his Grand Championship in August at the Terv specialty in Greeley, Co with an AOM, BOS, and a Select; we were so happy that title was achieved – now on to herding.

We tried the two places that have herding trials here in the metroplex, but neither place had a training style I felt comfortable with in training Cody. But as luck would have it a friend heard about a lady in the Austin area that was a very good herding trainer so we went to check it out.

She was very good herding trainer and she thought Cody had a lot of natural talent, but the 3 ½ hour drive one way was a challenge by itself. So she thought it would better if I did a “Board and Train” in the fall. Mid-October Cody went to herding camp for 6 days and I went back down on Friday and Saturday so I could learn what she started with Cody. Camp ended very well, Cody and I were off to a good start, as luck would have it a friend of hers had moved to Granbury.

That is when I met Alison & Herbert Holmes and things really came together for us. We now had a place we could train almost weekly. So I entered him in a trial mid November. On Saturday thing went well, Cody qualified (Thank You judge Susan Abrams), but Sunday there was a big weather change – Thunderstorms!! Naturally the stock was very spooky and uncooperative so no qualification.

So in January we attended a clinic with Cappy Pruett and Kyle Smith that went well. Cody and I learned some new things to add to our herding bag of tricks.

There were no herding trials in the whole state of TX until March but in February there was a Herding trial being put on by the Sunshine Belgian Terv Club that had Terv herding judges. I thought it would be nice to see other Belgians herding and since Den's brother lives in Florida, well, I like killing two birds with one stone when I can.

I am starting to think that I have my own personal rain cloud that follows me to herding trials - the rain stayed away until a few minutes before the start of the Herding Tested part of the trial. This time it was just rain - no thunderstorm. The stock was light but Cody did fine and qualified, (Thank You judge Sharol Hathaway).

“If additional nominations are received by the Secretary they shall be included in the ballots which shall be sent out to the members by the Secretary prior to July 31<sup>st</sup>.
