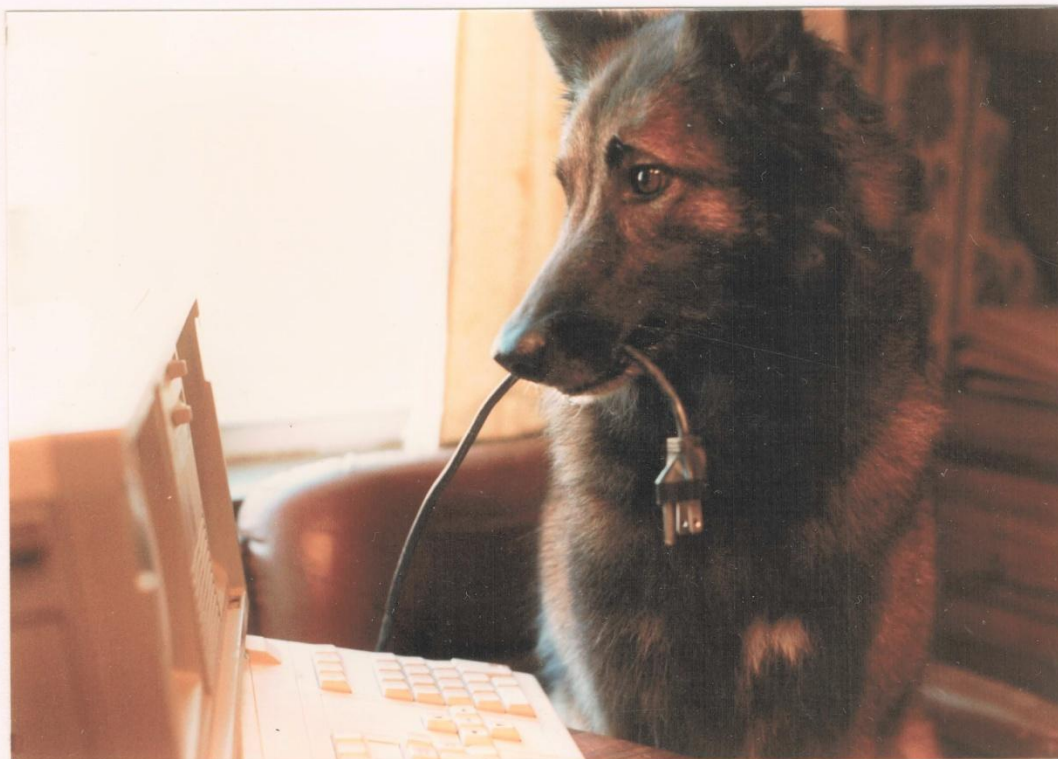
AKC MEET THE BREEDS
