Such nominations must be received by the Secretary no later than June 30th. No person shall be a candidate for more than one position.

“If no valid nominations are received by the Secretary on or before June 30th, the Nominating Committee’s slate shall be declared elected and the membership so notified.

“If additional nominations are received by the Secretary they shall be included in the ballots which shall be sent out to the members by the Secretary prior to July 31st.
