

Monthly Transacting Users (M)




Monthly transacting users (MAU) refers to the number of unique customers who interacted with Coinbase within a month.



Total Trading Volume (\$B)




Institutional versus Retail Trading volume (in \$B)







Revenue Sources




Revenue from various Services & Subscriptions

Source of revenue, total in \$M





Consequence


A series of resignation follows; 5% or 60 employees resign (Sandler, 2020)








As the trading volume increases; Coinbase transaction fee matches that of Binance; however low volume traders have to pay a comparatively higher fee.

As per the Coinbase COO, Emily Choi;

- The overall average of trading Fee is at par with other exchanges for retail flow;
- ✤ Institutional flow rates are lower than the industry average rates

What is driving customer choice here?

- ✤ An easy to understand intuitive User experience.
- ↔ Has maniacally pursued compliance with existing regulations and law enforcement, putting it on the right side of the law
- ✤ The best in industry security features for crypto assets
- ✤ A wide range of platforms to suit various trading requirements.



Recommendation : Auto Trader - Monetize market volatility

Whilst critics of the crypto industry argue that Blockchain has passed the investment phase and has now entered into the utility phase, crypto markets are still driven by sentiment which implies higher volatility than a regulated stock market.



Recommendation

A new Sentiment \longrightarrow Score Button on the Blotter



The Tesla CEO just can't guit tweeting about his favorite

cryptocurrency, which is now worth \$0.18.

Requirements

Sentiment Score as a radio button on the blotter and watchlist

Sentiment Score button captures the ongoing sentiment of a coin, it is a score on a scale of 1 through 5, with each score mapped to a color, for example 1 indicates extreme negative sentiment and the corresponding color is Red. Sentiment analysis involves the process of scraping through news articles online and running complex machine learning algorithms to understand the sentiment of a coin, whether it is positive, negative, or neutral. It also considers the trading activity of an asset, and upcoming milestones (for example an upgrade or enhancement).

A curious trader could further drill down on underlying news to understand the reason (news items) driving a particular sentiment rating.

Ability to create **alerts** against sentiment score value for coins in watchlist.

Auto trigger trading decisions. Sentiment feature could be clubbed with trading instructions, for example buy $\pounds 1000$ of coin X following tweet about coin X from Y personality and sell after it moves up by 10% (based on historical price movement). Coin is purchased from FIAT stored on exchange wallet and the transaction is reversed if the underlying condition is met.

Questions to the CEO

- The mission of Coinbase is to empower every individual through crypto economy, but the hardest hit in terms of commission are small volume traders who trade below \$10 K USD in a 30 days timespan and end up paying 0.5% (5 times higher than Binance). What are your plans to empower small volume traders ?
- The institutional volumes are way too high; however the revenue is more from retail flow, how is this possible ? What is the strategy behind the pricing (brokerage for institutional investors)?
