### **COMMUNICATIONS**

DJ shared Donor View mailing for fundraising nonprofit software.

Checks for Embassy Bank and Neffs Bank for EITC were received as well as a check from Aetna, Yoder's Heating, American Express and Terraform.

**TREASURER:** Steve shared the financial report for February through March.

Net fundraising included income for Tiger Run preregistration and the Sporting Clay sponsorship, miscellaneous income from stadium seats and sponsorships. Over \$1500 was reporting for donations from employee contributions and the district giving campaign.

Expenses for marketing include design fees and the Penn Sports commercials.

Net Assets were \$81,589.27.

### **COMMITTEE REPORTS**

**Allocations/EITC:** Dan shared the report for the allocations committee which included \$130,000 received to date for EITC funds.

A brief recap of previous allocations commitments was provided and a new request for \$1,475 for the Middle School Makerspace.

\$60,000 was budgeted for unrestricted funding. \$42,401.50 had previously distributed and the recommendations for April include \$23,450 - \$19,250 for the Mini-Grant Program (round 2) and \$4,200 for a High School Library Collaborative Seating and Work Space Project.

Due to the district being shut down, and limited staff, the board agreed to hold off on any votes and funding at this point.

Alumni: No updates.

#### **Fund Development:**

Senior Signs – 35 sold – Mertz is still able to provide these unless he runs into a supplier issue due to the shut down. Keeping in touch regularly. Reaching out to admin this week to coordinate a few special deliveries. Orders end April 26
