Purpose

Horseplay / Pranks

Key Responsibilities

- Stay on task in the work environment
- Supervisors / Leads are required to ensure all employees know that horseplay and pranks are not acceptable in the workplace.
- E&B Employees are required to stay on task and focus at the job at hand while in the workplace.

Hazard and Risk Identification

- Horse Play and fooling around are the opposites of safe, responsible work
 - Horseplay means rough fun
 - o Fooling around means doing foolish, useless things
 - o Fool is a person with little or no judgement or common sense
- Workplace Rules ban horseplay because it's dangerous
 - When you're fooling around, you're not concentrating on your work
 - Directing your horseplay at others is even more dangerous, They're not expecting the distraction and could easily have an accident such as falling into a moving machine parts, slipping on the ground, or dropping a tool.
 - Giving less than full concentration and attention to safety procedures makes you less likely to notice or account for hazards until it may be too late.
 - o Most accidents are caused by unsafe acts and horseplay itself is an unsafe act
- Horseplay Creates unnecessary Risks
 - Running, chasing, or pushing can cause slips, trips, falls and other accidents. You may:
 - Not notice spills or items lying on the ground
 - Crash into, or push someone else into, heavy equipment or moving parts
 - Knock boxes or materials onto a person
 - Knock over open containers of hazardous substances
 - o Throwing tools is a frequent cause of injuries. They may:
 - Stab someone with a sharp edge
 - Hit someone in the head, eye, foot, etc. And cause an injury
 - Fall from a height and hit a person below with tremendous impact



- Fooling around with PPE can damage it and expose you or another worker to a hazardous substance
- Pushing, teasing, or otherwise distracting people working could cause pinch points or other injuries
- o Practical jokes like "hiding" someone's PPE are not funny they're dangerous
- Take your job, your responsibilities and safety seriously
 - o You're responsible for performing your job correctly, which includes safely
 - Safety rules and procedures are designed to protect you
 - Everyone must follow safety rules
 - Failure to follow the rules is dangerous for you and for others
 - Horseplay and other safety rule violations can lead to disciplinary action
 - o Don't indulge in horseplay or accuse those who won't go along of having "No sense of humor"
 - Think how bad you would feel if your horseplay injured or sickened someone else
 - o Don't allow other people to engage you in horseplay

Risk Assessment

Hazards are classified and ranked based on severity. The program identifies hazards are classified/prioritized and addressed based on the risk associated with the task. (See the risk analysis matrix outlining severity and probability).

Horseplay often occurs between younger, less experienced employees.

- How Can You Prevent Horseplay in the Workplace?
 - o 1. Don't play into horseplay. Don't initiate it. Don't get pressured into participating in it
 - o . 2. Educate employees on Workplace Safety.
 - o 3. Reinforce Standards of Conduct Policy.
 - 4. Avoid being distracted at work.
 - 5. If you see someone behaving in an unprofessional or unsafe way at work, report it to a supervisor.
 - o 6. Follow instructions and obey the safety rules designed for your protection.
- Employee Responsibility
 - o 1. Do not engage or participate in any type of unsafe behavior or acts.
 - o 2. Follow all regulations and work rules to ensure the safety of individuals or other employees.
