I hope this newsletter finds you and your family healthy and well. It is hard to believe that we have come full circle from when the COVID-19 pandemic started in the U.S. a year ago. This has been a difficult and heavy year for all of us. In this year, NEBO was able to make many internal changes that will promote efficiency and transparency for those seeking and maintaining the title of Board Certified Ocularist.

The NEBO certification test is now administered remotely due to the inability to travel freely for most individuals. Candidates no longer will have to take the test at the annual AAO conference city. This change will better accommodate those candidates that are eligible to take the certification exam.

Even though the exam was a challenge to administer to eligible candidates during the pandemic, NEBO felt it was important to make sure the test was offered to those individuals that have studied and worked so hard to get to this stage in their profession.

We continue to set policies that are fair and defensible for all members. In this last year some of the first Board Certified Ocularists have transitioned to our "Maintenance of Certification" platform. This new scheme will help clarify some of the ambiguity that existed in the past by following a calendar year format. Member's certificate will be valid from January to December in that calendar year. It will also serve as a stepping stone to moving closer to regaining accreditation. The process of obtaining accreditation is multifaceted and it has forced the board to analyze all rules and policies of the past as well as the future.

NEBO was also able to audit and award credits to the very first virtual conference offered in the field of ocularistry. Awarding credits for this event allowed individuals the ability to safely continue their education and gain the necessary credits for recertification.

I am very proud of the hard work, dedication and time this board has put forth to strengthen the very core of our certification. The NEBO website (www.neboboard.org) is a great source of information and I encourage everyone to check out the new updates. I look forward to guiding the NEBO board in 2021 and hope you all can continue to stay safe and healthy.
