

ONLINE PRIVACY POLICY AGREEMENT

Why We Collect Information and For How Long

- To contact you to fill out surveys or participate in other types of market research, when we have your consent to do so;

The length of time we retain said information will be determined based upon the following criteria: the length of time your personal information remains relevant; the length of time it is reasonable to keep records to demonstrate that we have fulfilled our duties and obligations; any limitation periods within which claims might be made; any retention periods prescribed by law or recommended by regulators, professional bodies or associations; the type of contract we have with you, the existence of your consent, and our legitimate interest in keeping such information as stated in this Policy.

Use of Information Collected

Network Of Glory does not now, nor will it in the future, sell, rent or lease any of its customer lists and/or names to any third parties.

Network Of Glory may collect and may make use of personal information to assist in the operation of our website and to ensure delivery of the services you need and request. At times, we may find it necessary to use personally identifiable information as a means to keep you informed of other possible products and/or services that may be available to you from networkofglory.com and its subsidiaries.

Network Of Glory and its subsidiaries may also be in contact with you with regards to completing surveys and/or research questionnaires related to your opinion of current or potential future services that may be offered.

These may collect your IP address and require cookies to work properly. These services are governed by the privacy policies of the providers and are not within Network Of Glory's control.

Disclosure of Information

Network Of Glory may not use or disclose the information provided by you except under the following circumstances:

- in other ways described in this Policy or to which you have otherwise consented;
- in the aggregate with other information in such a way so that your identity cannot reasonably be determined;
- as required by law, or in response to a subpoena or search warrant;
- to outside auditors who have agreed to keep the information confidential;
- as necessary to enforce the Terms of Service;
- as necessary to maintain, safeguard and preserve all the rights and property of Network Of Glory.

Non-Marketing Purposes

Network Of Glory greatly respects your privacy. We do maintain and reserve the right to contact you if needed for non-marketing purposes (such as bug alerts, security breaches, account issues, and/or changes in Network Of Glory products and services). In certain circumstances, we may use our website, newspapers, or other public means to post a notice.

Children under the age of 13

Network Of Glory's website is not directed to, and does not knowingly collect personal identifiable information from, children under the age of thirteen (13). Notice to European Union Users
