ELIGIBILITY

All nominations must:

1. Come from an Active FCSTAT member or group of Active members.
2. Exclude members currently serving as a Director or Alternate on the FCSTAT Board of Directors.
3. Allow five (5) years to elapse between nominations for winners of the Region Teacher award.

<p>1. Region/State Teacher of the Year: To recognize and honor a Family and Consumer Sciences (FCS) teacher from each of the five regions for creative and innovative teaching, growth and development of students, and contributions to the community and profession.</p> <p>a. Eligibility: Any member of FCSTAT who is an active Family and Consumer Sciences teacher in Texas is eligible; recipients of the State awards will be selected from the regional winners.</p>
<p>2. Rookie Teacher of the Year: To recognize and honor a Family and Consumer Sciences teacher who has been teaching no more than two (2) years.</p> <p>a. Eligibility - Any member of FCSTAT who is an active Family and Consumer Sciences teacher in Texas.</p>
<p>3. Administrator (Superintendent or Principal): To identify administrators (Superintendents or Principals) who have consistently contributed to support Family and Consumer Sciences Education.</p> <p>a. Eligibility: Any administrator in Texas.</p>
<p>4. Counselor: To identify counselors who have contributed consistently and outstandingly to support Family and Consumer Sciences Education.</p> <p>a. Eligibility: Any counselor in Texas.</p>
<p>5. Career and Technical Education Administrator/Local Supervisor: To identify Career and Technical Education administrators and/or local supervisors who have consistently contributed to support Family and Consumer Sciences Education.</p> <p>a. Eligibility: Any certified Career and Technology administrator and/or supervisor in Texas.</p>
<p>6. Distinguished Service: To recognize individuals or organizations who have consistently contributed to support Family and Consumer Sciences Education. Recipient(s) not limited to any individual or group.</p> <p>a. Eligibility: Not limited to any individual or group.</p>
<p>7. Golden Flame Award: This award recognizes the significant contributions of State Board of Education members and/or State Legislators to Family and Consumer Sciences Education.</p> <p>a. Eligibility: Any Texas State Board of Education member and/or State Legislator.</p>
<p>8. Golden Service: To recognize auxiliary personnel in public schools who have made consistent and outstanding contributions in support of Family and Consumer Sciences teachers and their programs.</p> <p>a. Eligibility: Any auxiliary personnel in a Texas public school.</p>
