A Year Unlike Any Other

The year 2020 will go down as the most difficult time ever experienced by the Humane Society of Wyoming County since our incorporation in 1985. Despite COVID-related lockdowns, cancellations of all our fund-raising events, temporary closing of spay/neuter clinics, loss of meeting and rabies clinic venues, and personal struggles by some of our officers, Board members, and volunteers, we were able to continue serving companion animals and their owners in Wyoming County. In the past year:

- Our humane officer responded to an alarming and growing number of abuse, neglect, and cruelty cases. Animals involved included horses, dogs, cows, goats, donkeys, chickens, pigs, a
 pigeon, and (for the first time in our history) Koi fish. Many calls involved lack of proper care
 and the need for owner education, but sadly there were intentional cruelty issues as well.
- Our spay/neuter program continued. Since the beginning of 2020, 85 free or reduced-cost vouchers were issued to Wyoming County pet owners for spay/neuter surgeries on dogs and cats. Disappointingly, an additional 16 free cat vouchers which had been issued to Wyoming County residents who had requested them in 2020 were never utilized by the pet owners. These will be reissued to others this year. Additionally, ten vouchers for free spay/neuter surgeries, which had been provided to us by the Bissell Pet Foundation, were distributed to qualified pet owners in Wyoming County.
- Pet food donations to local food banks continued. Due to the pandemic, demand increased over previous years.
- Administrative work continued, with grant applications being submitted, our tax return filed, Commonwealth of Pennsylvania required paperwork submitted, and an audit of our Pennsylvania Workmen's' Compensation filing successfully completed.

Rabies Clinic Update

The Humane Society of Wyoming County reminds all dog and cat guardians that rabies vaccinations are **mandatory** in the Commonwealth of Pennsylvania. In order to assist county residents in obtaining these required vaccinations for their dogs and cats over three months of age, the HSWC normally sponsors two low-cost rabies vaccination clinics each year (spring and fall). Due to the COVID-19 pandemic, both clinics in 2020 were forced to be cancelled.

We are hoping to be able to run one clinic this summer. This will be dependent on factors beyond our control, but know that we will do everything possible to schedule this event. If COVID numbers begin to decrease in Wyoming County, and we can obtain a venue, veterinarian, and adequate volunteers, we will proceed. Feel free to check on clinic updates (as soon as available) in local media, on our answering machine, or on our webpage at www.hswcPA.org.

Remember: vaccinating pets protects not only the animal population, but the human population as well. If you have any questions on this event, please call us at 570-836-4745.

- Contact us (or local police) if you witness animal abuse. Calls are confidential.
- Make sure your pet is always wearing an I.D. tag. (We receive many calls on found pets, and would be able to return them home quickly if only they had on proper ID!)
- Prepare a disaster plan that includes your pet.
- Be sure all your pets are spayed or neutered to fight pet overpopulation.
- Adopt you next pet from a shelter or rescue rather than purchasing one.
- If you shop on Amazon, indicate our name under the "Amazon Smile" program, as we receive a donation for each purchase made.
- Consider a bequest to the HSWC in your will.

Lake Winola Fire Company to the Rescue

The brave and compassionate members of the Lake Winola Fire Company were dispatched, and were able to rescue the dog. <u>Important Reminder</u>

2021 dog licenses were due by law on January 1st. If you haven't yet purchased your dog license, please do so immediately. This will help you avoid a fine and provide identification should your dog become lost. Wyoming County dog licenses are available at the courthouse, as well as designated area businesses. All dogs 3 months and older must be licensed each year. Discounts are available for spayed or neutered pets, and for senior or disabled owners. (Yet another reason to spay or neuter your dog!)

Financial Update for 2020

The Humane Society Wyoming County had income of \$13,025.92 for 2020 (mostly grants, donations, from memberships, and memorials). Total expenses for the year were \$15,356.00 (mostly for officer humane expenses, veterinary costs, spay/neuter program, insurance, and pet food for food banks). It should be noted that every single one our normal fund raising events was cancelled during 2020 due to COVID. We had to dip into savings to meet expenses for 2020.

Elective Cat Declawing

Animal advocates have been lobbying to outlaw elective cat declaw surgeries (except in rare cases when it is medically necessary). Many countries, Canadian provinces, U.S. cities, veterinary clinics, and even the state of New York now forbid the procedure. Sadly, feline declawing can sometimes lead to long-term emotional and physical problems. According to VCA United States animal hospitals, "feline scratching and nail sharpening are normal behaviors, and the removal of nails has been shown to lead to chronic pain and, in some cases, to cause long-term behavioral issues." Instead, please consider asking your veterinarian about environmental changes to properly channel your cats' need to scratch. Also, your veterinarian or groomer can instruct you on how to safely give Kitty's nails a proper trimming.
