

AMENDMENT TO MASTER DEED AND DECLARATION OF CONDOMINIUM PROPERTY REGIME OF WEMBERLEY HILL GARDEN HOMES

This Amendment to the Master Deed and Declaration of Condominium Property Regime of Wemberley Hill Garden Homes, is made and entered into as of November 3, 2013, by the undersigned member of the Board of Directors of the Wemberley Hill Garden Homes Association, Inc. and a majority of unit owners.

WITNESSETH:

WHEREAS; The Master Deed and Declaration of Condominium Property Regime of Wemberley Hill Garden Homes, dated May 5, 1994, is of record in Deed Book 6455, Page 979 in the office of the Clerk of Jefferson County. The Master Deed has been amended from time to time since the initial filing; and

WHEREAS, Section W of said Master Deed provides that the Master Deed may be amended by signatures of a majority of the Unit owners, effective only upon recording of the signed instrument setting forth the amendment; and

WHEREAS; The Board of Directors and Condominium Unit Owners now desire to maintain the original owner-occupied nature and environment of the Condominium association; and

WHEREAS; The Council Board of Directors and Condominium Unit Owners now desire to prohibit the leasing or rental condominium Units; and

WHEREAS, the signatures of the majority of Unit owners below, have adopted the following amendment, to modify and amend the Master Deed as hereinafter set out; and

WHEREAS, Section G(2) of the Master Deed, stated as follows:

"2. The number of Units owned by one person or organization, for the purpose of rental,

may be limited by the Board of Administration."

NOW THEREFORE, Section G(2) of said Master Deed, is hereby amended to read as

follows:

"2. From this date forward no owner of a Unit may rent or lease said Unit. Additionally,

from this date forward all Units must be owner-occupied. The Association is aware that as of the

date of this Amendment there are certain Units which are not being rented or leased, but are also

not owner-occupied. Therefore, the Units which are not currently owner-occupied as of the date

of this Amendment shall be allowed to continue as non-owner-occupied Units until the current

occupant(s) no longer reside(s) in said Unit, at which point the Unit must become an owner-

occupied Unit. In order to qualify for this exemption owners of all non-owner-occupied Units as

of the date of this Amendment must within thirty (30) days of the Amendment recording provide

the Board of Directors with a copy of a letter detailing the current non-owner occupancy."
