- 1. Lisa Smith 7:01pm called to order.
- 2. January 2023 Board Meeting Minutes were approved without changes.
- 3. 2022 Budget v. Actual Operating Budget Financial Recap Lisa Smith More income because past dues paid plus interest and four homes sold; landscaping of oaks on Marsh; legal fees overage due to legislative changes to HOA covenants and bylaws; Misc repairs sprinkler repairs; bank balance \$24,082.18 is in good shape; tree landscaping budgeted for every two years but included in annual budget; will have dues current possibly by end of year due to sales and payment plans; question about dues increase needed to properly budget \$5,000 in tree trimming; motion to approve.
- 4. 2023 Proposed Operating Budget Review Lisa Smith

All homes except Treasurer pays HOA dues which is how proposed budget is calculated; Board has discussed raising transfer fees from \$50 to \$250; increased landscaping budget and added an accrual line for tree trimming; Board insurance has increased and will since 2015 up \$1,000; Board will shop around cheaper plans; might email statements to decrease postage; new Zoom line item so we don't run out of time during meetings; shows deficit but will likely have extra income; trying to avoid raising dues; voted to approve budget.

- 5. Election of Board Members Lisa introduced new treasurer since former one sold house; Cheri Peters is new Treasurer started in February and she is an original homeowner; vote on open positions:
 - a. Vice-President Doug Boss is willing to serve as VP; formerly served as Member
 - b. Community Member JoAnn Yancy will serve as Community Member
- 6. Other Topics for Discussion All

- a. Darius posed question about corner house on 2828 Kings Gate and parked cars and traffic concerns; Lisa encouraged residents to complain to City; Citation was issued to resident; Trailer is illegal; Resident is renting; contact City Code department and request follow up; Pat posed that if bylaws are not followed that the HOA should issue legal action/fines against the homeowner to get action taken; Pat complained to neighbor about barking dogs and was dismissed. Owner does not reply to emails; we do have homeowners mailing address and will discuss options at next Board meeting.
