Citizens to be Heard – (This time is provided for citizens to address the Council on issues and concerns. No action can or will be taken on issues discussed under this portion of the meeting. Please limit your remarks to a period not to exceed three (3) minutes. We ask that you approach the council and state your name and address for the record.) **Pursuant to House Bill 2840 (codified in Texas Government Code Section 551.007), all attending citizens who wish to comment on specific agenda items, during a scheduled meeting, must sign up to do so PRIOR to the start of the meeting and indicate which agenda item the citizen wishes to comment on. Said public comment on agenda items shall occur once the agenda item is reached during the meeting, but prior to the City Council deliberating the matter. A time limit of three (3) minutes shall be observed by all commenting citizens.**

1. Discussion/Action on the Implementation of a taxation limitation to be applied to the ad valorem taxes of Senior Citizens (65 years and older) and disabled persons who have completed proper exemptions with Gonzales County Appraisal district pursuant to section 11.261 of the Texas Tax Code.
2. Discussion/Action on Adopting the Proposed 2023-2024 Fiscal Year General Fund, Utility Fund, Nixon Fire Department Fund, and the Rate Sheet for the City of Nixon.
3. Discussion/Action on Adopting Ordinance O-08-28-23 Adopting a Budget for the Fiscal Year 2023-2024 Beginning October 1, 2023, and Ending September 30, 2024. Appropriating the Various Revenue and Expenditures Amounts thereof and Repealing all Ordinances or Parts of Ordinances in Conflict therewith Providing for an Effective Date and Declaring an Emergency.
4. Discussion/Action on Adopting the Proposed 2023-2024 Tax Rate.

5. Discussion/Action on Adopting Ordinance 0-08-28-2023 Texas Levying Property Taxes for Use and Support of the Municipal Government of the City of Nixon, Texas for the Fiscal Year Beginning October 1, 2023, and ending September 30, 2024; Providing for a Repealer, Providing for a Severability Clause and Providing for an Effective Date.
