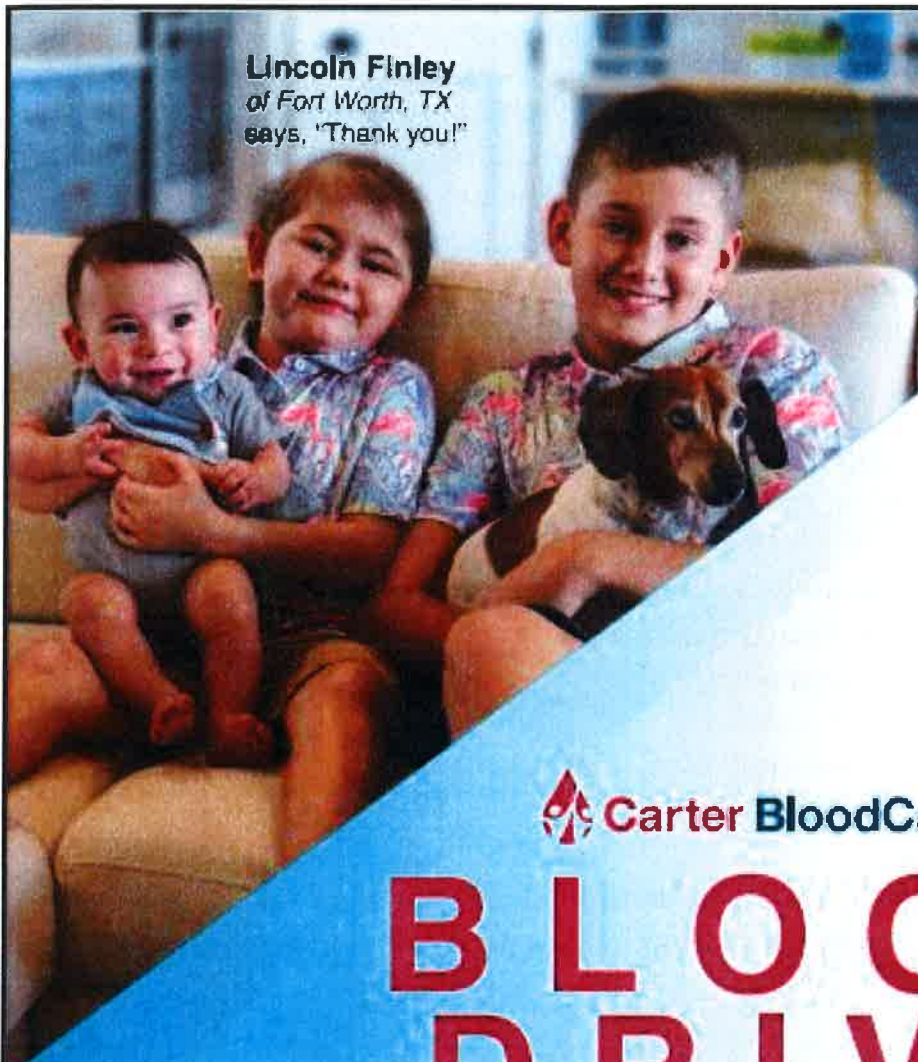

3. He should have the ability to express himself clearly in language that will make us proud of him, rather than apologetic.
4. He should present an imposing person appearance.
5. He should be able to hold his own and advance the interest of his Temple and Freemasonry in high places as well as among the humble.
6. He should be a devote Mason and constantly promote the interest of Freemasonry everywhere.
7. He should be proud, yet humble.
8. He should have good Character and a past open to investigation.
9. He should be a good leader, have good standing in his community and be influential in its affairs.
10. He should be financially secure.
11. He should be in good health, full of energy and vitality.
12. He should be able to devote ample time to his duties.
13. He should be a man who, when he appears anywhere in public, you will be proud of and not apologetic for his shortcomings.
14. His wife should be able to understand his devotion to duty; realize that he is the Recorder and not she; be able to dress and wear appropriate clothing and be familiar with social amenities.

The duties of the Recorder outlined in the Bylaws set forth by Shriners International can be found in the office if any candidate would like to go through the list.

Nominations for Recorder should be based upon thorough and accurate evaluation of character, ability and interest. **Candidate for Recorder**  
**BIOGRAPHY OF CRAIG T. HUGHES**  
**September 8, 2022**

The career of Craig Hughes has spanned over 40 years in a wide variety of industries, but his concentration has always been focused on inventory control, logistics management, and related information technologies. In later years he has expanded his scope into the direct management of the manufacturing process. His wife of 45 years is an attorney in Tyler, TX where they currently reside. He has two sons, one is the senior director for Fox in Washington D.C, and the other has earned a master's degree in Geophysics from LSU. He is currently employed by the state of Texas. Away from the office, Mr. Hughes is an instrument rated pilot, Ham Radio Operator, Scuba Diver, and a big game hunter.

After graduating from Stephen F. Austin State University in 1975, Mr. Hughes initially worked for Anderson Clayton Foods in production planning. It was at this time that he became involved with the American Production and Inventory Control Society (APICS) and became certified in production and inventory control. From Anderson Clayton he moved on to Mitsubishi Aircraft International where the new MU-300 business jet (now sold as the Beach Jet) was under development. Here he was instrumental in the installation of the IBM COPICS manufacturing system. Once again changing industries, Mr. Hughes moved to the fledgling MCI Communications Company. After initially being based in Washington, D.C., he moved on to Dallas, Texas where the MCI Engineering headquarters had been established. At the Dallas engineering facility, he and an APICS associate established an inventory management department for the first time. At the time, MCI was involved in the construction of billions of dollars' worth of microwave and fiber optic infrastructure. To manage this, Mr. Hughes helped develop the proprietary Engineering Planning System based on MRP methodology. After this he was promoted to the manager of the Logistics Management IT organization, and along the way, he was named as the primary inventor on an early U.S. patent for RF barcode scanning technology. In 1999 he was recruited to Hood Packaging Company in Tyler, TX as the Materials Manager. Wanting to get back to his East Texas roots, he took this position which soon expanded to the management of manufacturing operations as well as logistics. As Operations Manager he was responsible for Purchasing, Customer Service, Logistics Management, and all Manufacturing Departments (a total of more than 100 employees). He retired from this position in 2018, although he continues to do consulting for Hood Packaging.

## Candidate for Oriental Guide

### **Russell C. Brown**

Russell Brown was constituted a Noble in Sharon Temple in 1986, and has been an East Texas Mason for more than 42 years. During his nearly four decades as a Shriner, Russell has been active in various units and clubs of Sharon Temple, including the Past Masters' Unit and the Director's Staff. Russell organized the Sharon Hot Rods unit and reactivated the Rusk County Shrine Club in Henderson. Russell served the Nobility of Sharon Temple for many years as the Temple Attorney, and worked closely with, and advised, the Divan on legal and private matters in that capacity.

Russell was raised to the sublime degree of Master Mason in Lufkin Lodge No. 669 in 1980 while attending Texas A&M University. A few months after being raised, he also joined both the Scottish Rite and York Rite of Freemasonry. Upon graduating from A&M in May of 1981, Russell moved to Houston and went to work for Gulf Oil and affiliated with Morton Lodge No. 72 in Richmond, where he served as Worshipful Master in 1985. In 1986, he presided over Richmond Chapter and Council. After joining Sharon Temple, Russell continued to serve the Nobility while living in Houston by affiliating with Arabia Temple and becoming active in its Knights of Mecca unit. In 1985, Russell left Gulf; joined Shell Oil; and began law school.

Russell graduated from law school and, in 1989, left Shell and moved back to East Texas. He was appointed law clerk to the Chief Judge of the federal court for Eastern Texas and moved to Beaumont. There, he affiliated with Beaumont Lodge No. 286 and El Mina Temple.

In late 1991, Russell joined the Wellborn-Houston law firm and moved to Henderson. He has been in practice there for over 30 years. He also affiliated with Clinton Lodge No. 23 in 1991 and served as Worshipful Master in 2003. In 2004, Russell was successful in getting Robert E. Lee Lodge No. 431 reconstituted and chartered in Henderson and served as the Charter Worshipful Master. In 2020 Russell joined together with 25 other Texas Shriners and chartered Union Lodge No. 82 in Waco.

A servant at heart, Russell (a 33<sup>rd</sup> Degree Scottish Rite Mason) serves as a trustee, and member of the executive committee of the Texas Scottish Rite Hospital for Children in Dallas. He has served the Grand Lodge of Texas in numerous positions and capacities. He served as District Deputy Grand Master in 2000 and Special Deputy in 2019; District Instructor 2002-2009, and from 2019-present; Grand Orator in 2004; and most recently as the President of the Grand Lodge Library and Museum of Texas. He served as chairman of both the Civil Law and Masonic Jurisprudence Committees. He has conferred the 33<sup>rd</sup> degree in Texas for many years.

Russell is a dedicated Shriner and Mason. Most importantly, however, is his family. Russell has been married to his wife, Kelly, for 37 years. They have three children, Katy, Clay, and Tom. Clay teaches history and coaches football, and Tom is in the United States Air Force. Both are Past Masters of Clinton Lodge No. 23 in Henderson. Katy recently married a Master Mason and is a licensed counselor in Dallas. Russell and Kelly are active in the Henderson community, and he loves participating with the Sharon Hot Rods in various parades and community events. He served for several years as a member of the Henderson City Council and served as Mayor *pro tempore*. He is currently serving his community as a member of the Board of Trustees of the Henderson Independent School District.

Russell Brown is a dedicated Shriner, Mason, and a natural leader. He looks forward to continuing to serve the Nobility of Sharon Shriners.
