MARCHING BAND COMMITMENT CONTRACT 2024-2025

As a member of the South Greene High School Band, you are required to adhere to the organization's policies and procedures as well as those set forth by South Greene High School and Greene County Schools. Please read thoroughly and sign your initials on the line next to each statement stating that you understand each item.

_____ I have made the decision to be a member of the South Greene High School Marching Band (the "program")

_____ By submitting this form, I realize that my participation is expected in the 2024 Marching Band show. If I do not fulfill my obligation, I will cause hardship for those members who remain in the program. This form expresses my commitment to the organization.

_____ I am aware of the time commitment required. Furthermore, I understand the importance of my attendance at all rehearsals and performances. I will plan my personal schedule around planned rehearsals and performances. I understand that program items may be added to the schedule throughout the year and that directors of the program will provide me with as much notice as possible. I will use my best efforts to incorporate these added items into my schedule.

_____ I am aware of the financial commitment that is involved. I understand the importance of timely payment of fair share money, and the need for help in fundraising efforts.

_____ I understand that a \$50.00 fair share fee is required to participate in the marching band.

_____ I understand I must return school owned instruments by the announced date.

_____ I have read, understand, and will uphold the rules and regulations outlined in the South Greene High School Marching Band Handbook.

_____ I understand that I must behave like a responsible young adult. I understand that I must refrain from vaping, smoking, drinking, using illicit drugs and other irresponsible behavior.

_____ I am dedicated to work with every member of the band, and I will strive to achieve excellence in practice, rehearsals, and performances.

The undersigned understand Jacob Frederick, hereinafter referred to as “Director South Greene Bands”, will be the director for the said events.
