## NOTICE OF COMMUNITY ENHANCEMENT PROJECT WALK PICO! A CATALYST FOR COMMUNITY VITALITY

Starting May 31, 2022 the City of Los Angeles, Department of Public Works, Bureau of Street Services (StreetsLA), Engineering Services Division will begin site improvements in your area represented by Paul Koretz of Council District #5. Construction is expected to last from May 31, 2022 until Fall 2023.

The limits of work for the **Walk Pico! A Catalyst for Community Vitality** will be on Pico Boulevard from Patricia Avenue to the I-405 Freeway as well as the intersection of Westwood Boulevard and Tennessee Avenue. The scope of work will include the following:

- Bus Stop Safety Lights (east and west bound lines on Pico Blvd.)
- Upgraded Access Curb Ramps (Pico. Blvd and Westwood Blvd/Tennessee Ave)
- Concrete Sidewalk Improvements (Pico. Blvd)
- Crosswalk Improvements (Pico. Blvd and Westwood Blvd/Tennessee Ave)
- Bicycle Signal Upgrades (Westwood Blvd/Tennessee Ave)
- Community Wayfinding/Historic Signage (Pico Blvd.)
- Landscape Median and Bumpout Enhancements (Pico Blvd. and Overland Ave.)
- Street Furniture (Pico Blvd.)
- 50 Proposed Street Trees (Pico Blvd.)

Between **May 31, 2022 to July 2022** property owners can expect to see construction activities at the intersection of **Pico Blvd. and Overland Ave**, which will include temporary traffic lane disruptions and closures. In addition, "Tow Away – No Parking" signs may be placed on the street 72 hours before work begins. Please have all vehicles removed from the street so they will not interfere with the planned work and to protect them from possible damage by construction debris. Some driveways may be temporarily out of service so please coordinate with the crew supervisor who will be wearing a white hard hat. Crew supervisor will also coordinate directly for any sidewalk removals fronting business storefronts and doorways.

We appreciate your patience and cooperation while we are working in your neighborhood. We will strive to keep any inconveniences to a minimum.
