I. Welcome & Introductions

II. Approval September 13, 2021, Executive Committee Minutes

III. Approval of November 10, 2021 Planning Council Agenda

The Planning Council agenda was reviewed. It was decided, that if presenters were available, information about new HIV medication Cabenuva be added to the agenda,

Ms. Thomas made a motion to accept the proposed Planning Council. The motion was seconded by Ms. Osk. All in favor-motion carried.

IV. Administrative Update

Ms. Shelton will begin her term as Planning Council chair at the November Meeting. Mr. Ruiz will be the Vice-Chair of the Planning Council.

A program within the Early Intervention Services (EIS) is being shut down at the end of the fiscal year. It is a difficult priority to operate and PSRA allocations for this priority were reduced for FY22-23. Currently there are three funded programs, two in Nassau County, one in Suffolk County. This program was underperforming in comparison to the other two.

The Updated Integrated HIV Prevention and Care Plan is due December 2022. Using new guidance the EMA will once again collaborate with the State and NYC to submit a joint plan. The SAP committee is responsible for reviewing/updating the plan.

A HRSA site visit is being scheduled for next year tentatively in June. The project officer is retiring in December 2021.

There will be a virtual World AIDS Day event on Friday, December 3rd in the evening.

V. PC Membership

Ms. Henn provided an update on the current membership. Current Planning Council membership is at 30 members. Two applications were approved by the membership sub-committee. Planning Council members will vote on the applicants via Survey Monky after the November Council meeting. Overall consumer membership on the Council is at 40% with unaligned consumer membership at 33.3%. There are continued efforts to increase the unaligned consumer membership.
