### **April Guest Speaker**

Chris Mackowski, Ph.D.

"Strike Them a Blow: Battle Along the **North Anna** River"



The most overlooked segment of the Overland Campaign also represented some of the best chances both generals had for destroying each other's armies but the war of attrition had taken a personal toll on the commanders, peppering the North Anna River with lost opportunities.

Chris Mackowski, Ph.D., is the editor-in-chief and cofounder of Emerging Civil War. He is the series editor of the award-winning Emerging Civil War Series and the "Engaging the Civil War" Series. Chris is a writing professor in the Jandoli School of Communication at St. Bonaventure University in Allegany, NY. Chris has authored or co-authored a dozen books on the Civil War, and his articles have appeared in all the major Civil War magazines. Chris serves on the board of directors for the Central Virginia Battlefields Trust and the national advisory board for the Civil War Chaplains Museum in Lynchburg, Virginia.



## Civilian Glimpses of the War Years

(Contributed by Compatriot Fred Boelt)

In 1852, Littleton Tazewell Waller purchased Lombardy, a large farm on Old Forge Road. At that time, Lombardy joined John Taylor Martin's farm and Martin's journal has already given us some insight into local conditions during the war years. In the following letter now in a private collection, Waller is writing to his neighbor, Dandridge Watkins Marston, who was living directly across the road at Variety Grove.

During the war years, there was a Goddin family living near the Ship Yard landing [Menzel's Road] and this may be who was referred to in the letter. Mr. Wilkinson is Cary Wilkinson who lived at Merry Oaks [present day housing area off Route 60].


Richmond Dec 12th 1862

My dear Sir


Your neighbor Mr. Goddin has just called to see me, in order to buy from me various articles which we now have at Lombardy, which if not sold will be waste[d] and stolen, and prove an utter loss to me. He says there is quite a good crop of corn, some wheat, and potatoes, some 21 hogs now in the fattening pen, and some cattle and perhaps some fodder. Now as I do not know what there is at Lombardy nor the prices of things there, and as you are near the spot, and can be informed of what is there, and its value, I ask as a great favor that together with my friend Mr. Wilkinson, will sell to Mr. Goddin upon fair terms such things as he may want – he tells me that he will give \$6 per barrel for corn, \$150[sic] per bushel for potatoes, \$25 per hundred [pounds] for pork – for wheat, fodder or cattle the price not named, but I leave the price of each and everything to you and Mr. Wilkinson. If you should sell things to Mr. Goddin – please send me an account of sales, and Mr. Goddin will settle with me here – I wish however in case of sale that there be retained for the use of the negroes who are still at home, 20 barrels of corn -500 pounds of pork and some potatoes. I also wish one yoke of oxen and two of the best cows to be retained for the use of the negroes. Whatever expenses may be incurred in the sale, I wish you of course to deduct from the proceeds. It may be as well to state to you the prices of some of these articles here – Viz – corn \$18 per barrel, pork \$35 per hundred, fodder \$4 per bushel, such are the prices of these things here in Richmond and by these you and Mr. Wilkinson and Mr. Goddin can settle upon what he can afford to pay. All this however I leave to you to do with as you think fit, but there is one thing which is most important, and that is, that you make sale of this property as soon as possible, as all of it may be lost by least delay; and you can well imagine how every little [bit] is a big help to one who has suffered so heavily as I have. I make no apology for asking of you and Mr. Wilkinson this favor, for I know that you both will cheerfully do for me whatever you can, and you know that you will have my sincere thanks for your friendly kindness. You can send me the account of sales when made, by Mr. Goddin who will be the safest opportunity." To be continued....

Remembering the plundering and great loss of commodities at John Martin's adjacent farm in 1862 [*Picket Lines*, February 2019], it seems remarkable that there was anything left to be sold at Lombardy. Waller, his wife Elizabeth, and daughter Fannie, had refugeed to Richmond just ahead of the Peninsula Campaign that spring. The farm had been left in the hands of trusted enslaved workers who apparently had continued to work the land. There will be more about this in the second part of the letter.


