CHAPTER 130: PUBLIC OFFENSES

§ 130.01 INTOXICATION.

It shall be unlawful for any person to be or appear in any public place in the Town of Pickstown, including its public parks, in a state of intoxication or drunkenness, or to be found intoxicated therein. (1986 Code, Title 19, § 9.01) Penalty, see § 10.99

§ 130.02 DISTURBANCE OF PEACE.

It shall be unlawful for any person to threaten any person for the purpose of intimidation or to inspire fear or in any manner disturb the peace of any family, person or neighborhood. (1986 Code, Title 19, § 9.02) Penalty, see § 10.99

§ 130.03 MALICIOUS MISCHIEF.

It shall be unlawful for any person to, in any way, injure, damage, break or destroy any plant, flower or shrub being or growing upon the private property of another or to injure, damage or destroy any tree, plant or shrub on the parking space adjacent to property owned or controlled by another. (1986 Code, Title 19, § 9.03) Penalty, see § 10.99

§ 130.04 ASSAULT AND BATTERY.

It shall be unlawful for any person to willfully and unlawfully or maliciously commit any assault or assault and battery against another person.

§ 130.05 INDECENT CONDUCT.

It shall be unlawful for any person to appear in any public place in a state of nudity or to indulge in any indecent, lewd or lascivious conduct or behavior to commit any indecent, wanton or filthy act in the presence or hearing of any person.

§ 130.06 LARCENY.

It shall be unlawful for any person to take or attempt to take from any other person or any store, building or other place within the Town of Pickstown by fraud, stealth or by any manner, any money, property or anything of value, tangible or intangible, with the intent to deprive the owner of that property.

§ 130.07 VAGRANCY; VAGRANT DEFINED.

(A) A *VAGRANT*, as contemplated by this chapter, is one who goes about from place to place who has no lawful or visible means of support, and who lives upon charity, although physically able to support himself or herself.

(B) It shall be unlawful for any person within the Town of Pickstown to pursue the calling defined by the preceding division as vagrancy. Vagrants, as defined by division (A) above, shall include gamblers, persons without visible occupation or means of support, loitering around gambling houses or places where liquor is sold or drunk, common prostitutes, habitual drunkards, persons who beg in public places or from house to house, or who procure children to do so or persons who fraudulently represent themselves as collectors of alms for charitable institutions.
