D.R.A.W. SCHOOL ADVANCED FIREARMS INSTRUCTOR TRAINING

The **D.R.A.W. School Advanced Handgun Instructor Training** course is a 5-day, 40-hour advanced instructor development and certification course designed to provide law enforcement instructors with the basic and advanced shooting skills, instructional ability, training, and knowledge required to teach basic and advanced shooting and handgun handling skills to their officers. The curriculum

is designed to teach instructors how to effectively train officers to increase their speed, accuracy and focus when shooting. This is a highly dynamic course that focuses on real-world application of the skills learned. This hybrid course combines an online pre-requisite training course (6-hours), with intense practical exercises and live-fire training.



The **D.R.A.W. School Advanced Patrol Rifle Instructor Training** course is a 3-day, 24+ hour advanced instructor development and certification course. It provides instructors with an enhanced ability to train officers both basic and advanced skills to master the complexity of their patrol rifle, even in the most demanding or hostile environments. With many departments now utilizing patrol rifles, instructors must be

able to train their officers in a highly efficient manner without compromising instructional quality. This is a highly dynamic course with almost all instructional time devoted to practical and live-fire exercises. This course takes patrol rifle training and instructor development well past recognized minimum state and federal standards.

PREREQUISITE: All instructor candidates attending either course must complete the 6-hour online training prerequisite training course. Per SCCJA guidelines for the D.R.A.W. School Advanced Instructor Training courses, candidates may attend these courses prior to obtaining their Basic Instructor Development (BID) or their Specialized Skills Instructor (SSI) certification. However, those candidates must attend either BID or SSI within 12-months. The original D.R.A.W. School issued certification date will be the renewal anniversary date.

The D.R.A.W. School instructor development curriculums are hybrid instructional courses that are designed to maximize training time, while ensuring that each skillset is learned,



retained, and applied by instructor candidates. In doing so, the goal is to help instructor candidates to **effectively and consistently duplicate the training process** so that officers become high proficient with their weapons. Each segment of the curriculum starts with an academic study of the subject where instructor candidates learn the true science behind the methodology. Each step in the training process answers the “why” behind the method. Next, instructor candidates are immersed in a series of

specifically designed practical exercises that help them correctly perform each physical and mental function in the proper brain/body sequence. This portion of instruction is performed in the classroom and on the range utilizing a special designed “stairstep” training methodology. As each step is mastered, the speed is increased, and fast, dynamic movement is added. Once the practical exercises are mastered, instructor candidates then perform the same skills in a live-fire environment on the range. At the end of the course, instructor candidates will shoot a 50-round qualification course for each of the instructor development courses. These qualifications include many of the skills they learned and practiced during the course. WHO MAY ATTEND THE COURSES?

The D.R.A.W. School Instructor Training courses are strictly for sworn law enforcement personnel only. Each applicant’s employment and position will be verified to maintain the strict attendance requirements. Preference will be given to current SCCJA-certified BID and SSI instructors wanting to obtain their FIS and/or PRI certification. Candidates without BID or SSI certification must obtain their BID or SSI certification within 12 months of course completion to be valid. The following individuals may apply to attend either course:

1. Local, state and federally certified law enforcement instructors
2. Local, state or federally certified law enforcement officers
3. Retired LEOs currently instructing at a college or state-licensed agency

COURSE REGISTRATION FEES & REGISTRATION PROCESS

To attend either the Advanced Handgun Instructor or Advanced Patrol Rifle Instructor course, **the application at the end of this packet must be filled out in its entirety and returned to D.R.A.W. School via email.** The application is a PDF document that can be filled out and printed off, or the entries can be handwritten on a hardcopy. **Applications must be submitted along with any required supporting documentation by the application deadline, Monday, May 20, 2024.** Each instructor candidate must submit a copy of their law enforcement credentials and a letter from their law enforcement agency stating that they are currently in good standing and meet the requirements to attend. **DO NOT submit your application until your agency approves you to attend.**

The registration fee for the **Advanced Handgun Instructor is \$649.00 per person** and the fee for the **Advanced Patrol Rifle Instructor is \$549.00 per person.** If an applicant is attending BOTH courses at the SAME location, a **discounted combined course rate of \$1,099.00 per person will apply.** Payment type and information must be provided on the application when it is submitted. Payments made via credit/debit will be charged upon approval of the application and receipts will be sent via email. ***Please provide the name and email address of the person(s) that should receive the receipt for payment if other than the applicant.** **Seating for both courses is limited to fourteen (14) seats.** Acceptance and approval is based on a first-come, first-served basis.

PLEASE NOTE- Refund requests will be issued if the instructor candidate notifies D.R.A.W. School at least fourteen (14) days before the start of the course that they cannot attend. A non-refundable fee of \$299.00 will apply in such cases. **Refund requests made less than twenty (20) days from the start of the course for any reason are non-refundable.** If an application is received and the desired dates are full, the applicant will be notified by phone or email. In such situations, applicants may be placed on a waiting list.

INSTRUCTOR CANDIDATE DRESS CODE

Instructor candidates should wear comfortable clothing that is conducive for a physically demanding firearms training environment. It is highly recommended that instructor candidates wear the following:

- **Soft tactical uniforms-** tactical pants and polo shirts
- **Tactical uniforms-** tactical pants, tac-shirts, or combat shirt
- Other tactical/practical uniforms or dress, t-shirts

Clothing will become dirty throughout various parts of the course and during range training exercises, so we do not recommend wearing clothes that instructor candidates do not wish to get dirty or possibly damaged. **Do not wear jeans to class, as they are not allowed.**

The range facility is outside, so **please be sure to bring appropriate clothing that will keep you comfortable while still allowing for physical activity.** Mornings may be much cooler during early range activities, so layer appropriately based on the forecast. Some range activities will be for an extended time. If you plan to wear short-sleeved shirts on the range, we recommend that you apply sunblock before going outside or wear a lightweight sunshirt. It is highly recommended that you bring a lightweight water-repellent jacket in case of rain during the range exercises. Comfortable, supportive footwear is highly recommended for all segments of the course as you will be on your feet for extended periods. **Instructor candidates should bring and wear their body armor throughout the course to properly simulate their entire duty uniform ensemble during all training exercises. Body armor is required to be worn on the range during all live-fire exercises.**

EQUIPMENT AND PACKING LIST

Each instructor candidate must wear a duty holster properly affixed to a belt during all practical and live-fire range exercises. It is preferred that the holster issued by the instructor candidate's department is the one brought to class as this is the holster that they will be training others to use. **Level II and Level III duty holsters are required. The use of IWB holsters is NOT allowed in either course.** **Duty holsters affixed to outer carriers or tactical rigs are not allowed in class.**

PHYSICAL FITNESS & HYDRATION

Both the Advanced Handgun Instructor course and the Advanced Patrol Rifle Instructor course are physically demanding courses with daily practical and range exercises. In addition to being on your feet for extended periods of time, some of the practical and live-fire exercises are strenuous. **Applicants are highly encouraged to have a physical fitness capacity capable of allowing them to participate in all exercises and complete the course.** If an applicant has any medical issues or physical limitations, they are



required to state those on the application and in-class registration forms. However, this does NOT disqualify an applicant from attending. It is highly recommended that instructor candidates refrain from consuming beverages that tend to cause dehydration (soda, sugary drinks, energy drinks, etc.), and drink plenty of water with an electrolyte-based drink mix added (i.e. Liquid IV, LMNT or DripDrop) to stay properly hydrated.

TRAINING VENUE AND RANGE FACILITY

These advanced instructor courses are being held at the **York County Law Enforcement Training Center** and **York County Sheriff's Office Range Facility**. ONLINE INSTRUCTOR PORTAL

Once an application has been approved, the instructor candidate will be emailed an invitation to create an account for the **D.R.A.W. School Instructor Online Portal**. **Once the instructor portal account has been created, the instructor candidate will have access to all information that is needed for the course.** This information will include the following:

- **Course Preparation Check List-** Walks the instructor candidate step-by-step through the process of preparing for the course(s) they will be attending.
- **Equipment Packing Lists-** Provides a full list of all the equipment instructor candidates need to bring with them to the course.
- **Health & Safety Recommendations-** Recommendations for any health or safety concerns that may affect the course and what precautions, or restrictions are in place, i.e. COVID, Flu, etc. **Please Note- Instructor candidates who are sick should NOT attempt to attend class and may be sent home by the instructor.**
- **Online Training Course-** Directions to log into the D.R.A.W. School Online Training System free of charge and order their free BarrelBlok safety and training device. **Please Note- The online course must be completed by Friday, February 16, 2024 in order to attend the in-person portion of the course.**
- **Updates-** Any course informational updates instructor candidates need

LAW ENFORCEMENT D.R.A.W. SCHOOL FIREARMS TRAINING

Law enforcement officers across the country are facing increasingly violent, fast threats and therefore must have a higher level of mastery when using their firearm. Yet, due to manpower levels, scheduling, range availability, ammunition shortages, budget cuts and other issues, many departments struggle to regularly train their officers **past the minimum levels** required by their departmental or state standards. School** was developed in 2014. The D.R.A.W. acronym stands for **Drawing, Reloading and Aiming of Weapons**.

This expertly designed law enforcement firearms training and instructor development curriculum meets and/or exceeds all state/federal law enforcement firearms training requirements in all 50 states. D.R.A.W. School firearms training curriculums are designed to complement each state's training requirements and can be **easily integrated into any agency's training program for consistent training results**. D.R.A.W. School is a nationally recognized firearms training and instructor development curriculum and is POST-certified in various states. It is also SCCJA-approved for FIS and PRI instructor equivalency in South Carolina. It has been taught to instructors in over 40 states and has been widely recognized as the most up-to-date law enforcement firearms training program available in the nation.



The introduction of the **D.R.A.W. School Online Training System**, an LMS-based individualized, self-paced firearms training course, changed the game when it comes to how departments conduct regular firearms training. The Online Training System helps officers to stay consistent and ready with twenty-three separate 10–15-minute training segments that cover all aspects of the five core competencies of the D.R.A.W. training curriculum in an in-depth manner. D.R.A.W. FREQUENTLY ASKED QUESTIONS

Q: I am not a certified SSI or BID instructor yet, but I am a sworn law enforcement officer. Can I still attend the advanced instructor courses?

A: Yes, however you must obtain your SSI or BID certification within 12 months for the firearms instructor course to be valid with SCCJA. The D.R.A.W. School certificate date will serve as the anniversary date for your SCCJA instructor renewal and qualifications.

Q: Can I take the Advanced Patrol Rifle Instructor course by itself?

A: To take the Advanced Patrol Rifle Instructor course by itself, applicants must already have their FIS certification issued by the SCCJA. If an applicant did NOT attend the D.R.A.W. School Advanced Handgun Instructor course to obtain their FIS certification, they must go through the online 6-hour prerequisite training course BEFORE attending.

Q: If I attend the Advanced Handgun Instructor School can I take the Advanced Patrol Rifle Instructor the following week?

A: Yes, but only if you successfully pass the Advanced Handgun Instructor course.

Q: The information says these courses are certification courses. Who is the certifying entity?

A: The South Carolina Criminal Justice Academy, through the course equivalency approval, certifies all graduates who submit the paperwork to obtain their FIS and/or PRI certification(s).

Q: Is D.R.A.W. School Instructor Training SCCJA-approved?

A: Yes. Advanced Handgun Instructor (Lesson Plan Number 6162); Advanced Patrol Rifle Instructor (Lesson Plan Number 6163); For SCCJA Course Equivalency, see Page 10.

Q: How physically demanding are these courses?

A: These courses are physically demanding. There is a lot of repetitious movement involving speed and agility. There are also a lot of training segments that require getting down on to and up off the ground. Instructor candidates are required to perform and complete all exercises in the classroom and on the range to pass the course.

Q: Does the host agency endorse independent courses such as D.R.A.W. School?

A: No, most governmental agencies are not allowed to endorse D.R.A.W. School. However, since the SCCJA has properly vetted and approved the course curriculum and training standards for instructor certification equivalency (beginning in 2020), York County Sheriff's Office has graciously agreed to host the courses at their training facilities.

Q: How difficult is the qualification course of fire?

A: The course of fire is representative of the training. Both handgun and rifle courses of fire require a 93% minimum and all 50 rounds MUST be on the silhouette of a B-27 target. All subsequent instructor qualifications must be performed through the SCCJA.

Q: Is there a written test with this course?

A: Yes, there is a 50-question True/False/Multiple Choice test at the end of the Advanced Handgun Instructor course. Instructor candidates must score 80% or higher to pass.

Equivalency (DRAW)

The following process should be used for those students who successfully complete either of the above-listed DRAW courses and wish to have an instructor equivalency through the SC Criminal Justice Academy.

1. Email the DRAW certificate(s) to lwfennell@sccja.sc.gov with an accompanying letter from either the agency's Training Officer (unless that person is also the student) or the Agency Head requesting the equivalency.

The letter should contain the officer's name, Acadis ID number, and dates of training.

2. The Academy will ensure the officer's Specific Skills or Basic Instructor Development is in good standing, log the DRAW training, and send the requestor a letter granting the equivalency. If the Specific Skills/Basic Instructor or DRAW training is expired, the equivalency will not be granted.

Allow five business days for the equivalency to be noted in the Acadis file.

3. The Firearms Instructor School (FIS) equivalency will be granted for those officers who attend that comparable DRAW training. The officer will be required to recertify with the Academy to maintain this certification.
4. The Patrol Rifle Instructor (PRI) equivalency will be granted for those officers who attend that comparable DRAW training.
