RESOLUTION NO. 2022-11

A RESOLUTION OF THE VILLAGE OF LAZY LAKE, BROWARD COUNTY, FLORIDA, AUTHORIZING THE MAYOR TO RENEW THE INTERLOCAL AGREEMENT WITH BROWARD COUNTY FOR USE OF TEMPORARY DEBRIS MANAGEMENT SITES AND OTHER RELATED SERVICES FOR AN ADDITIONAL FIVE YEARS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE THEREFOR.

WHEREAS, the Village of Lazy Lake ("Village") and Broward County ("County") entered into that certain Interlocal Agreement in August 2022 ("Agreement"), pursuant to Section 163.01, Florida Statutes, also known as the "Florida Intergovernmental Cooperation Act of 1969", whereby the Village procured the services of the County to provide temporary debris management sites to the Village during the aftermath of a natural or man-made disaster; and

WHEREAS, the Agreement allows the Village or authorized contractors to bring to County temporary debris management sites, disaster debris collected from within the Village's boundaries; and

WHEREAS, the Agreement expires on November 30, 2022; and

WHEREAS, the Agreement provides that the Parties, may, upon mutual written consent of the County Administrator and the Village, renew the Agreement with the same conditions for two additional five-year terms; and

WHEREAS, the County has advised that the renewal provision will take the form of a counter signed letter between the County Administrator and the Mayor; and

WHEREAS, the Village Council authorizes the Mayor to execute the letter on behalf of the Village, which will renew the Agreement for an additional five-year term.

NOW, THEREFOR, BE IT RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE OF LAZY LAKE, FLORIDA, THAT:

- Section 1. The foregoing recitals are true and correct and incorporated herein.
- Section 2. The Village Council hereby authorizes the Mayor to execute the letter (or other document) with the County, which will renew the Agreement for an additional five-year term, with an expiration date of November 30, 2027.
- Section 3. Should any section, paragraph, sentence, clause, phrase, or other part of this Resolution be declared by a court of competent jurisdiction to be invalid, such decision shall not affect the validity of this Resolution as a whole or any portion or part thereof, other than the part so declared to be invalid.

<u>Section 4.</u> This Resolution shall become effective immediately after passage by the Village Council and by signature by the Mayor.

In 2018, Broward County and your governmental entity entered into an Interlocal Agreement ("ILA") that allows your use of County-owned Temporary Debris Management Sites ("TDMS").

The initial term of the ILA will soon expire. Section 4.1 of the ILA provides for a five-year renewal that may be exercised "upon mutual consent of the County Contract Administrator and the Government Entity . . . "

- 1. A countersigned copy of this letter indicating your written consent to renew the ILA;
- 2. Any authorizing resolution or legislation deemed necessary by your governmental entity to authorize your countersignature or this renewal.

if this countersigned letter (with any required authorizing resolution or legislation) is not returned by November 15, 2022, Broward County will assume your governmental entity does not desire to renew the ILA and proceed accordingly.
