

# WEDDING VIDEOGRAPHY INFORMATION

## Wedding Video Packages:

### Four-hour Wedding Package \$400.00

- Continuous Coverage for up to 4 hours-one shooter
- Highlight + Ceremony/ Reception Edit
- Photography coverage for ceremony and reception
- Online Gallery with high-resolution video

### Six-hour Package \$500

### Booking fee/deposit: \$200.00

**Additional fees** include a second drone shooter at \$200.00 and extra time outside the hours included in the base fee. In addition, anytime after six hours will incur an additional \$100.00 fee per hour.

The final payment is due on Tuesday before your wedding.

The Clients agree to provide a meal for the Videographer if the length of attendance exceeds five hours.

**Entire Agreement:** This agreement contains the entire understanding between the Clients and the Videographer.

**Confirmation:** A signed "Contract for Wedding Videography Services" is necessary to confirm the stated wedding services from the Videographer.

**Pre-Wedding Consultation:** This typically happens at the time of booking. You, the Clients, will outline what is required, and the Videographer will advise on planning, logistics, and timings where needed. If required, the Clients are welcome to call or meet with Videographer for an additional chat closer to the time of the wedding (about two weeks) to iron out the remaining details. In any case, we will contact you by phone a few days before the wedding to ensure that there have been no last-minute changes.

**Cooperation:** The Clients and the Videographer consent to happily cooperate and communicate with each other to achieve the best possible result within the understanding of this contract. It is recommended that the Videographer is provided with a member of the wedding party who will point out key individuals to film. The Videographer may also require the assistance of the wedding party member in organizing family groups.

The Clients also agree to give the Videographer sufficient warning of key events at the wedding to give the Videographer time to prepare, e.g., Bouquet throwing, cutting the cake, speeches, etc. Please note that not all guests at weddings like being filmed. In such cases, the Videographer will use their discretion but cannot be held responsible for the lack of video of these people.

**The Schedule:** The shooting schedule, work style, and experience are designed to achieve a great wedding film for the Clients, accomplished with good humor and enjoyed by all concerned. Therefore, both the Clients and the videographers agree that punctuality and cheerful cooperation are essential to producing outstanding photographic results. In cases where the wedding does not run on time (for example, extreme lateness by one of the Clients arriving at the church), we cannot guarantee to take our typical set of shots. However, we will do our absolute best to compensate in such circumstances.

**Paparazzi Wedding Guests:** All your guests will have digital cameras/ phones, and all your guests will want to photograph the Clients. In the spirit of cheerful cooperation, the Clients agree to give the Videographers precedence over the guests to take the photographs required for the wedding services described above. However, we cannot be held liable for the lack of wedding shots if guests taking their shots of the Clients continually interrupt the Videographer's work.

**House Rules:** Note that videographers are sometimes limited by rules imposed by registrars, ministers, and venue management regarding what can and cannot be done. For example, some ministers insist that no flash photography is allowed, and others will insist that the Videographers shoot from a specific location. In such circumstances, the Clients agree to accept the technical limitations that may impose on the equipment

used. We advise the Clients to make themselves aware of the rules of the venue concerned and, if necessary, negotiate with the personnel concerned.

**Copyright Law:** The copyright of photographs remains with the Videographer. The Videographer grants the Clients permission to make copies of the video under the following conditions. The footage taken by the Videographer is for personal use by the Clients and their friends and relatives. Sale, Publication, or any Commercial use of the photographs is not allowed without prior written permission from the Videographer.

**Model Release:** The Clients grant the Videographer and its legal representatives and heirs and assign the irrevocable and unlimited consent to use the photographs of the Clients for editorial, competition, advertising, and any other purpose and in any manner, to alter the film without restriction, and to copyright the video. The Clients hereby release the Videographer and its legal representatives, heirs, and assigns from all liability and claims in connection with the video.

**Limit of Liability:** If a Videographer is too ill or becomes injured and cannot supply the wedding services specified above, the Videographer will try to book a replacement wedding Videographer. Under normal circumstances, a second Videographer the Videographer is there for the day anyway, and this Videographer will then shoot the day on their own. If both Videographers are unavailable and a replacement Videographer cannot be found, then liability is limited to a refund of any payments received. The Videographer has a working method to prevent your video's loss or damage. There is the unlikely possibility that video may be lost, stolen, or destroyed for reasons in or beyond our control. In these circumstances, liability is limited to the return of fees paid for the service or part thereof according to the percentage of video supplied.

**Cancellation Fee:** If the Clients cancel the wedding for whatever reason, the Cancellation fee is \$200.00 is non-refundable. It will be considered as liquidated damages to the Videographer.
